He identified the subject as Tyler Scott Kolbe ██████████. He advised Tyler was having mental issues. He also advised Tyler was obsessed with the Sandy Hook shooting incident and ██████████.

I made contact with Mary at her residence. I did ask if she knew if anything was going on with Tyler. She advised not to her knowledge. She advised he had his SCRAM unit taken off by his probation officer and seemed happy. She advised she took him to Meijer yesterday morning and he bought something but was unsure what he bought. She advised he had not seemed like he was having any issues. She advised ██████████ ██████████

I did speak to Tyler on the porch of his residence. I did ask him what was going on. Tyler advised nothing was going on. I did ask Tyler if he wanted to harm himself or others. He responded no, he was not having any thought of suicide or homicide. He did advise he feels guilty for the Sandy Hook shooting incident but knows he didn't do anything. While talking to Tyler he seemed out of it. I asked Tyler if he needed help Tyler advised that he did need help because he knows something is wrong with his head. I did ask Tyler if he would like to talk to someone at the hospital. Tyler advised yes he would like to seek help. ██████████

**TRANSPORTATION:**

I did transport Tyler to HFA for a voluntary mental health evaluation. Prior to placing him in my patrol vehicle he was patted down. Nothing of value was found on his person.
