### INCIDENT SUMMARY

I was dispatched to [REDACTED] in reference to an assault complaint. Upon arrival I did make contact with the victim and a witness who stated that an assault had taken place. After taking the initial report I did proceed to the suspect's house who admitted to the assault. The suspect was taken into custody and lodged at JSO for assault. The status of this case will be open pending warrant request.

### CONTACT WITH VICTIM:

[REDACTED]

Upon arrival I did make contact with the victim [REDACTED]. I asked [REDACTED] what had taken place. [REDACTED] stated that he was staying at a friend's house drinking the night prior as well as today. He stated at approximately 1200 hours he did contact his [REDACTED] via TX. After a brief conversation he stated that his [REDACTED] said "something was not right" and shortly after she did show up at the house. [REDACTED] stated that his [REDACTED] tried to get him to go home of which he stated he did not want to go.

After a brief period of time he stated that his [REDACTED] showed up and got out of his car and walked up to him and started punching him. I asked [REDACTED] if his [REDACTED] would be identified as Steven Eric [REDACTED] stated anything prior to hitting him of which he stated he did not. Be advised that upon making contact with [REDACTED] I did observe dry blood as well as a bruised nose on [REDACTED]'s face. I also noticed blood on both hands and fingers with blood on the left hand sleeve of his shirt. [REDACTED] also advised that the homeowner who would be identified as Leon Andrew Walker saw the whole thing "he can corroborate my story."

At that time I did ask [REDACTED] to step back in the house and asked Leon Andrew Walker to come out of which he complied.

### CONTACT WITH WITNESS:

Leon Andrew Walker, white male, 7/30/90  
6600 Blackman Road  
Jackson MI

I did make contact with Leon Andrew Walker and asked Leon what had taken place. Leon stated that his friend [REDACTED] had stayed the night and he had "been drinking all day." At approximately 1200 hours [REDACTED] had contacted his mom. After a brief period of time his [REDACTED] who would be identified as Mary Sue [REDACTED] did arrive at Leon's residence. Leon stated that he and Mary attempted to get [REDACTED] in the car but [REDACTED] "struggled" and refused. At that point Leon stated that Mary called her [REDACTED] Steven to come over and help.

Shortly after, Leon stated that Steven arrived. Upon arrival Steven immediately exited his car, walked over and began to punch [REDACTED] in his face. Leon stated that he was eventually able to separate Steven and [REDACTED]. After pulling Steven and [REDACTED] apart he eventually let Steven go. Leon stated that as soon as he let Steven go, Steven immediately attempted to "go after him" again. At that point Leon was able to get between [REDACTED] and Steven and eventually all three would go to the ground. Leon stated that he was able to separate them again and immediately stood up and told Steven to leave his residence multiple times.

Leon stated that Steven would eventually comply and leave.

### OFFICER ACTIONS:

After taking the initial report I did contact Dispatch and asked for another unit. At that point I proceeded over to 5606 Coonhill Road to attempt to make contact with the suspect. Upon arrival I did notice a white male sitting outside on the porch.

### CONTACT WITH SUSPECT:

Steven Eric [REDACTED]

Upon arrival I did make contact with the suspect who would identify himself as Steven Eric [REDACTED]. Be advised that prior to asking

Steven what had taken place he immediately stated "let's go." I asked him if he knew why I was there. Steven stated "because [REDACTED] called you." I asked Steven what had taken place. Steven stated he was called over to Leon's house by his wife Mary to help [REDACTED] come home.

Steven advised that approximately two weeks prior [REDACTED] had attempted to commit suicide. I asked Steven what happened when he arrived at Leon's house. Steven stated that upon arrival he got out of his car and asked [REDACTED] to "get in the car" twice. Steven stated that when [REDACTED] refused he "punched him." Steven stated he was "sick of it." At that point I did ask Steven to stand up and come down the steps of which he complied.

**ARREST:**

I did ask Steven to place his hands behind his back of which he complied. Handcuffs were placed; the handcuffs were double locked and checked for tightness. Steven was escorted to my patrol vehicle and placed in the back seat without incident. After speaking with Steven I did wait for his wife who would be identified as Mary Sue [REDACTED] to return home. After a short time she did return home after walking her dog.

**CONTACT WITNESS:**

I did make contact with Mary Sue [REDACTED] at the end of the driveway. I immediately noticed that Mary was visibly upset as she was crying. Mary immediately stated "you should have knocked on the door." I did explain to her that her [REDACTED] was in the back of my patrol vehicle and I did want to talk to her about the incident. Mary stated "my [REDACTED] probably told you what happened."

Mary immediately went on to state "[REDACTED] tried to commit suicide two weeks ago. She stated that she was worried about him. At approximately 1220 hours she stated that [REDACTED] called her. She said that [REDACTED] was not making sense and would eventually hang up the phone. Mary stated she was worried about [REDACTED]. Mary stated she was able to contact [REDACTED] again by phone of which she was unable to make out his words.

At that point she decided to go to the house because she did not know "if he was suicidal or not." Upon arrival on Blackman Road, Mary stated she attempted to get [REDACTED] in the car with Leon multiple times. At one point she stated [REDACTED] did get into the back of the car but he would not put his feet inside so they could close the door. Frustrated, she contacted [REDACTED]'s father to come help her put him in the car.

I asked Mary what took place at that time. Mary stated "my [REDACTED] told you already." I explained to Mary that I needed to talk to her seeing as though she was a witness. Mary stated "he punched him and that is why I am upset." At that point I informed Mary that her [REDACTED] was being taken into custody and under arrest. I did explain to her that he would be at the Jackson County Sheriff Office of which he would contact her once he was booked.

After informing her of her [REDACTED]'s status I did clear the residence.

**INJURIES:**

[REDACTED] had visible injuries to his face, nose and elbow. Steven had no visible injuries.




