SUICIDAL SUBJECT

SUMMARY

I Deputy Barlund and Deputy Hudson was dispatched to a residence for a suicidal subject. Upon arrival to the residence we made contact with a man who had stabbed himself, he was transported to HFA. A mental petition was filled out and attached to this report. The status of the case will be closed.

INFORMATION

On 06/28/2018 at 2029 hours, I Deputy Barlund and Deputy Hudson were dispatched to [REDACTED] in Pleasant Lake, MI 49272 in Henrietta Township to take a report of a suicidal subject.

CONTACT WITH KAREN KOLBE

Upon arrival to the residence I did make contact with Karen Kolbe who was standing next to Tyler Kolbe, the subject who stabbed himself. Should be noted that Deputy Faouzi stood by with Tyler while I spoke to the Aunt Karen. The Aunt Karen Kolbe told me that her nephew Tyler Kolbe had been having a hard day. He just lost his job and he has made several suicide attempts in the past and he is also bipolar. Karen also stated that he walked up the stairs and he was covered in blood, his neck, chest and arm area. She did not know what he cut himself with, she said she assumed it was knife but whatever it was it was still in the basement where his bedroom is located.

CONTACT WITH TYLER SCOTT KOLBE

I spoke with Tyler and asked him if he had tried to harm himself, at which point he stated yes because he was upset because [REDACTED] Tyler did attempt to the rescue personnel who were treating him at the time that he did cut himself with a knife.

INJURIES OBSERVED

I did observed cuts to Tyler's neck and to both of his arms at the elbow region. There was blood covering the chest area of his shirt.

SCENE INVESTIGATION

During the protection search done after Tyler was secured, we did go down to the basement where his bedroom was and we located a black folding knife that Tyler used to cut himself. I observed several blood droplets all over the ground in several spots. There were some areas that were about the size of a baseball. There were several bloody rags and clothes in the entire bedroom.

I did collect the knife that Tyler had used to attempt suicide.

MENTAL PETITION

Tyler was transported to HFA by JCA. I did complete a mental petition form and attached it to this report in Aegis.

PROPERTY

The knife that Tyler used to harm himself was placed in evidence locker #23 at Jackson City Police Department.
