On 7/12/2021 at about 2115 I was informed of a disturbance in Zone 4. I responded and observed Subject: Werner, Lucas (Self-identified) seated on the ground near the railing. S/O's Traba and Swann appeared to be attempting to speak with Werner but he continually yelled and screamed things about needing love, women, and hating being alone. Werner would repeatedly yell that he loved Gen Zer's and AOC, stating he supported the left and deserved love.

During this fit of yelling I overheard Werner state he should, "Just die", and should, "Commit suicide". At this point I made my own contact with Werner. I asked how he was doing and what he needed from our Security Team. Werner stated he was 40 and single and that he needed a relationship. Werner then stated that he wanted to die. I asked Werner what he meant and he informed me that he would kill himself. Werner said that he had a pair of scissors in his backpack that he would use to kill himself.

I asked Werner where they were located and he attempted to remove his backpack. I told Werner I would feel safer if he didn't reach into his backpack and asked if I could remove them myself. Werner agreed, allowing me to remove the backpack and the scissors. I resealed the backpack, setting it near him.

SFD arrived, followed shortly by AMR. It was requested that the scissors be left behind so they were placed with Lost & Found.

AMR transported Werner to Deaconess Hospital for evaluation.
