On Wednesday, 8/10/11 at approximately 12:54p.m., I received a call of threats made at the pool. As I was en route, I was advised that the suspect was Patrick Tomlinson and he had made threats against his soon to be ex-wife, Adrienne Tomlinson. I was advised that the witness to the incident was waiting for me at the pool and her name was Ronamarie Tomlinson.

I arrived and spoke with Rona. She explained that Patrick and Adrienne Tomlinson have been having marital issues. She also advised that they were going through a divorce and that Adrienne had a new boyfriend named John. Rona stated that Patrick had spoken to her about Adrienne's boyfriend and Patrick became very upset. Patrick then threatened to kill both Adrienne and John. Rona stated that John lives in Pennsylvania and that was not a legitimate threat at this time. She did state that Adrienne lived in the City of Portage. Rona stated that she did call and speak with Adrienne about the threats that were made. Adrienne then contacted her father, Tim Raimer, who called this complaint in to the police department.

Rona was visually disturbed. When I asked her what happened, she started to cry and we had to take a few moments for her to calm down to explain the incident to me. Rona was able to explain the threats that Patrick had made. She did write a written statement in regards to what he said. She did state that it was just her and him having a conversation and that no one else witnessed what he had said. One of the comments that Patrick made to Rona was that he was going to wait until Adrienne had the baby and then kill both her and the newborn.

I did make contact with Patrick at his apartment located at 704 Dunn Street. I spoke to him about the comments that he had made at the pool. He admitted to threatening to kill John, however he stated that he did not make any comments about harming Adrienne or the unborn child. Patrick advised that the comments that he made were out of line and apologized for the incident.

Patrick was advised that he was going to be taken into custody for Disorderly Conduct. He was cooperative and I did place him into handcuffs. The handcuffs were double locked and he was seat belted into the back of my squad car. Patrick was transported to the Columbia County Jail and turned over to the jail staff without incident. Patrick did advise that he did have the means to post the \$150 bond for himself and would be released. The jail staff was advised of this.
