I made phone contact with the complainant, Samantha Howard, who advised she was scared she was going to be targeted by online hackers and could possibly fall victim to a "swatting" incident at her residence.</p> <p>Samantha stated she is a gaming streamer where people watch her play video games online. The company she works for, Cover Corp (located in Japan), recently advised her that her information, including her home address, had been leaked out online by unknown individuals. Over the last few days Samantha has received several anonymous messages while online stating that she is going to be "swatted" in the near future and there is nothing she can do to stop it from happening. Samantha is concerned the threats may be real and wanted to relay this information to the Police Department in case the threats were carried out.
