NARRATIVE

On the listed date and time, I made contact with Barbara Howard via telephone in reference to a suspicious incident. Barbara advised her daughter, Samantha Howard, is a professional gaming streamer on Youtube and has had various food items sent to their residence (12861 Cinqueterre Dr) for her.

Barbara explains various instances people have driven by and attempted to take pictures of the house but could not verify the date, time, or vehicle descriptions. She advised this time a note was left with more food from McDonalds at the front door with a Discord hashtag on it. I responded to the residence to find exactly that. The note advised "Ry#2023 on discord". Upon searching Discord for that hashtag nothing appeared. It is unknown at this time if it is real.

Barbara also advised this has been reported with NPPD before in reference to Samantha being "swatted" (reference NPPD case 21020778).
