Samantha forwarded Barbara a message that she received yesterday where the subject stated other unknown subjects have been payed money to go to Samantha's parents house in Florida, at night, to take video and pictures of their residence and to identify their vehicle registrations. Included in the message was pictures of the outside of Barbara's residence and a BMW vehicle she sold a few months ago. Barbara is very concerned over the recent message and feels like someone may be attempting to stalk her and her family.

At this time no further information is available and the subjects whereabouts are unknown. Barbara requested that extra patrols be conducted at her residence throughout the day and night. A screenshot copy of the message received was taken and will be uploaded to Evidence.com. Barbara was advised to contact the Police Department if she observed any suspicious activity or received any further information.
