Synopsis:

Narrative:	<p>I, PPO W. Henry, have been a commissioned officer with the Tacoma Police Department since 2022. On the above date I was on duty working routine patrol. I was driving my department-issued marked patrol car equipped with lights and sirens and was clearly identifiable as a police officer. My Body-worn camera was attached to my uniform, was operable at the beginning of my shift, and likely captured audio and video of the summary provided below.</p> <p>At the above-referenced time, I was dispatched to a call at 6019 S Lawrence St. The call indicated that an operator from the National Suicide Prevention Hotline was calling to advise that an individual who identified himself as "Jason" texted the hotline claiming that he was home with his children, had a firearm on his person, and wanted to kill himself and his children. The individual also stated that his wife left him and he had been using hallucinogens.</p> <p>I arrived on scene with PPOs Komljenovic, Juarez, Figueras, O'Dell, and Correa. I took up a position in the alley while other units used the PA system to request residents of the house step outside. The residents complied and advised that V1/JASON HALL does not live at the location. They advised that he owns the property, which they rent from him, and he lives in Lakebay, WA. They were able to provide a phone number for V1/JASON, which I attempted to contact without success. The residents also stated that there had been multiple "swatting" calls at the location in the past prior to them moving in. Jason often livestreams on Twitch and occasionally gets "swatted" by viewers.</p> <p>I attempted to call V1/JASON multiple times without success. As a precaution, we requested PCSD conduct a welfare check at V1/JASON's DOL address. A prior report showed that V1/JASON streams on Twitch under the name "PirateSoftware". I was able to view his profile on Twitch and confirmed he was in the middle of livestreaming.</p> <p>It should be noted that V1/JASON has received threats online in the past, which he has reported under case no. 2509101428, and was the victim of a prior "swatting" call under case no. 2424300063.</p>

SS911 advised that the phone number that texted the National Suicide Hotline returns to O1/DAMIAN HALL located in Aurora CO. Further research traced the IP address to a company out of Sweden that provides VPNs for users wishing to remain anonymous. Per SS911, the company is AMAGICOM AB.

Based on my investigation, I have probable cause to believe that the individual who contacted the hotline committed the crime of False Reporting (RCW 9A.84.040).

A special situation was created for SS911 for the address in case of future similar incidents.

Synopsis:

Narrative:

I, PPO W. Henry, have been a commissioned officer with the Tacoma Police Department since 2022. On the above date I was on duty working routine patrol. I was driving my department-issued marked patrol car equipped with lights and sirens and was clearly identifiable as a police officer. My Body-worn camera was attached to my uniform, was operable at the beginning of my shift, and likely captured audio and video of the summary provided below. At the above-referenced time, I was dispatched to a call that indicated V1/JASON HALL was hoping to talk to an officer.

I made contact with V1/JASON by phone. He advised that around the same time as the "swatting" call at 6019 S Lawrence St, he received a call from an unknown number (14087677347). He did not pick up, and when he listened to the voicemail after the stream, he advised that it was the sound of someone screaming "as if they were being killed". He advised that these incidents are tied to a site called kiwifarms.st, out of Sao Tome & Principe. They began targeting him after he spoke out against a bill that would tighten regulations for video game developers. He does not know who these individuals are, but advised that in the past month he has received thousands of death threats online.

V1/JASON was sent an evidence upload link for the voicemail.
