**Subject was arrested after resisting arrest. Lodged at JSO. Sgt. Hibbard. Report to follow.**

**Circumstances:**

On 05/08/18 at 1525 hrs. I was dispatched to The Super Liquor at 1200 W. Michigan Avenue because the Fire Department was requesting me to respond. Just prior to that it was with another fire truck at Blackstone and Pearl Street with an intoxicated subject.

Fire at that time advised that their other truck was headed to a seizure in the parking lot of Super Liquor. From my experience drug overdose type calls have been called in as seizures or diabetic reactions or something similar so I started to head in that direction. When I was a few blocks away the Fire Department did request the police for assistance.

When I arrived the suspect in this case Tyler Scott Kolbe [REDACTED] MCL was speaking with paramedics. I made contact with Fire and they advised that Mr. Kolbe was found behind the wheel of the vehicle. A silver Malibu that was parked in the parking lot advised that they had observed open intoxicants inside of the vehicle and they also handed me the keys to the vehicle.

I was advised that the store manager Abro had removed the keys from the vehicle. OFF. Glass then arrived. I had him stay with the subject Tyler Kolbe while I made contact with Mr. Abro.

**Interview with Witness Mr. Abro:**

Mr. Abro advised that he was working when an elderly customer came in and told him that there was a subject outside in the vehicle that was running and the subject "looked dead." Mr. Abro ran out there and observed that the vehicle was running and observed Tyler Kolbe behind the wheel. Abro said that he pounded on the window yelling for Mr. Kolbe to wake up but he did not.

Mr. Abro said that he then opened the door and shook Mr. Kollbe and got him to wake up. Mr. Abro said that Tyler Kolbe seemed "out of it" but he did ask him to turn his car off and hand him the keys. Mr. Abro said that after he handed him the keys he told Mr. Kolbe that he was calling 911 and Mr. Kolbe became irate and tried to fight with Mr. Abro to get his keys back. It was long after that the Fire Department showed up.

Mr. Abro said that while they were waiting for Fire that Mr. Kolbe was stumbling all around and that he had trouble with his balance.

**Suspect Statement:**

JFP and JCA had already pointed out 4 distinct marks on the inside of Mr. Kolbe's left elbow. These marks resembled track marks and all medical personnel believed that they were track marks. Mr. Kolbe said that it was from grabbing a freezing cold rack while he was working at Kroger.

I noticed that Mr. Kolbe was wearing a Comcast Xfinity identification badge. Fire also pointed out that Kolbe had pinpoint pupils; however when I later took him in the shade they did not stay pinpoint. While speaking to Mr. Tyler Kolbe I noticed an odor of alcohol about him. He also frequently stumbled while we were talking and walking around the parking lot.

Mr. Kolbe initially denied drinking any alcohol. I asked him about the open alcohol inside of his vehicle. Mr. Kolbe said he would be more than willing to give me the open alcohol from his vehicle. I later noticed that it was a 22 ounce can of hard cider in the center console of his vehicle. Mr. Kolbe admitted to drinking but said that it was four hours ago.

Mr. Kolbe refused any medical treatment. He signed the refusal with JCA. JFD and JCA left the scene.

At this point I had Mr. Tyler Kolbe walk with me up to the small amount of shade that was available under the awning in the front of Super Liquor. Mr. Kolbe denied using drugs or drinking alcohol. I did notice that his pupils did get larger in the shade. I explained to Mr. Kolbe that if he wasn't going to have alcohol in his system that he must have drugs in his system as he was acting very strange or under the influence.

Mr. Kolbe kept saying to take his blood and at this point I decided that I was going to conduct some sobriety tests on Mr. Kolbe.

**Sobriety Tests/PBT / Resisting and Obstructing Police.**

While directly in front of my patrol vehicle and in front of the Super Liquor Store I was about to begin the horizontal gaze nystagmus test and I was instructing Mr. Tyler Kolbe where to stand. I told Mr. Kolbe that I was going to try to determine if he was under the influence and at this point Tyler Kolbe said "fuck this, I am out" and walked away.

I said several times “Tyler don’t do it, Tyler don’t do it.” Tyler Kolbe then asked me if he was under arrest and I immediately said yes you are under arrest. At this point Mr. Kolbe was near the driver side door of his vehicle which he was now in between his vehicle and my patrol vehicle.

Mr. Kolbe had his back to me and I attempted to take Mr. Tyler Kolbe to the ground but this didn’t work so I pushed him toward the front of the patrol vehicle to a much safer area that was not in between the two cars. Kolbe and I both went up against the wall in front of The Super Liquor as I was trying to get control of him.

Kolbe just kept turning his back and keeping his arms in the front of his body away from me. I was able to finally take him to the ground. Mr. Kolbe then just laid there limp and refused any commands. One of the store managers Joseph Zartman then came to my aid. Mr. Zartman knelt down next to Mr. Kolbe and gained control of Kolbe’s right arm and assisted me with the handcuffing.

After Tyler Kolbe calmed down I was able to get him to his feet and walk him to the patrol car. Once inside of the patrol car Mr. Kolbe kept saying that he wanted to speak to his attorney. He told me that he had his number in his phone. I did dial the number for his attorney; however not a local attorney and I could not recall the attorney’s name.

While speaking to his attorney on speaker phone I explained the situation and the attorney told Mr. Kolbe to consent to the blood draw and to comply with the police officer.

#### **Chemical Test Rights:**

Once in the patrol car I did read Mr. Tyler Kolbe his chemical test rights. At the conclusion of the chemical test rights at 1627 hrs. Mr. Kolbe stated that he would take the test by saying “yeah.” I confirmed that he was consenting to the blood test and he said that he was consenting.

#### **Blood Draw:**

I did transport Mr. Tyler Kolbe to Henry Ford Allegiance Hospital where blood was taken by License Phlebotomist Jill Filip. Ms. Filip drew two vials of blood; both at 1706 hrs. The blood was secured at MSP Blood Kit and I later submitted this into Evidence and a request was submitted for it to go to the lab for analysis.

**Vehicle Information and Disposition:**

Prior to this phone call I did make contact with the store manager inside Mr. Zartman. Mr. Zartman said that he did not want Mr. Kolbe's vehicle left there while Mr. Kolbe was in jail and he said that it would have to be towed. I did call for Phelps Towing to come and I did impound the vehicle.

During an inventory search I did see several other full cans of hard cider and one open that was about half full which I discarded.

**Photos / Injuries:**

Mr. Tyler Kolbe did suffer some minor scrapes from the wall and pavement. Scrapes were on his face and photographs were taken of these and submitted into Evidence.

**BAC:**

Mr. Tyler Kolbe did blow a .23% BAC on the PBT at JSO. He was also lodged and charged with Resist and Obstructing Police and Transporting Open Intoxicants inside of a motor vehicle.

MCL 28.214-LEIN

I

decided not to charge Kolbe with the driving offense.

Mr. Tyler Kolbe's driver's license was confiscated and submitted into Evidence, pending lab results and he was provided with his copy of the DI177. I did mark on that temporary driving permit that his license was suspended and expired before placing that inside of his property.

OWI Work-up, Warrant Request and CCH was completed and turned in to the Court Officer.

**Conclusion:**

Mr. Tyler Kolbe was lodged at JSO for Operating under the Influence.
