On the above date and time I was dispatched to the above address at Multimatic Michigan for a threats report. Upon arrival I made contact with the manager Greg Darling. Darling indicated he has an employee who was making odd statements about mass shootings. Darling received the information second hand.

Darling advised the employee making the statements is a Tyler Kolbe. Darling stated his shift is over at 1500 hours and he will point him out when he walks out to leave for the day. Darling then went inside of the business to locate Kolbe. Kolbe was located in the bathroom.

After Kolbe exited the restroom he was escorted out to the parking lot by Officer Bean and I.

Suspect Name:

Kolbe, Tyler

Suspect Interview:

Kolbe was asked if he knew why I wanted to speak with him but was not sure. I then asked Kolbe about the statements he made to some of his fellow coworkers. Kolbe indicated he was going back and fourth with Jared and Brandon about music specifically "Pleasure to Kill" by Creator. Kolbe stated he was joking about mass shootings and does not want it to happen. Kolbe did not go into specifics about what the discussion was about. Kolbe feels there are too many bad things society and this is a way for Multimatic to fire him.

Kolbe did not have or make any suicidal or homicidal comments.

Witness Statement(s):

Pratto stated while he was working Kolbe came to his area of the shop to hang a part up and made the comment that his goal for the day is to have more people dead the happier he would be. Kolbe then made the comment of wouldn't it be cool if the Bright Walls were painted red and

that a mass shooting would make this place famous.

Kolodge did not hear exactly what Kolbe said but Kolbe made a comment to him confirming what Pratto told him.

Quainton was asked if he was discussing music with Kolbe at which time he indicated it was never discussed or mention. Kolbe then told him apparently you cant talk about mass shootings around this place.

Conclusion:

I provided Darling with a business card and report number. Kolbe was trespassed from the business.
