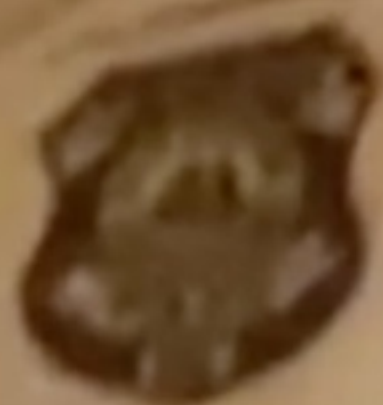

NARRATIVE

On 11/18/18 at approximately 12:00 AM, Patrols were dispatched to 339 Morgan St. for a reported domestic incident. Upon arrival at the above mentioned location, reporting Officer observed Janet Ditch sitting at the dining room table. Janet appeared to be frightened, and reporting Officer was able to also observe that Janet was having trouble catching her breath. Reporting Officer asked Janet as to what happened and at which time Janet stated that her son Andrew Ditch got into her face and was screaming at her. Janet did report that she was and is always frightened of Andrew. Reporting Officer also observed Andrew sitting at the dining room table at this time. Janet was asked if she wished for TFD to respond in order to check her out, to which she stated that she did wish to be checked out. TFD responded and evaluated Janet, and she declined transport at this time. Andrew was asked about the incident, to which he admitted to having a "meltdown", however denied getting into his mother's face and screaming at her. (Entire incident recorded on Officer's body camera) Janet denied wishing to pursue anything at this time. A

Call was filed in relation to the incident and Patrols left the residence.

On 11/26/18 at approximately 12:10 AM, Andrew Ditch called dispatch (18-017771) wanting to speak to an officer regarding a previously reported harassment (18-014703) in which he had an audio recording of his father Thomas Ditch threatening to punch him in the face. Patrols then responded to 339 Morgan St. and upon arrival Andrew was asked if he wished to sign a complaint charging his father for harassment. Andrew then stated that he did in fact wish to do so. Andrew was then transported to 200 by reporting Officer where he signed a Harassment 2nd Degree information. Thomas Ditch was then placed under arrest at his residence and transported back to 200 by Officer Bentley. Thomas was then booked on a single charge of Harassment 2nd Degree and held to see the Judge on 11/28/18. While Thomas was being booked under (18-014703), Janet and Joseph Ditch responded to the lobby of 200 wishing to speak to an Officer regarding having Andrew charged in relation to (18-017330) menacing Janet at the family's home on 11/17/18. Janet then provided reporting Officer with a signed supporting deposition regarding this incident that occurred on 11/17/18. In Janet's statement she reports that while Andrew was screaming at her, he also raised both of his arms and clenched his fists. Janet stated that she felt as if Andrew was going to attack her and cause physical injury to her. Janet also mentioned that while Andrew raised his fists and screamed at her, she had a flashback to a time a few years ago in which Andrew had threatened her with a knife. Officer Bentley then went to 339 Morgan St. and brought Andrew Ditch back to 200 where he was then arrested, booked, fingerprinted and photographed under one count of Menacing 3rd Degree. Andrew was then held to see the Judge on 11/28/18.

Thomas Ditch also provided a signed supporting deposition regarding this incident. An order of protection request was completed in relation to this incident.
