

In his own words, this is how Sesseur/Jeff Case described the incident that resulted in the arrest of his brother, Brandon Case.



The following is a transcript of the official police report (see parent tab for sources), detailing what actually happened.

Parties involved, cousins (both teenagers at time of incident) were given pseudonyms

Brandon Case (Arrestee, 24 at time of incident)

Melonie Case (Brandon and Jeff's mom, also semi-adopted Brandon's two cousins for a period of time)

Sienna (Cousin 1)

Tara (Cousin 2)

On **October 19, 2021** at **0718** hours, I responded to **1140 Taylor St** in reference to a battery domestic violence call. Prior to my arrival, I observed the screen comments stating that the other

party involved in the incident left in a black Hyundai car. Deputies were able to make contact with the black Hyundai on [REDACTED], several homes down from the incident location.

I made contact with **Sienna** who advised that [REDACTED] **Brandon Case**, engaged in a verbal argument with her, [REDACTED]. According to **Sienna**, **Brandon Case** grabbed **Tara** by her neck and pushed her into a dresser. During this, **Sienna** and **Melonie Case** attempted to separate the two of them. While trying to get **Brandon Case** off of **Tara**, **Brandon** turned around, *grabbed Sienna by the neck, and got on top of her on the bed*. She kicked him off of her. She didn't want **Brandon** to grab her, but when he grabbed her neck she could still breathe and he didn't inhibit her breathing.

I made contact with **Tara**, who advised she was lying in bed when [?] came in to wake her up. She asked **Melonie Case** to keep the boys out of her room at night on school nights. Twenty minutes later, [?] came back in and **Brandon** was in the doorway. She tried to walk out of the door, past **Brandon**, and brushed into him with her arm. **Brandon** grabbed her by the neck, shoved her into a wall, and grabbed her hair. She hit him to get him off of her. She didn't want him to grab her and when he grabbed her around the neck she could breathe.

I made contact with **Melonie Case**, who advised that **Tara** told her to tell the boys not to go into their room. **Brandon** went into the room and said they were all lying about something. All three of them began to argue. **Tara** jumped up and pushed past **Brandon** and he grabbed her around the neck. She didn't know what hand he used to grab **Tara**. She didn't see **Brandon** push **Tara** into anything and didn't see **Brandon** touch **Sienna**.

I made contact with **Brandon Case**, who advised that his mom was getting the girls ready, he went into the room, and they all began to argue. **Tara** pushed him first to get by him and pushed him with her shoulder and hand. He grabbed her by the hair, she turned around, and he grabbed her around the jaw. **Sienna** hit him and he grabbed **Sienna** around her face. **Sienna** fell back on the bed and started kicking [him]. He stated that he was "being an idiot, was mad, and **shouldn't have done it.**"

I observed that **Tara** had a small scratch on the left side of her neck. I did not observe any visible physical injuries to **Sienna**. **Brandon Case** had scratches on his right arm, to which he advised were from **Sienna** kicking him.

I determined that [REDACTED] and **Brandon Case** [REDACTED] and have for [REDACTED]. [REDACTED] and **Brandon Case** is their cousin. Both **Tara** and **Sienna** declined the use of EMS (Emergency Medical Services) and did not need a domestic violence shelter. I contacted CIC (Crime Information Center) and spoke with Operator Stoner (#8218). I advised Operator Stoner to verify if **Brandon Case** had any previous battery convictions, to which she advised he did not.

Based on my investigation, I determined that **Brandon Case** did actually and intentionally touch or strike **Tara** and **Sienna**, and both were against their will. **Brandon Case** was arrested and

charged with **Domestic Violence Battery Touch or Strike F.S.S. 784.03(1)(A)1. Brandon Case** was transported to the Polk County Sheriff's Processing Center without incident.

Brandon actually uses the name Jared sometimes on his YouTube channel to honor his dead friend, and it occurred to me that in 2017 I confused him with Jared too and he corrected me, that was when we met.

I had no idea that Brandon used Reddit, but I am aware of these disturbing thoughts of his, and I know why he was arrested, it was domestic assault, he assaulted a woman in his home, apparently a family member, who told me That was Jeff, but in his own words "it was her fault"
