Context of situation

The situation involves issues relating to child safety on different platforms which led to Criticism, Targeted harassment, Slandering, Smearing and also threats. The situation involves several different users and organizations. The situation started in August 2025 prior to the Schlep situation.

My apology

This is the key part of the document. I know this is hard to apologize to some of you guys but after taking a moment to process the situation and the evidence and the insanity I just saw. I know owe a lot of you an apology for all that has happened.

To RoCatchers and Schlep.

I want to deeply apologize for the drama caused on both of your pages throughout the past few months. I understand you two have different opinions on different things and I understand you guys are trying to keep the Roblox platform safe. I know that lashing out on you two would've led to some serious problems. I understand that I may have offended you with all of these comments I said and I know it's wrong for me to say those things. I deeply regret what I did to you guys and yes, I do in fact feel guilty about it myself. I will try to be careful what I say about you two from now on to prevent further conflicts.

To the Roblox Community

I deeply want to highly apologize for the outrage I caused. I understand that everyone on Roblox has their own disagreements on something or they had different or mixed opinions on something. I know the whole child safety stuff may be important to some of you. I'm just having a hard time making agreements with things that I'm unfamiliar with. I know this is hard to come out and apologize to this community but now I think it's deeply necessary to do so. I will aim at rebuilding the community's trust and be careful with my words when discussing Roblox related drama on X.

To the communities of Genshin Impact, Blue Archive, ZZZ, Honkai, Stella Sora, Azure Lane, Grand Theft Auto, Minecraft, Battlefield, COD, Fortnite, Arknights, Umamusume: Pretty Derby and RDR,

I deeply want to apologize for my actions if it offended any of you guys from these communities. I understand I might've put the Genshin Impact community in a situation that it wasn't supposed to be in. I understand I might have made a rude comment about Battlefield's rivalry with Call of Duty. I know it was very offensive and almost controversial to those playing on those two platforms. I also deeply apologize to both Activision and EA for saying things about both of your games. I understand you two have rivals of your own and I deeply respect that rivalry between you two. You two both make great games nowadays and I've seen the success in both Call of Duty and Battlefield. I will aim to build trust in the two platforms and continue to share great memories from both sides of the community without causing anymore conflicts or drama.

I also want to deeply apologize to the Genshin Impact, Honkai and ZZZ communities for involving you three in this situation. What I did was very disgraceful and dishonorable to you three. I understand I might have offended you three communities with the comments I said. I deeply regret it and also felt guilty for all of it. I will aim to rebuild trust within these three communities and make amends for those affected.

I also want to deeply apologize to the Blue Archive community for something I do in fact want to admit to because I know I've been hiding it in front of you guys. I want to say that I did in fact use cheats to get past certain parts in the game. It was the most dishonorable thing I've done and I know it probably also affected you all especially those at NEXON. I also want to deeply apologize

to NEXON also for this. I deeply regret it and felt guilty for this. I know I' ve done such stupid stuff like this in the past on Roblox even before Blue Archive launched it' s global servers. I know how bad it is and I know it made things unfair for a lot of you. I will aim at rebuilding trust in that community and maybe making up for the damages caused.

To the other communities involved, I' m deeply sorry for my actions, I may have damaged some community reputations or done stupid stuff on their platforms. I will aim to rebuild trust in those communities and making up for any damage I may have caused.

To Aku

I deeply want to fully apologize for my actions and my outrageous comments including all those things I' ve said and done to you. I understand I may have offended you badly including those associated with you. I understand the evidence I saw or heard are in fact true. I know what I did was extremely disgraceful, dishonorable, disrespectful, extremely offensive, extremely harsh, extremely outrageous, extremely rotten, Extremely unfair and extremely and completely wrong. I deeply do regret all of this I' ve said and done, Yes, I do feel very guilty on all of this I' ve said and done. I will aim to making up for any damages I may have caused to you or the people associated with you and preventing similar issues from happening again. I know this is very hard to apologize.

My explanation

Predator allegations

The predator allegations have been going around for months and I know I' m been putting it off on explaining it until now.

The allegations claim about me protecting certain predatory by offering tools like VPNs, Hacking and cheating tools and also tools to report Safety advocates.

The allegations started when **Aku made a derogatory comment on her X page regarding some of these things I previously did.** I realized that I have to stop these things. So, I decided to not go any further with this predatory protection stuff. I already understand the situation and knew what I was actually doing.

I also made comments about Louisiana State Attorney general ' **Liz** ' about some of her posts she made on her X page. I' m literally pissed and considering calling for her to resign because of what she is doing. **A lawsuit against Roblox won' t change a thing about the safety of this platform.** I also said this same thing to Kentucky' s State Attorney general including Florida' s. I know I done this out of frustration but I said these things a reason.

Opinions on KOSA (COPPA 2.0) and the SCREEN Act

As a long-term player of many games including **Roblox**, I have been made aware of these two bills aimed to implement measures which includes censorship. This is something I want to express my thoughts on since these two were introduced.

I want to say that I' m 100% against KOSA (COPPA 2.0) and The SCREEN Act. This also includes the UK' s controversial Online Safety Act. **These censorship bills cause nothing but privacy issues and adding requirements for ID verification raises the risks of people getting hacked or their information leaked. You should NEVER give a platform your ID. Plus, I don' t buy that '**

Think of the kids ‘ or ‘ Protect the kids ‘ stunt from anyone. What these two bills do is cause outrage and absolute chaos. If the bills were to pass, It will pose a risk of being doxed also and worse even you could get framed for stuff you didn’ t do.

So, For those asking about this, I say NO to all things COPPA 2.0 and the Online Safety Act. I’ m against it all and if I need to later on, I’ ll speak up on X about it. I don’ t like thinking about kids on some social media platforms and I seriously don’ t like protecting them either. So yeah, Fuck COPPA 2.0 and fuck Louisiana’ s State Attorney general. Plus, Do I even care of some minor dies because of something nobody wants to hear about. I don’ t actually and I sure as hell don’ t want to deal with any BS about that topic.

You see, I never want to protect the kids, I prioritize on Protecting myself and Adults only. I know it’ s hard to say in front of everyone. I’ ll protect those I know very well though. I also aim to prioritize profits just like what [Roblox](#) is doing.

So, For me, It’ s fuck COPPA 2.0 and fuck the online safety act in the UK.

And what happens if it passes? Well, I will go around X calling Liz a pedophile and see how she fuckin likes it. I bet she’ s already on the Epstein files.

The Epstein list

There was some small discussion about a sensitive topic and this one came up in particular which is about the Epstein list.

Not much is discussed because I have no knowledge of the scheme or the topic. However, When I went out to research the topic further. I found this somewhere.

After searching around the document for some of the names mentioned on some posts and yes I' m being serious about this.

There' s no ' Elon Musk ' or ' Donald Trump ' on the document as the posts rumored which now means the Epstein victims have lied about it completely. There are many posts from Democrats and liberals calling for the Epstein files to be released.

As Donald Trump (President Trump) stated on Truth social multiple times, The whole Epstein rumor is a ' Hoax '.

The actual reason why he could be covering something up is that he doesn' t want you or the world to find out that he was anywhere on the files and he' s doing it so that he can protect his image and prevent himself from getting impeached.

Aku Situation

The Aku situation started in August as a small dispute then later on turned into complete physiological warfare breaking out.

Me and **Aku** have been doing stuff to each like smearing each other with posts directing back and forth, Threatening each other' s lives, Slandering each other, doing woke things to each other and even made hateful comments about each other. This has been going on for a while and it must be stopped. The situation got so worse that even Grok now knows about it somehow. This situation is almost as worse as Sinder' s situation.

Yes, I went silent on **X** multiple times to let her say something. Thanks to the folks I spoke too on **Discord** in private. I was able to come up with a solution.

Yes, We did in fact reported each other in frustration.

She deactivated that Roblox account due to safety concerns.

After some time later, I was doing some asking around on different platforms. NightmareRain which is one of her associates was eventually found on Roblox. I caught the username and decided to do some searching around the profile for anything that might violate the terms until nightmareRain pointed out that it wasn't their profile, It was the profile of an innocent user. So, Then realized its not worth it and backed off

Safety advocacy conflict

The safety advocacy conflict started back in March 2025 due to a disagreement with Synospace over child safety on Roblox.

RoCatchers started discussing about Teddy, A user who has been a long-time developer of the Roblox Community was accused of pedophilia falsely after RoCatchers found a bed area in one of his games. This led to me and the agency Synospace interfering in this matter because we think Teddy' s own reputational safety is something we prioritized for a little while.

The June 18th post sparked outrage from me and Synospace leading to a conflict on what side we're on.

We only defended Teddy because of his popularity on Roblox and we couldn't risk a popular developer being banned over a stupid accusation.

The conflict ended in July 2025 due to lack of updates from Roblox. We almost filed a lawsuit against Rocatchers for their post about Teddy but I backed off after further review and realizing that the situation was only something Roblox can only handle and we weren't allowed to interfere in the matter further.

If Synospace were to continue to interfere, Yeah, I could've led to a more dense situation

TwitchCon 2025 incident

TwitchCon is a yearly event hosted by Twitch to meet and greet with famous streamers from around the country.

An incident occurred when a streamer identified as 'Emiru' was assaulted by a guy attempting to kiss the streamer on the neck. The suspect walked out with no issue but twitch responds by banning the guy from the event.

I apparently made a false claim on X saying I was a security officer for the event and didn't react on time when it took place. I also made false claims about defending 'Emiru' too.

Twitch did reach out to me personally and privately that I should be fine with attending next year's TwitchCon.

The situation was small and is currently resolved since.

Allegations of cheating and hacking

Recently, I have faced allegations involving hacking and cheating in both Roblox and Blue Archive. I want to clarify my position on these issues. I know that Roblox's Terms of Use clearly ban any form of exploiting or changing the client, and I take full responsibility for understanding those rules now. Although I've been accused of using certain third-party tools, I want to stress that I do not support cheating. I've learned how such actions can harm the experience for other players and break community trust. My focus now is on playing fairly and promoting a healthy gaming environment.

Regarding Blue Archive, I want to address the allegations directly. I have never used, downloaded, or tried to use any cheats, scripts, or hacks in Blue Archive. Doing so would go against both my personal values and the game's Terms of Service, which explicitly prohibit any unauthorized changes or manipulation of the game's systems. I've always played Blue Archive honestly, and I respect Nexon's rules for ensuring fair gameplay and data security.

Overall, I understand how serious accusations like these can be. I've taken time to think about the importance of fair play and following community

guidelines in all online games. Going forward, I' m committed to being open, playing by the rules, and setting a better example in the gaming communities I' m part of.

I was also accused twice as using private servers on two different Hoyoverse games such as Genshin Impact and Honkai: Star Rail. I do want to clearly say that I use these for testing purposes only and not for actual gameplay. This gives me the opportunity to try out characters before I pull for them.

Allegations of religion issues

Since January 2025, I have been hit with criticism over me criticizing Christianity over core beliefs and it' s values. I understand that Christianity may be important to some people but sometimes certain beliefs can get a little out of hand when it comes to setting dates for rapture predictions that could cause an insane amount of problems. I do understand attempting to remove street preachers or even doing it by force could have led to Criticism from Christian communities and pastors.

I also have received criticism over twisting the Bible multiple times during this year. I understand you guys want the word to come out more detailed but the twisting Is something I did to adjust the word for better understanding and detailed explanation on certain parts. I did receive criticism about the satanic stuff I do on my pages especially on Roblox.

There' s also been a history of criticism over me using mockery and blasphemy multiple times against Jesus Christ, God and the holy Spirit. I understand what I did or was all serious transgressions I' ve committed over the past 2 years. The mockery comments I made have also sparked widespread criticism.

I do want to say some things to address the issues with religion.

I was born without a religion, I was not associated with any as I chose to remain as a non-religious person. I was never baptized ever in my life. I also had to a make a decision when I got older if I want to continue being a non-religious person or move on with one. I decided and chose not to surrender my

life to Christ at all. In 2025 on April, I aimed to study each religion and decide again if I should be in one later on.

As I' m currently still researching the religions more, I still take a more careful look at the core beliefs of each one to better understand the purpose of each religion.

I fully respect anyone on different types of Christianity which include.

- Eastern and western orthodox
- Catholics
- Non-Practicing type Christians including Lukewarms.

Also, I highly respect those of the Catholic Church and Catholic communities since they' re more honest about their beliefs. Eastern and western orthodox Christians also are more detailed and more streamlined on their beliefs. I currently still follow people on X who are part of these sides.

I understand that the chances of getting into heaven are slim but who knows, Maybe I' ll be lucky enough to enter if I change things up a bit someday.

Allegations around different organization relationships

As stated on previous posts, I treat every community or organizations with 100% respect and honesty even in any situations.

Recently, I was criticized for giving different organizations and platforms including communities special treatment and using them during situations where it' s not supposed to be involved in.

I understand that dragging other communities into one situation could lead to potential clashing with the other communities along with other criticism being sparked around.

Communities and organization will continue to be treated with the respect they wanted without anymore of using them to completely cause sabotage to others.

For example, I almost brought Hololive (COVER Corporation) into a situation where it' s not supposed to be in and well, I was told not to. so I' m sorry if I did that.

Spawnism rumors

Spawnism is a cult made up from the Roblox game 'Forsaken ' by a random user who claims that if you die, You would respawn. The cult involves the worshipping of the spawn symbol still currently used by some players to this day.

Synospace initiated a plan back in April to expand the cult into Jerusalem and the UK but due to the UK' s online safety act, it was planned to be expanded to Jerusalem in Israel. The plan was later dropped after I received criticism that I was attempting to turn the cult into a full-fledge religion.

The plan resurfaced in July to establish Spawnism as a religion but it was later dropped for the second time after extreme backlash broke out across different platforms.

Since then, It was never mentioned again.

Looking back at past incidents or situations

Hoyoverse / Cognosphere Loot box incident

The Hoyoverse loot box incident is an incident that took place on its popular hit game 'Genshin Impact'. The incident in question is related to loot boxes. Because of this incident, The FTC slapped Hoyoverse with a whopping \$20 million for it. That's when Hoyoverse announced later on that they are introducing age verification but in a minimal type. All you had to do was put your DOB in and that was all. No ID required.

The Ruben Sim incident is one of the most controversial incidents that took place on Roblox. The incident started with Ruben Sim using homophobic and racial slurs, Sexually harassing other players and even uploaded pics of Hitler into the platform. Ruben Sim is also accused of being a leader of a ‘ Mob ‘ making terrorist threats which led to a temporary shutdown of an October developer conference. Ruben Sim is also held responsible for violating anti-hacking laws.

Speculations later came up thinking Ruben Sim could be some Islamic mob leader.

What' s changing

Changes will be made to adjust to currently enforced or updated platform guidelines. Please note that it takes time to apply each of them.

- Posts regarding the Schlep drama will no longer be made in order to comply with Roblox Terms of service and it' s currently enforced

community guidelines. This will prevent any situations similar to this from happening in the future.

- To comply with the X Rules, I will be changing to a more streamlined algorithm. Normal posts or reports will still be made. It's just that I won't be discussing the Schlep situation anymore.
- I understand the situation with predators being a thing on Roblox. So, I will only be reporting them to the minimal extent. I will now be only reporting any predators to only the platform's moderation itself. I WILL NOT be reporting anyone or making anymore tips to the NCMEC as that will be the for the moderation team of that platform to decide on for themselves since each one has a relationship with that organization especially Roblox.
- Discord server rules will be changed or readjusted to comply with Discord's Terms of service and any of its guidelines. Double Counter will still be implemented to comply with the guidelines.
