On Saturday, October 24, 2020, at approximately 1528 hours, I responded to 2710 English Ivey Lane, Longwood, Seminole County, Florida, in reference to a telephone call the Sheriff's Office received on a non emergency line from telephone number 407-216-1400.

The person on the telephone identified himself as Clayton Huff and he had just killed his parents and had his siblings tied up in the kitchen along with the deceased bodies of the parents.

As units arrived, a perimeter was set up on all corners of the house, a contact teams was formed and we attempted to make contact with the caller without success, who had hung up on the communications center. The Sheriff's Office communications center was able to identify and locate the homeowner of the home, who was out of town.

The homeowner informed me the Sheriff's Office is being "swatted" and there was no emergency.

The Sheriff's office made contact with the sole occupant of the residence who was unarmed, cooperative, and no violent crime were located.

The homeowner and occupant were very concerned about their privacy and the release of this report, body cameras, and in car cameras.

I provided a business card to the sole occupant of the residence to document this incident for further investigation.

Due to the homeowner and occupants privacy concerns, they were deliberately left out of this report. See event screen for further which was marked as an ONGOING INVESTIGATION - NOT FOR PUBLIC RELEASE.

On the morning of January 8th, 2020 at 0118 hours, I responded to 2710 English Ivy Court located in Longwood, Seminole County in reference to a shots fired call for service (event number 20210080167).

While enroute to the scene, a caller identifying themselves as "Glee Chum" using an apparent phone number of 646-598-7134 advised there were shots fired. The caller also provided information that they saw a flash from the backyard of the residence as well as a female screaming. The caller stated his address was "2715 English Ivy Court". It should be noted that this address does not verify in MiCAD, and does not exist inside the Wingfield North community where the target residence is located.

It should also be noted that the homeowner of 2170 English Ivy Court, Clayton Huff () contacted the Sheriff's Office on January 3rd, 2021 under event number 20210031953. In this event, Huff advised that he would be streaming online in front of thousands of viewers, and that somebody may contact the Sheriff's Office in reference to an urgent disturbance in the manner of a "swatting" call, or providing unfounded or blatantly false information to our communications center.

Upon arrival, initial contact was made with a male subject via a Ring doorbell camera. Contact was then made with the homeowner and his friend, Nicholas, who advised they were okay and there was no disturbance. Huff and Nicholas also advised they were streaming themselves online, and that was likely the reason the shots fired call was received.

Huff provided his current phone number of 689-710-3994 for reference. Huff is cooperative with law enforcement, however, he has explained that if he leaves his online streaming session in an obvious manner, the person who made the false disturbance claims will be able to see this and it will encourage repeat events.

Prior to making contact, we surveilled the residence for several minutes with no sign of anything suspicious. Other citizens in the area also advised they did not hear any gunshots, and any other disturbance. This final disposition of this event was unfounded.

On January 21, 2021 at approximately 0345 hours, I, D/S Mattingly responded to 2710 English Ivy Ct, Longwood, Seminole County, FL in reference to an alleged sexual molestation between father and juvenile son.

The initial call was received from the National Center for Missing and Exploited Children Hotline. The caller from the hotline advised their caller stated they were advised Stewart Ray Huff was molesting his 12 year-old son, Clayton Huff. The caller provided a phone number of 407-573-7717. After running the phone number provided, it appears to be a fake phone number as it is not registered to anyone.

Reference previous events, I was familiar with the residence and knew the alleged 12 year old victim was, in fact, an adult. Clayton Huff [REDACTED] is the homeowner of 2710 English Ivy Court. This has been verified several times from previous events.

Upon arrival to the residence, contact was made with friend and roommate, Nicholas, who confirmed they are the only two people who live there and everyone was ok.

Nicholas advised the calls will not stop unless law enforcement stops responding. He advised when the callers see he of Clayton leave their live stream due to their calls, it validates the purpose of the call and only encourages future calls.
