On 02/20/2021, at approximately 1603 hours, Deputies responded to 2710 English Ivy Ct, Longwood, Seminole County, Florida, in reference to a possible shooting with injuries to a minor.

The caller, who identified himself as "BIKKIKKICCIKK" and used the telephone number (445)200-3729, advised that he "shot his sister". It should be noted that there are several reports in CAFE regarding similar calls at this same residence. It was the belief that this was a "swatting" incident.

While Deputies and Emergency Medical Services were stationary near the residence, Dispatch advised that there was history in FINDER with the same phone number. The subject contacted the Tampa Police Department on 01/25/2021 and on 02/02/2021. Both incidents were determined to be "swatting" calls.

Deputies made contact with a male subject at the residence. The male subject appeared knowledgeable of the previous "swatting" incident and advised that no one was in danger. Deputies asked for consent to enter the residence and confirm if there was an emergency or not, but the male subject denied consent.

A report was documented due to the repeated incidents involving this particular residence.
