On 02/21/2021, at approximately 1609 hours, Deputies responded to 2710 English Ivy Ct, Longwood, Seminole County, Florida, in reference to a possible shooting with injuries to a minor.

The caller only identified themselves as a male this time, but they used the same telephone number (445) 200-3729 as yesterday's event. The caller advised that he "shot his father". It should be noted this is the second incident within the rotation with a similar story.

I contacted the homeowner, Mr. Huff, who advised that he was streaming live in the residence and that no one was in danger. Mr. Huff advised he was unable to step away from the computer at the time, but his roommate or mother would be arriving shortly to assist law enforcement.

Once Mr. Huff's mother arrived, Deputies were escorted inside and verified that no one was in danger. It was determined to be another "swatting" incident.

A report was documented due to the repeated incidents involving this particular residence. Please see cases 2020-6062 and 2021-1022 for a reference.
