**ORDER (1) GRANTING WITHDRAWAL OF ATTORNEY; AND  
(2) DIRECTING THE CLERK OF COURT  
TO UPDATE THE CASE MANAGEMENT SYSTEM**

IT IS ORDERED:

1. The Court grants the motion subject to the conditions below. The Withdrawing Attorney and Withdrawing Law Firm must fulfill all conditions identified in this Order for the withdrawal to be complete. Once all conditions have been completed successfully, Withdrawing Attorney and Withdrawing Law Firm are relieved of further responsibility in this case (except as provided below) and no longer are the attorney of record for Party.

2. Withdrawing Attorney and Withdrawing Law Firm must immediately serve a copy of this Order on all parties or their attorneys, **including Plaintiff**; execute a certificate of service identifying all persons served with service information; and file the certificate of service in the Court file.

3. Withdrawing Attorney and Withdrawing Law Firm must submit to the Court any proposed orders or judgments within the timeframe identified by the Court as well as respond to all Court requests for revisions to the proposed orders or judgments.

A self-represented Party must review Florida Rule of General Practice and Judicial Administration 2.516.

6. An attorney in good standing with The Florida Bar must represent corporate entities and, if Party is a corporate entity, the failure to have successor counsel file their appearance timely could result in the Court striking Party's pleadings, entering a default, dismissing the action, or other appropriate action.

7. Nothing in this Order impacts the e-service list hosted by the Florida Courts E-Filing Portal. Withdrawing Attorney and Withdrawing must separately remove themselves from the Portal's e-service list according to the Portal's procedures if they do not wish to receive further filings.

8. The Clerk shall deactivate Withdrawing Attorney and Withdrawing Law Firm as attorney of record for Party in this case within the Case Maintenance.
