the defendant digitally penetrated her several times to the point that she remembers her vagina being red and raw. [REDACTED] stated
that when she was about 11 years old the defendant came into the bathroom while she was naked, and was touching his penis
into her over and over again. [REDACTED] stated that she was uncertain if there was any penetration because she does not think he
knew what he was doing. [REDACTED] stated that a fluid came out afterwards, but she remembers thinking he was peeing inside of
her, because she was so young and did not know any better. [REDACTED] further added that she was forced to touch the defendant's
penis several times over several years, and that she would touch him until he ejaculated. [REDACTED] is currently enrolled in college in
another state and came to Manatee County on 4-16-2010 with her sister to report the sexual abuse that occur when she was a
child. The defendant is now 27 years old and enlisted in the United States Navy. Your affiant requested the assistance of the
Navel Criminal Investigative Service (NCIS) to obtain a interview with the defendant due to the fact that he is stationed in Bahrain.

On 06-03-2010, NCIS sent your affiant a typed confession from the defendant in which he admitted to committing multiple crimes to include sex battery. SEE EXHIBIT "A". The defendant stated that he started touching his sisters because he was curious and then eventually became addicted. He stated that while he was growing up, his parents were very strict, and he was not allowed to visit any of his friend's houses. The defendant further added that he remembers that the touching starting when he was about 11 years old with another sister, [REDACTED] who was about 6 years old at the time. The defendant added that over the next 3 years that when he found his sisters alone that he would fondle their breasts and vagina area. The defendant added that most of the time he would touch their bare skin and he would keep his clothes on. The defendant also admits to having [REDACTED] touch his penis, even though she did not want to. On one occasion, the defendant recalled getting into the shower with has naked sister [REDACTED] and possibly penetrating her with the tip of his penis. The defendant stated that [REDACTED] always wanted to be a doctor, and she seemed more curios about the body and was more receptive to the sexual activities, so he touched her more than [REDACTED]
