## Introduction:

Recently, a Roblox commentary YouTube named "[GwamgoXD](#)" on YouTube has begun harassing Sebmotions with allegations of pedophilia. This is all completely untrue, I will go over his manipulation in this document. Every point he makes has been debunked several times. He made his accusations of him being a pedophile before he actually explained why he thought so in an interview a couple days from the video coming out.

His actions are extremely immature and are a clear example of cancel culture. Sebmotions has made mistakes, but what they are claiming is worse than what actually happened and there is plenty of proof to back it up. This has been going on for years, it's time someone puts a stop to this borderline torture Sebmotion induces from people.

We will be going over the Sini situation which was a result of Sini, Arhum who has been harassing him with police reports and false claims, Kae who Seb asked her out to try to make her feel better when he thought she was 17 to cheer her up after Eggroll broke up with her, and finally how Gwamgo is using his platform to bully Sebmotions around and claim he is a pedophile.

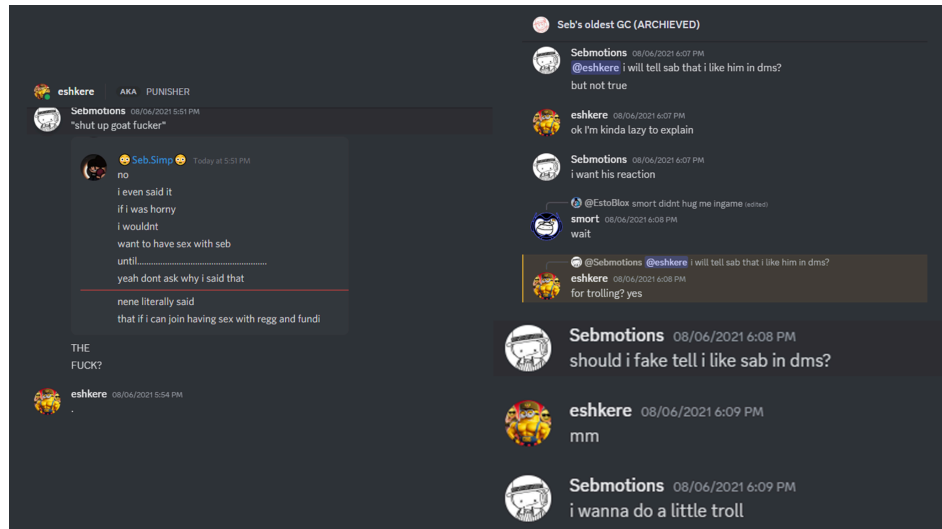

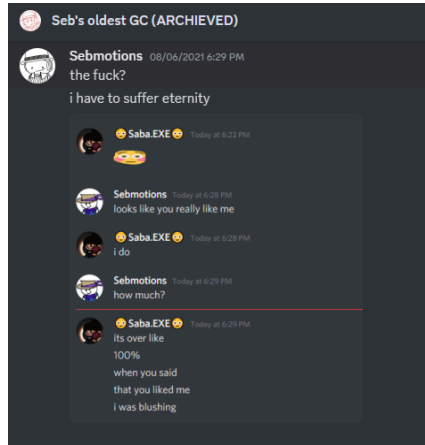
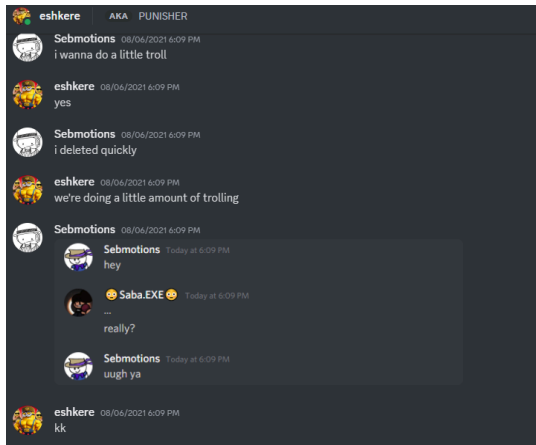

## What happened and why:

His past friend and him were shocked by the messages. Seb thought it would be funny to immaturely troll Sini by saying “i liked him”. It was supposed to be a harmless joke to “expose” his weird behavior towards his friends, but Sini would end up taking it seriously.

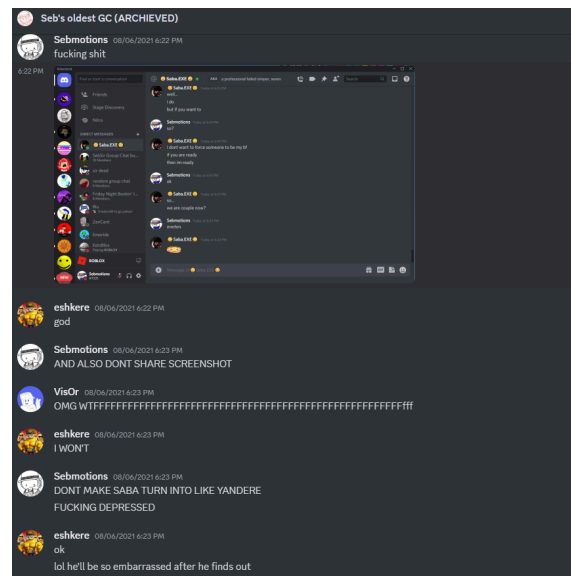


Seb acknowledged it was wrong and immature to do as an adult, he just wanted to see his reaction to the joke (as well as his friend). Seb never wished any harm towards Sini and he was disgusted by Sini's actions towards him.



Seb noticed Sini was getting more creepy, so he sent some images to a gc he had and asked they were not spread around.

Seb would delete many of his messages right after sending them because it was part of the joke/troll, however Sini would screenshot the messages. Sini responded with an emoji and said he liked Seb 100%.

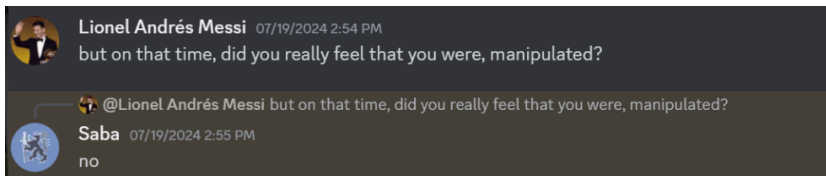




## Aftermath:

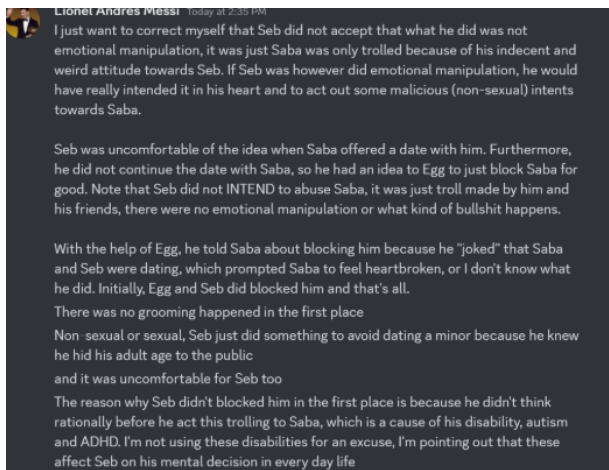

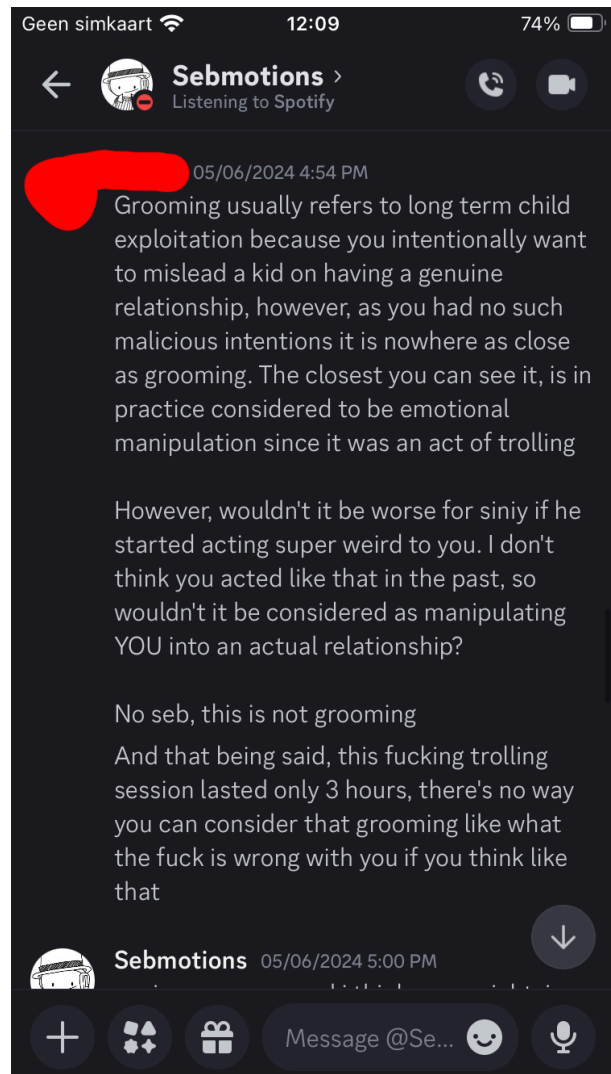
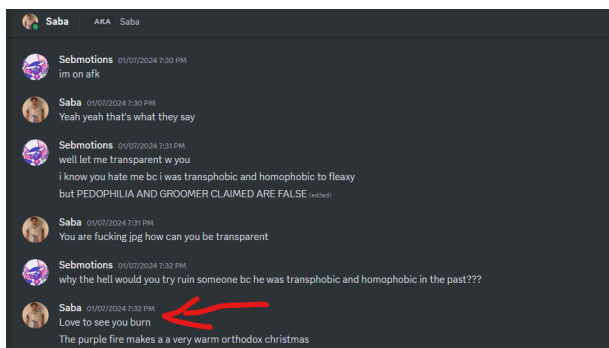


Multiple people have vouched for him explaining he never groomed anyone in complete detail.

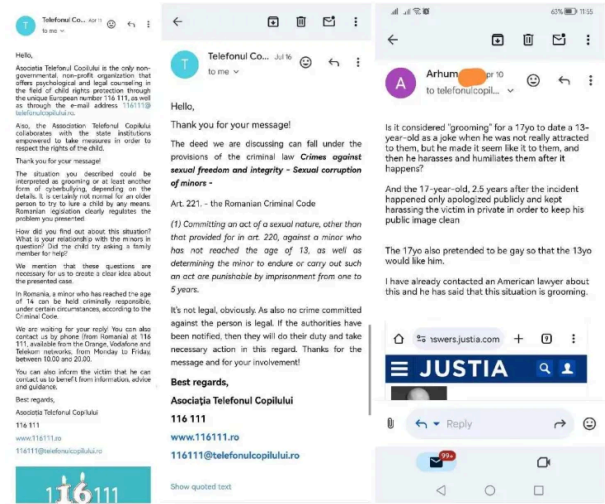
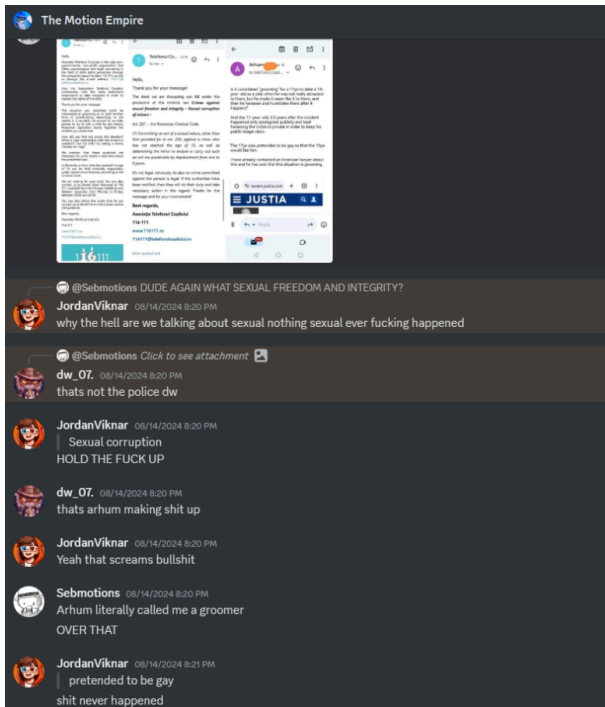

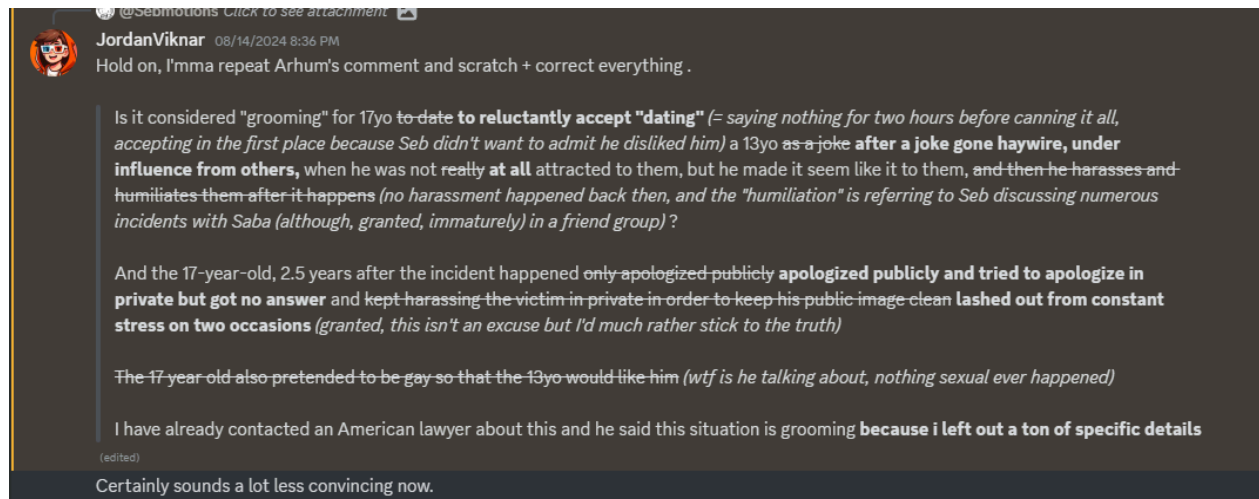
# Arhum situation:

## Arhum's claims:

Arhum attempted to claim Sebmotion was gay, this claim had 0 backing to him every claiming "I pretended to be gay" and pretending to be gay for Siniy. He has completely twisted the context before he sent emails.



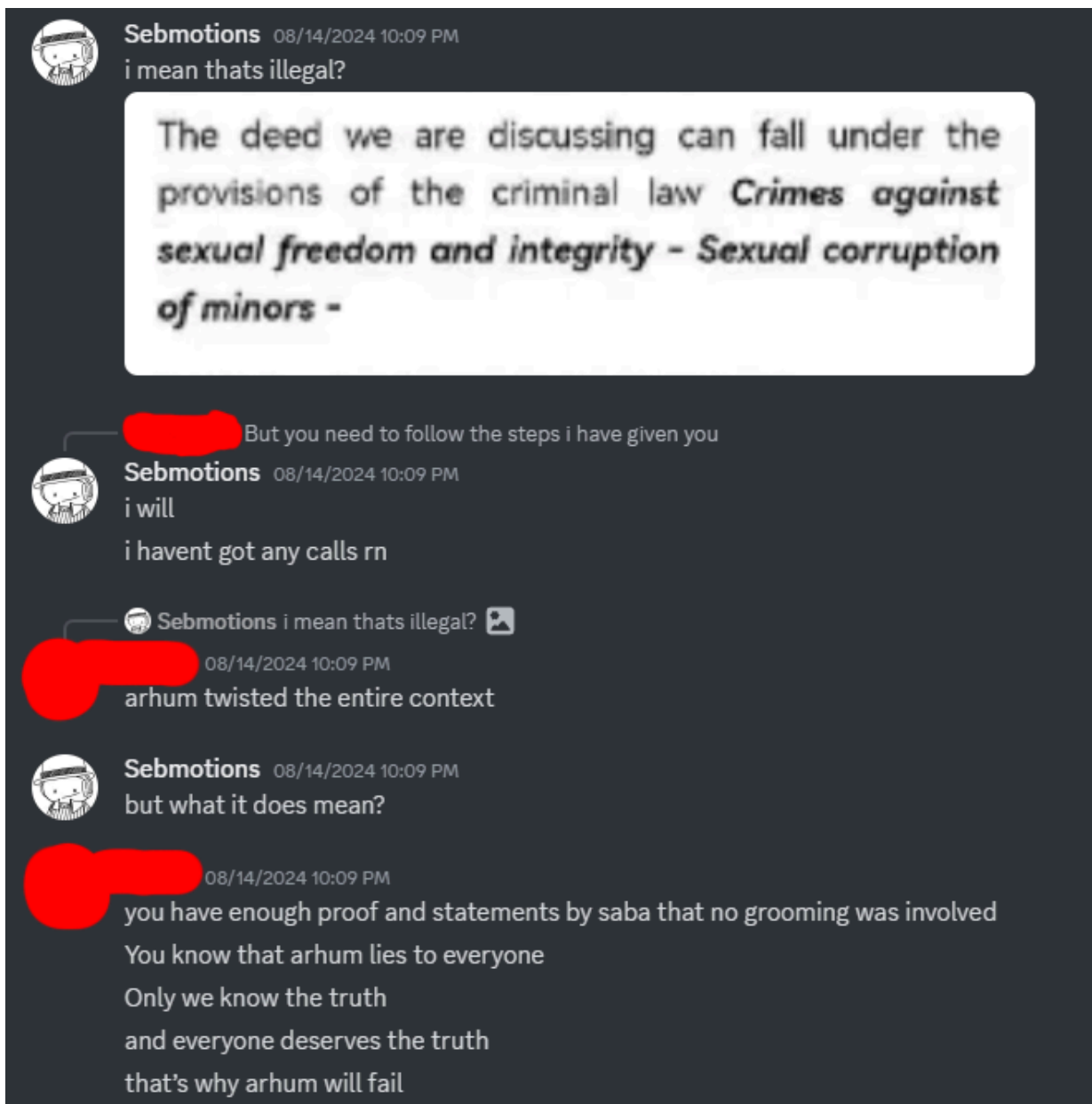
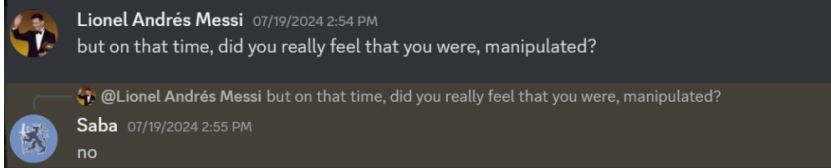
A friend of Seb called Jordan, responded as well. (Image below)

Seb never sent NSFW pictures or sexually explicit messages, nor manipulated Sini into engaging in sexual actions. Sini had been behaving this way before they talked.

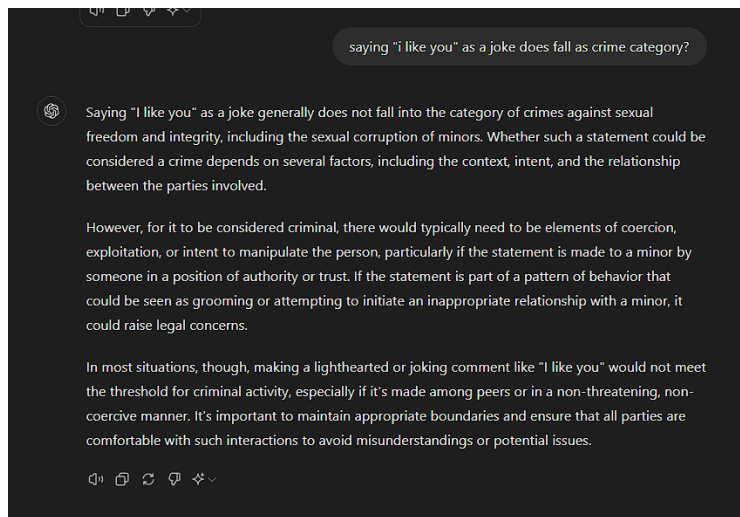
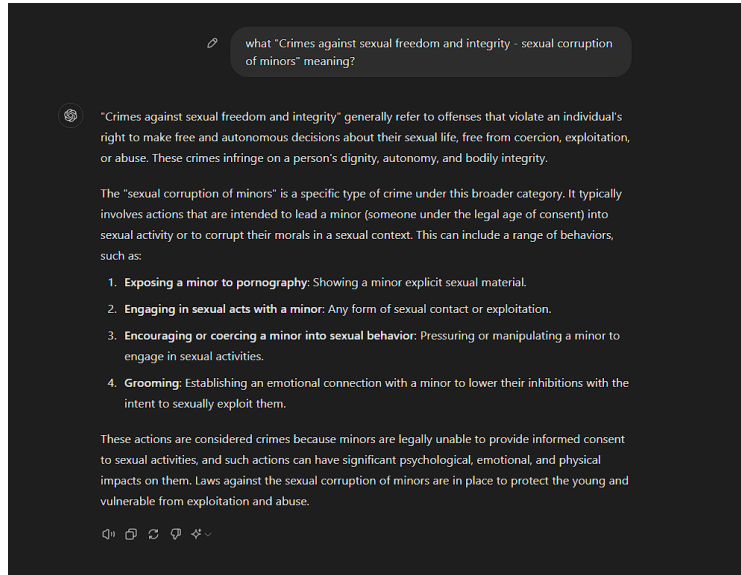
The deed we are discussing can fall under the provisions of the criminal law **Crimes against sexual freedom and integrity - Sexual corruption of minors -**



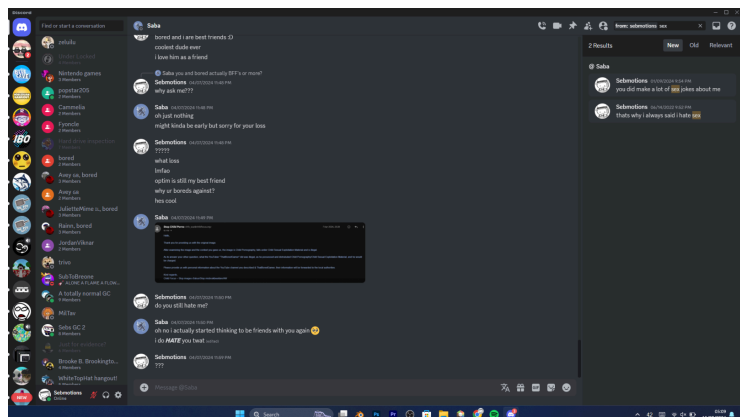
All Seb did was sarcastically say "I liked him" in a joking manner and then quickly delete the message. This does not violate anyone's sexual freedom. According to ChatGPT, this is what it means.

ChatGPT also says that the i like you joke isn't doesn't fall into those categories at all. This proves Seb didn't do anything illegal and Arhum was manipulating the story all along. Arhum even told them it was a joke in that email too.

In conclusion, the 2 source levels have been debunked and now I will explain all of Arhum's manipulative behavior.



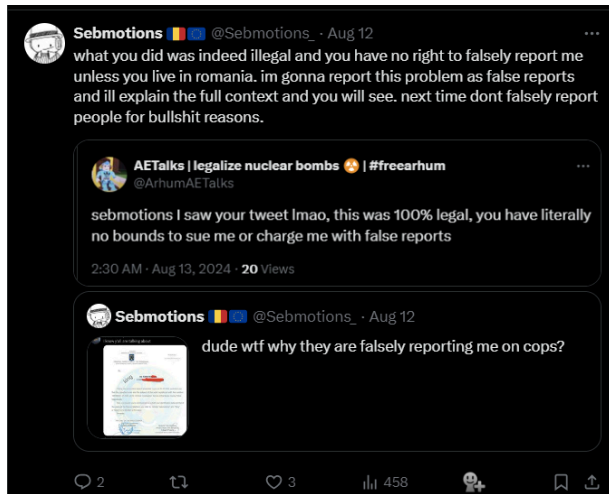
## Arhum's manipulation:

Arhum has manipulated many people and victims. He also tries to lie about everything that has happened to Seb.

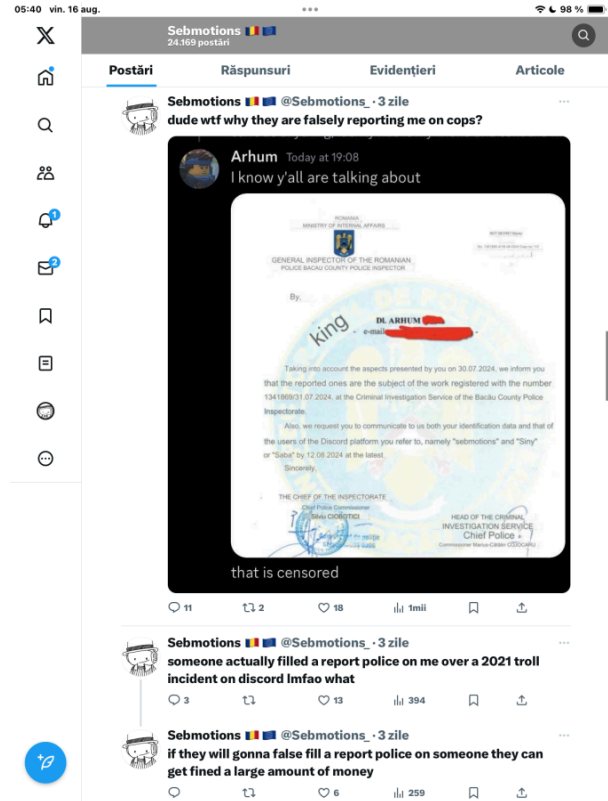


Arhum has no proof Sebmotions tried to get him in trouble

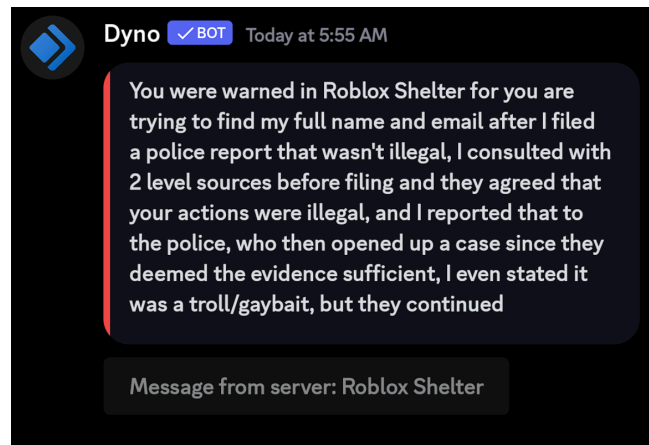
Oh and before Arhum tries to bring this up



Arhum then got him falsely warned in the Roblox Shelter server. He's bringing up the claims that have been already debunked.

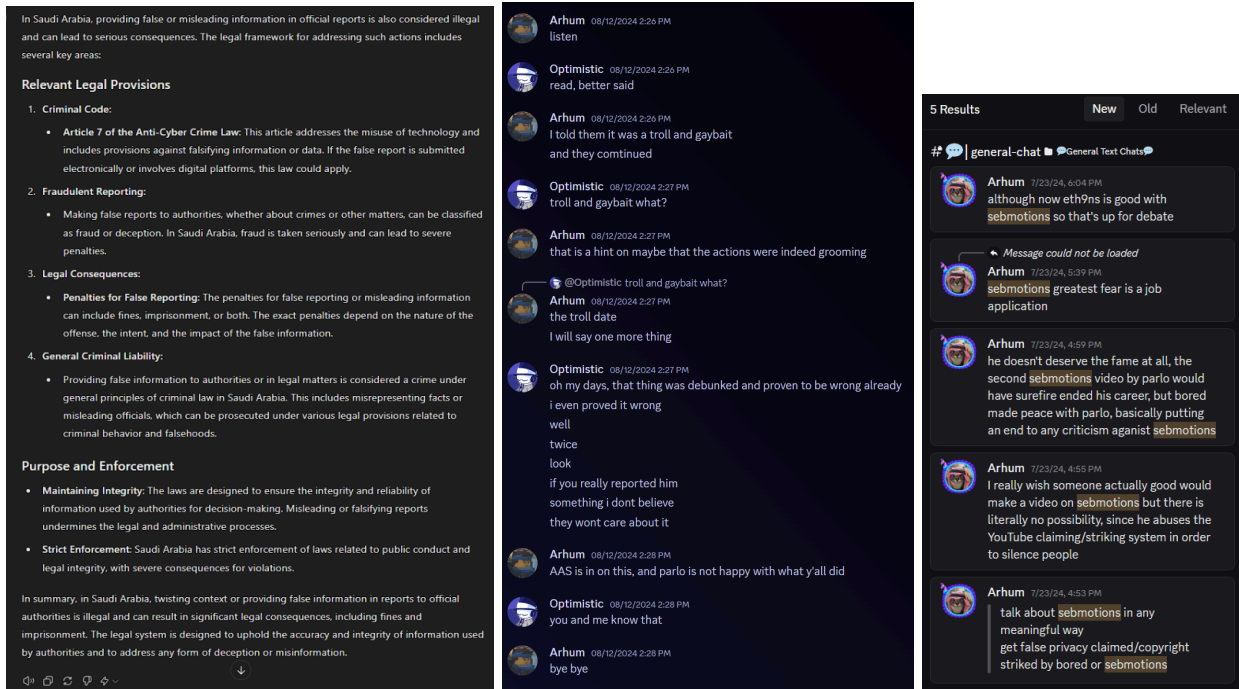


Seb was actually going to report this case as false with proof, since when did he mention he was going to get you in trouble. If he had, then it wouldn't be a false report since Arhum was falsely reporting him for false allegations.



It's also illegal for Arhum to falsely report Seb in Seb's country according to ChatGPT and the law.

Arhum also tried to brainwash multiple people, using Optimistic. His manipulation didn't work on him but it worked on the members of Roblox Shelter.

Arhum can also be seen insulting Sebmotions, saying "sebmotions greatest fear is a job application.". This proves he clearly has a bias towards him and is willing to harass him behind his back when things don't go his way.

# Arhum's legality:

Arhum can be charged with these crimes.

In the Romanian Civil Code, defamation is addressed under the provisions related to non-patrimonial rights (rights that do not have a financial value but are connected to personal dignity, honor, and reputation). The relevant articles include:

**Article 268 - False Reporting**

This article of the Romanian Penal Code states that making a false report to the authorities, such as the police or other official bodies, with the intention of misleading them, is a criminal offense. This includes:

**Falsely reporting a crime:** Claiming that a crime has occurred when it has not, with the intent to deceive the authorities.

**Falsely accusing someone of a crime:** Intentionally accusing an innocent person of a crime they did not commit.

**Penalties**

The penalties for false reporting can include fines or imprisonment, depending on the severity of the false report and the consequences it caused.

**Purpose**

The law aims to prevent the misuse of judicial resources, protect individuals from false accusations, and ensure the proper functioning of law enforcement and judicial authorities.

In summary, making false reports in Romania is illegal and is punishable under **Article 268 of the Romanian Penal Code.**

“Yes, it is illegal to twist or distort the context of information when submitting a report to an official site in Romania. Such actions can be considered as providing false or misleading information, which may fall under several legal provisions, depending on the nature and intent of the misrepresentation. Relevant Legal Provisions False Reporting (Article 268 of the Romanian Penal Code): As mentioned earlier, this article makes it a criminal offense to provide false information to authorities with the intention of misleading them. If the distorted context of the report leads to a false understanding of the situation, this could be considered a form of false reporting. Perjury (Article 273 of the Romanian Penal Code): This article criminalizes making false statements under oath in legal proceedings or to authorities. If the distorted context is presented in a way that it amounts to false testimony, it could fall under perjury. Fraud (Article 244 of the Romanian Penal Code): If the distorted context is used to deceive an official authority in a way that results in financial gain or other benefits, it could be considered fraud. This includes submitting reports that twist the facts to gain an advantage or cause harm to

another person. Penalties The penalties for these offenses vary, ranging from fines to imprisonment, depending on the severity of the distortion and the consequences of the misleading report. Purpose These laws are in place to ensure that authorities receive accurate information, which is essential for the proper functioning of public institutions and for justice to be served. Misleading or distorting information undermines this process and can have serious legal consequences. In summary, twisting the context when submitting a report to an official site in Romania is illegal and can lead to criminal charges under various provisions of the Romanian Penal Code, depending on the nature of the distortion.” - Sebmotions, Aug 15, 2024.

2 years ago a person called Eggroll on Seb's server used to be dating someone called Kae, Eggroll was a really bad person to her and broke up with her which made her depressed.

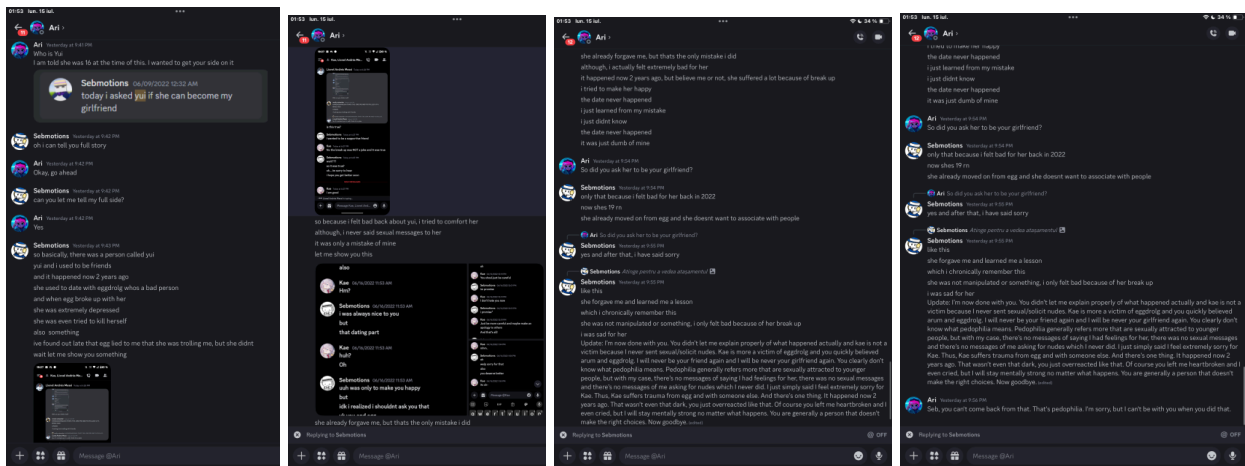
Seb was under the impression she was 17 (he was 19) because he was told this by people who knew her.

Eggroll two years later brings this back up, claiming Seb is a pedo when he never said anything sexual to her. He just wanted Kae to stop harming herself.

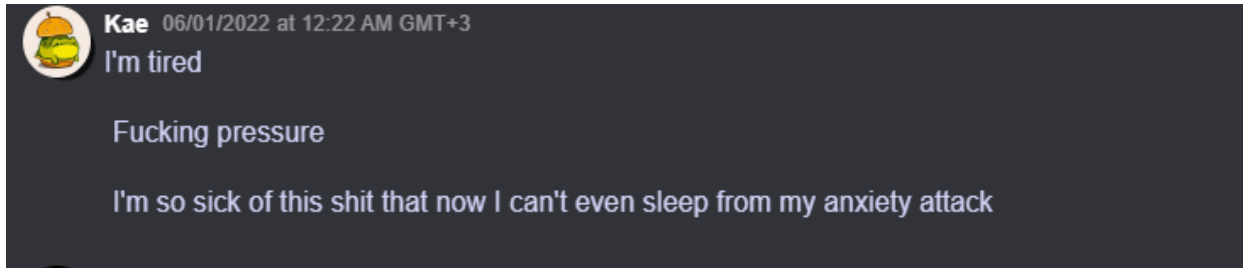
Eggroll then messaged Seb's real Girlfriend Ari which resulted in Ari breaking up with Seb. She didn't believe him and thought it was pedophilic.



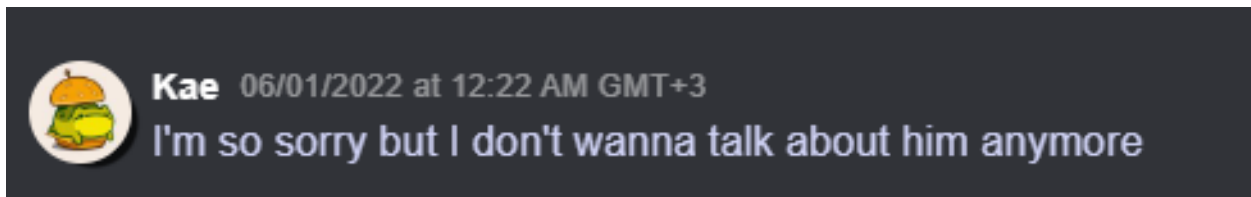
This would result in Seb having a mental breakdown.

This is how Kae guilt trips Sebmotions into feeling sorry for her.

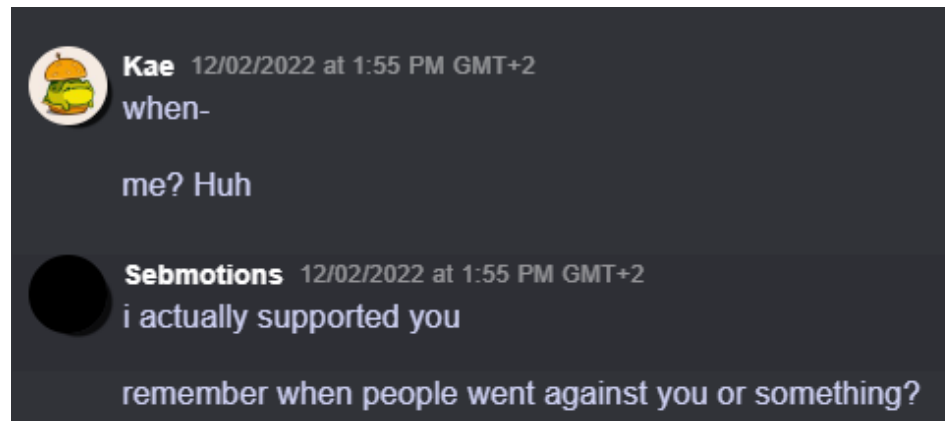


Kae constantly makes Sebmotions feel bad for her, with this guilt tripping. I will show the evidence down below:



Kae always expects Sebmotions to feel bad for her, and when he tries to comfort her; she tells him that she doesn't wanna talk about it anymore?

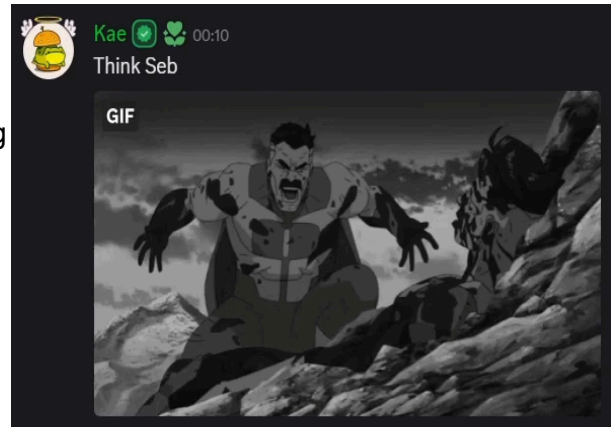

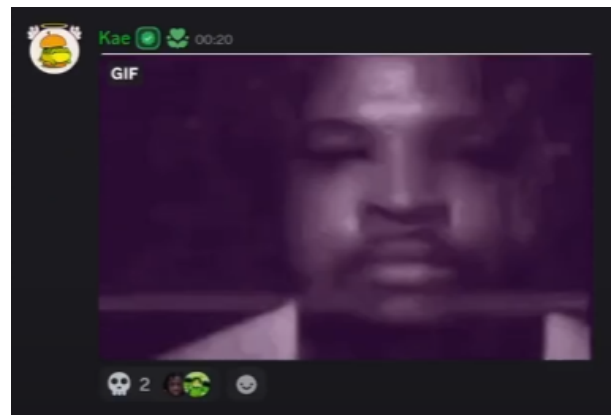
Kae's visible arrogance: (From Parlo)

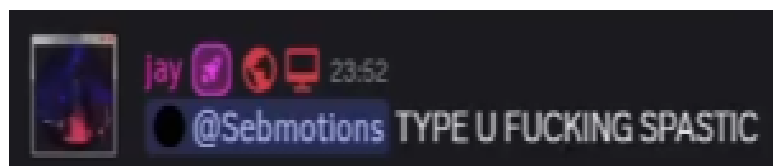
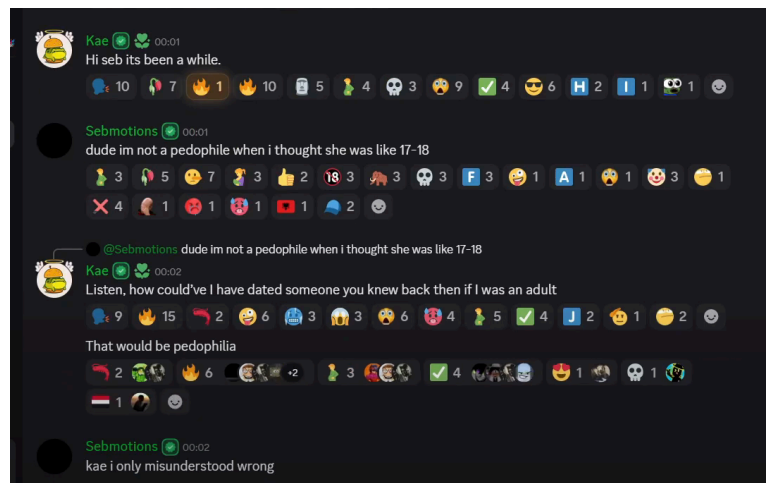

If you was invited, you would've saw the discord

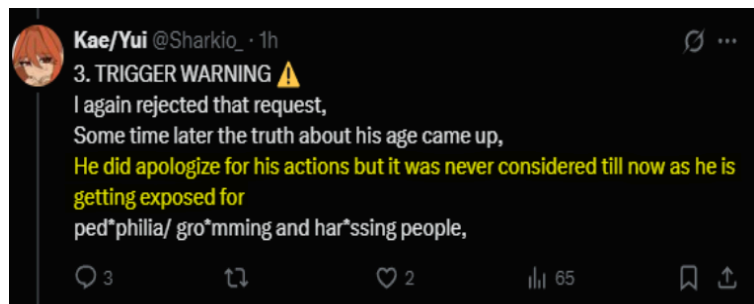
Server itself and saw that it was a condo server.

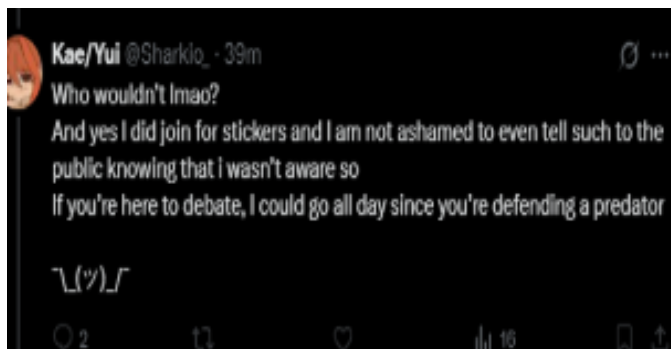


Kae's blocked Rarlo and Optimistic over confronting her on X:

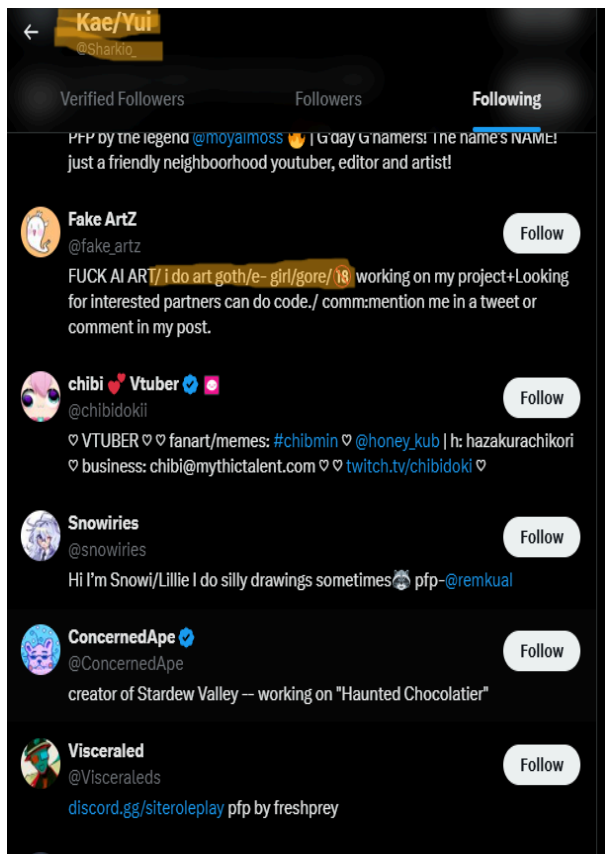
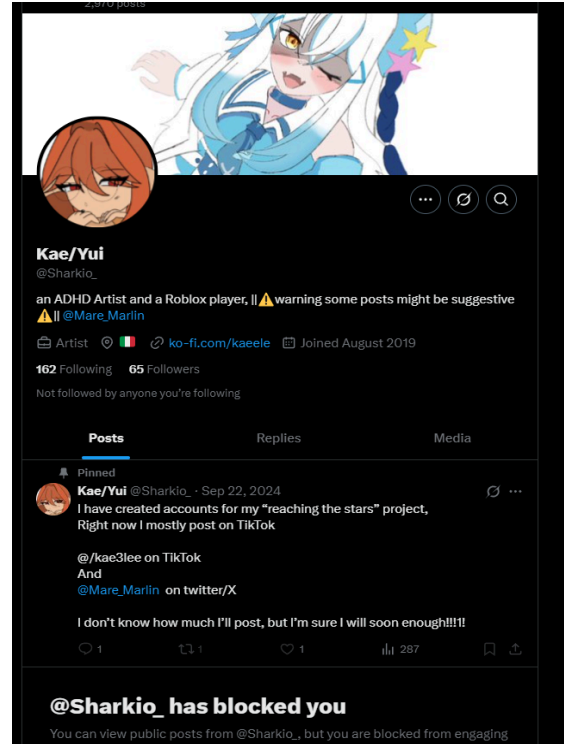

Kae follows loli accounts

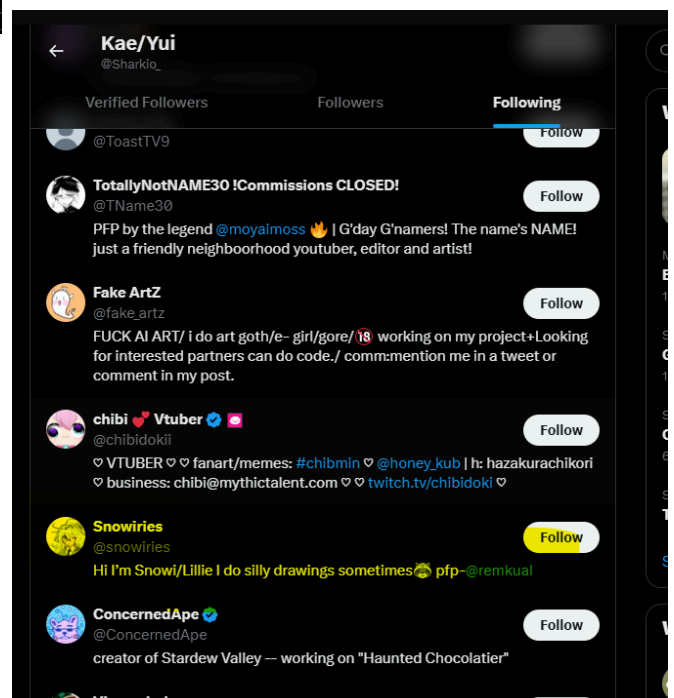
Kae follows 2 accounts that do loli. In this picture it's a young girl who's in a bunny suit. There a minor.

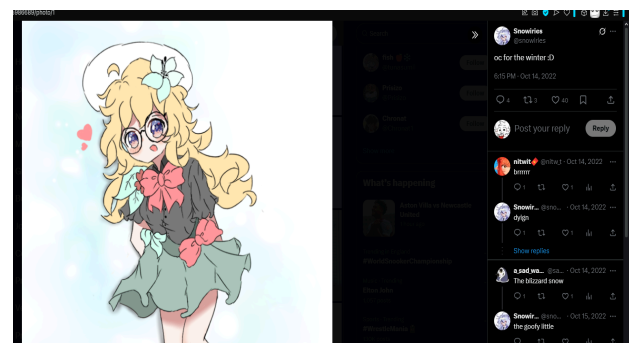
This is very clearly a kid/loli, the original image is a girl with just her underwear on and a womb mark. She is reaching under her shirt to her left breast.

Gwamgo cannot defend this anymore, Kae very clearly joins condos servers not for the stickers, but for the nsfw.

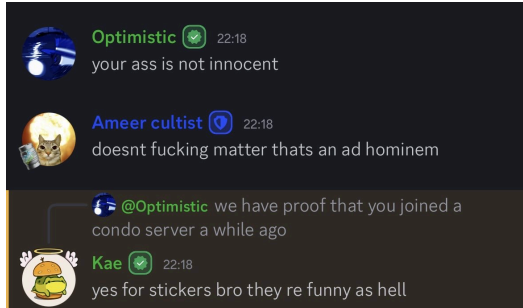

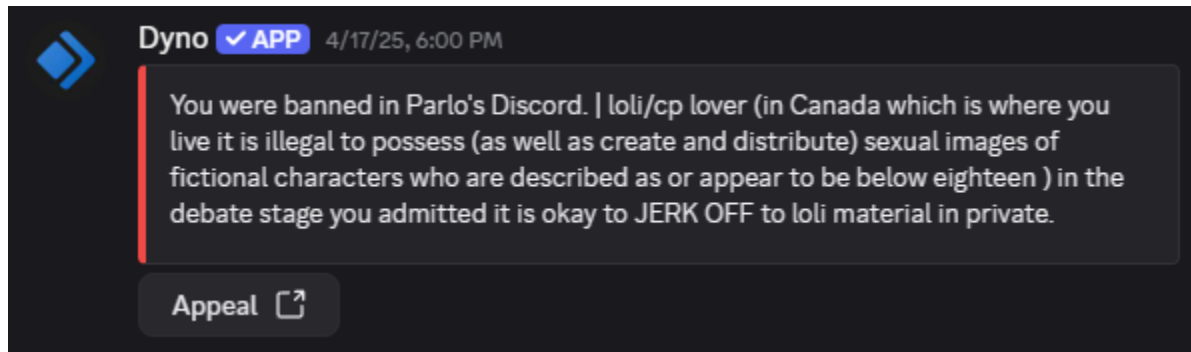
Kae openly stated she would go to the condo server to “get stickers”. Gwamgo allows her to stay on his server despite this. She never even called her out on it.



The double standards are quite clear.



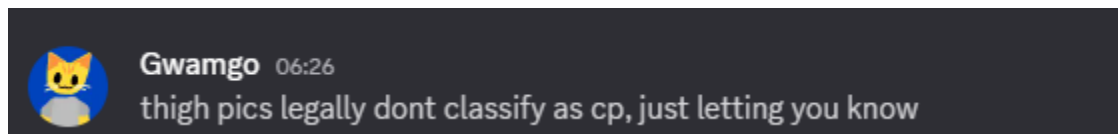
Note from Pete:

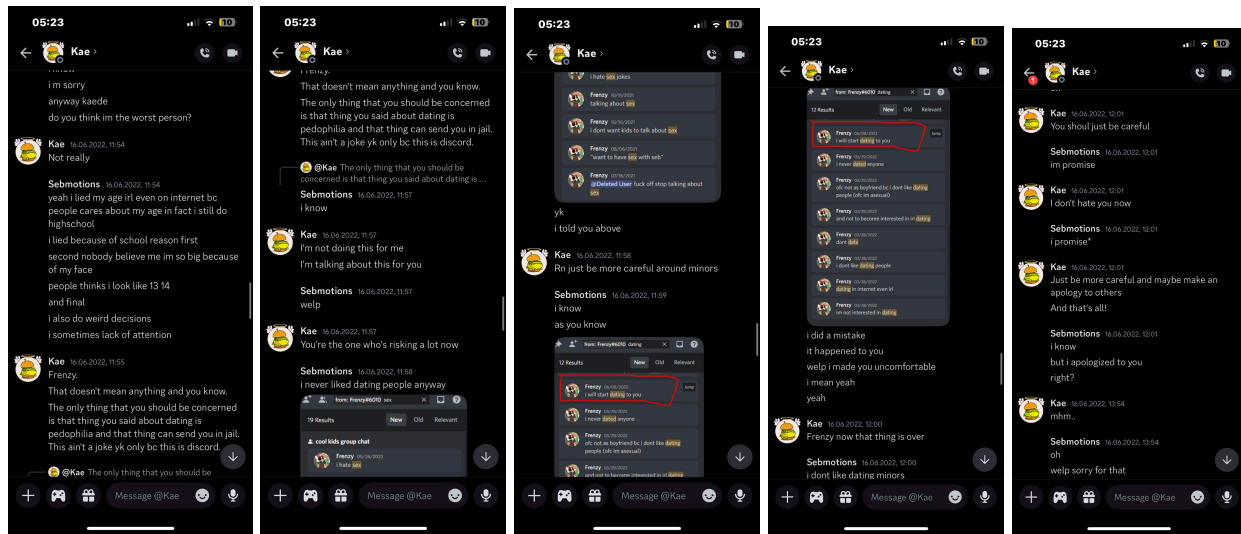
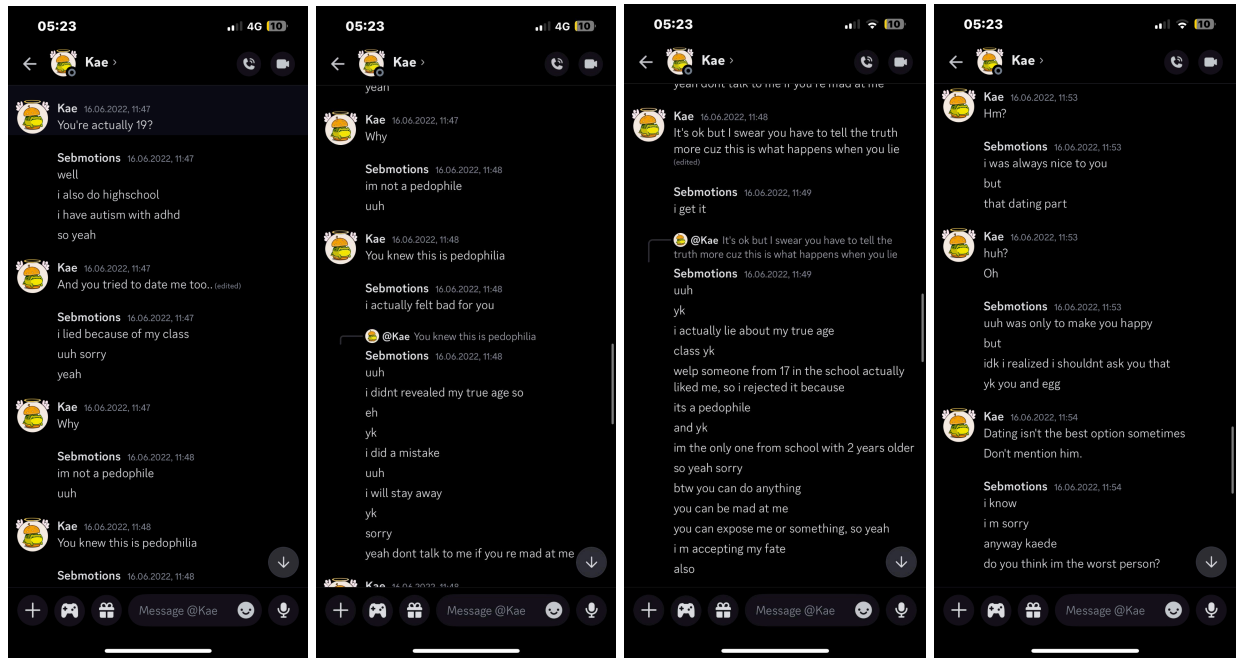


I also want to mention Gwamgo had a real life young girl's thighs saved on Discord and sent that to Parlo uncensored. I myself have never stored or owned this type of content.

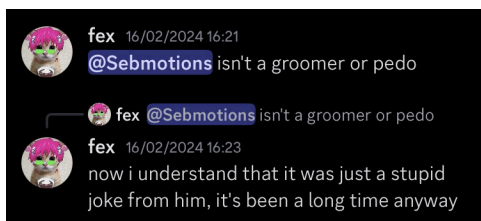
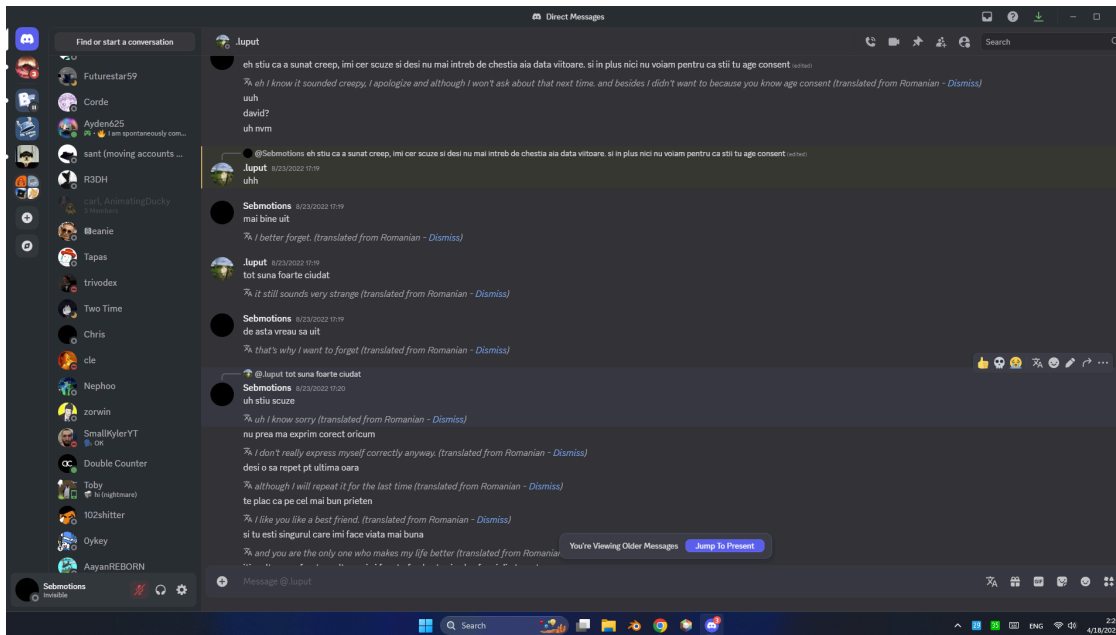
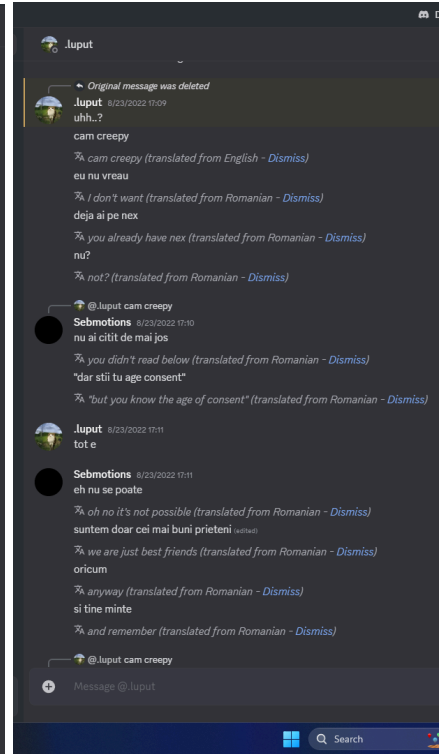
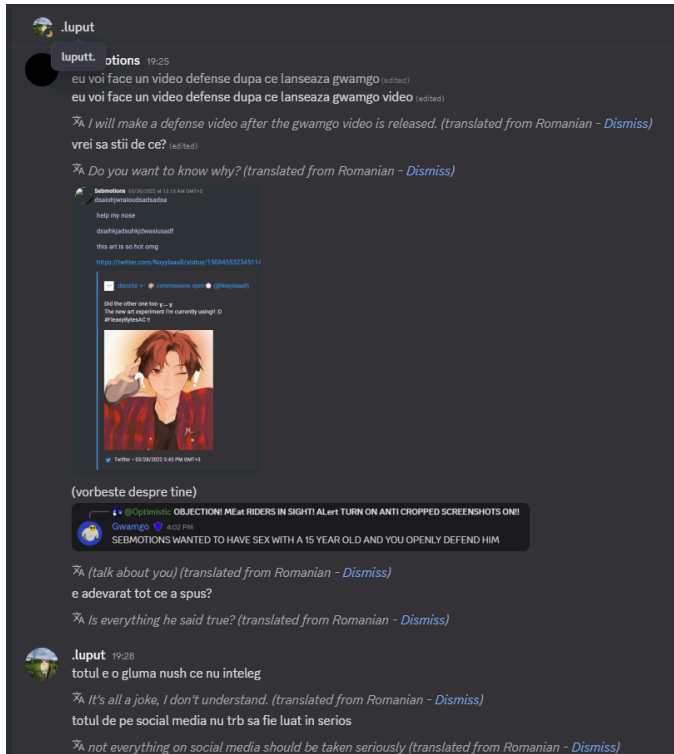
On top of Seb being asexual, there's an old discussion between Seb and Fleaxy proving that he had no intentions.

Didn't help that sir\_dead/eggdrolg/randy/punisheregg and his friends were trying all they could to have Seb falsely called a pedophile as revenge.

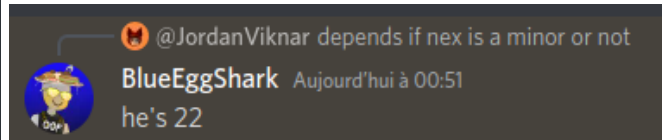
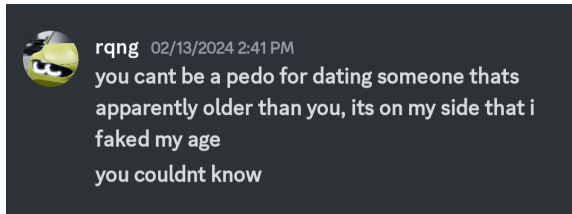

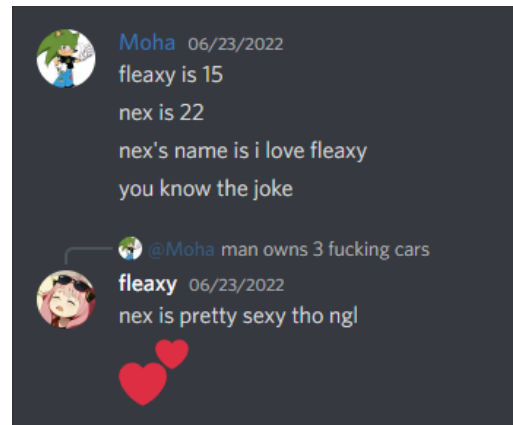
Seb was [aroace](#) back then and had doubts about being gay (wasn't attracted to women).

And much later, Nex switched their age to one that was under 18 (16 I think). Even if that had been an issue,

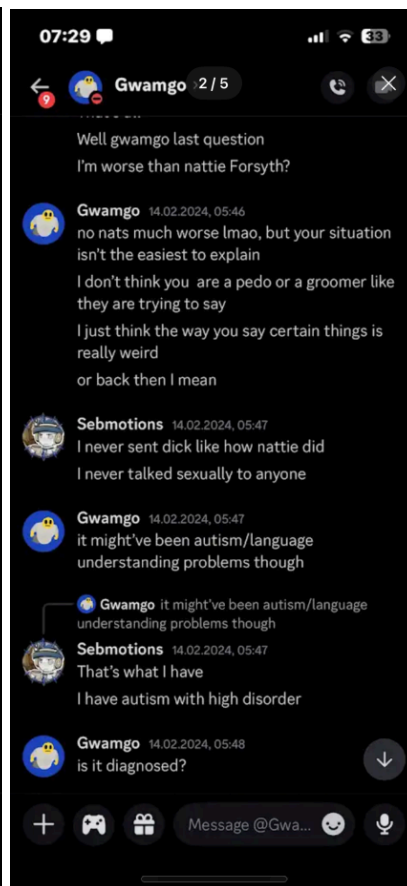
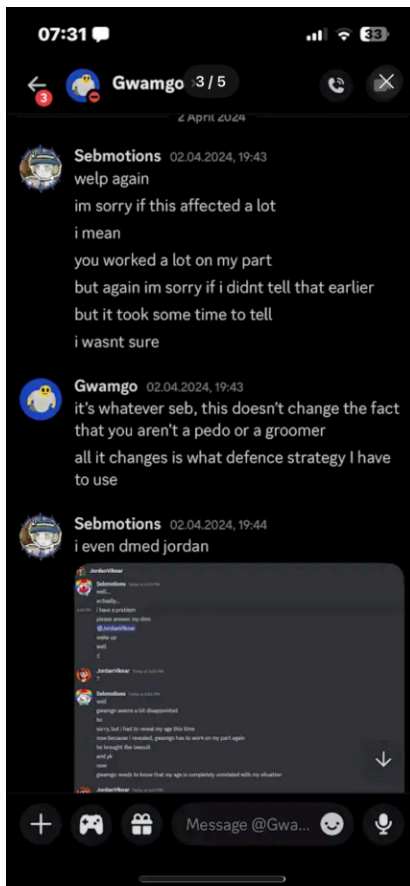
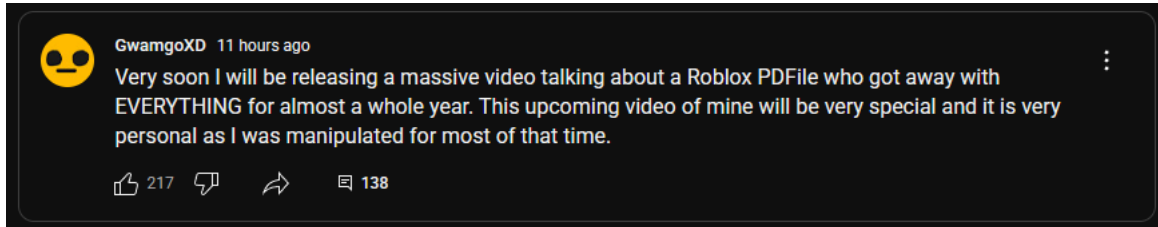

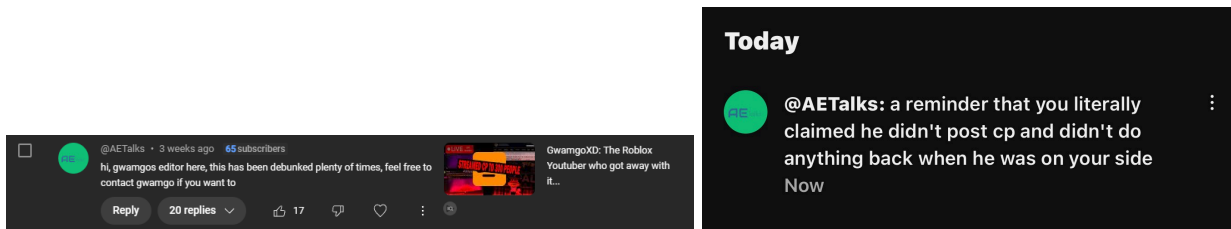
Gwamgo, you are a lying, manipulative person. Nothing can change the fact, considering you won't listen to anything but the sound of your own voice.
