Here is GPMI's re-finalized application for credentials for its 2020 GPUS nominating convention delegation, as of the date given below. This is updated from version 2, based on CredCom's demand for more documentation of our selection process since that version was submitted on June 23. GPMI held its state nominating convention June 20, and approved the delegation selected by our State Central Committee; follow-up work then identified delegates and alternates, and both those steps are reported on in more formal detail here.

A preliminary invitation was sent out to the members of GPMI on April 12 encouraging them to apply to serve in our delegation. A final invitation was sent May 1, as part of the notice for our June 20 state nominating convention – so consideration by our State Central Committee (SCC) ran from May 31 to June 19. SCC's voted selections were approved at the state convention – so we now have a full delegation to report to the Credentials Committee, including sub-lists of delegates and alternates and identification of our state reporter.

(Please note that Michigan does not have voter registration by party, so item 1h is not applicable.)

MCL 168.613a Statewide presidential primary election:
time; limitation on participation; conduct.

(1) A statewide presidential primary election shall be conducted under this act on the second Tuesday in March in each presidential election year. [NOTE: This is the only change in relevant statutes since 2012, when the primary was the fourth Tuesday in February.]

(2) A political party that received 5% or less of the total vote cast nationwide for the office of president in the last presidential election shall not participate in the presidential primary election.

(3) Except as otherwise provided in sections 614a to 616a, 624g, 759a, 759c, and 879a, the statewide presidential primary election shall be conducted under the provisions of this act that govern the conduct of general primary elections.

MCL 168.618 Allocation of delegates to national convention;
qualifications of delegates; selection procedures.

The allocation of all delegates and alternates to a national convention shall be made by the state central committee of each party. All delegates shall be registered electors of this state. Delegates elected from congressional districts shall be registered electors of those districts. All national convention delegates shall be chosen according to procedures and any other qualifications as may be established by the state central committee of that political party. The procedures and qualifications may include, but are not necessarily limited to guarantees that discrimination on the basis of race, creed, color, sex, age, national origin, or economic status does not occur.

MCL 168.620a Law applicable to selection of delegates;
state or national political party rule.

For purposes of this act, a state political party shall follow state law pertaining to the selection of delegates if required to follow state law by a state or national political party rule. If there is no such state or national political party rule, a requirement of this act pertaining to the selection of delegates applicable after the election of delegates to the county convention shall not apply to a political party if that requirement conflicts with a rule of that political party.

MCL 168.686 State convention; canvass of returns;
certification of nominees; presidential and vice-presidential candidates.

Within 24 hours after the conclusion of the state convention before a general election, the state central committee of each political party shall canvass the proceedings of the convention and determine the nominees of the convention. Not more than 1 business day after the state convention, the chairperson and secretary of the state central committee shall forward to the secretary of state, a typewritten or printed list of the names and residence, including the street address if known, of all candidates nominated at the state convention. In each presidential election year, the state central committee of each political party shall, not more than 1 business day after the state convention or the national convention of that party, whichever is later, forward to the secretary of state the typewritten or printed names of the candidates of that party for the offices of president of the United States and vice-president of the United States certified to by the chairperson and secretary of the committees. A party is not required to certify nominations made at an official primary election. The secretary of state shall forward a copy of a list received under this section to the board of election commissioners of each county, in care of the county clerk at the county seat.

GPMI has no formal, explicit, ongoing policy which fits these categories. However, GPMI has in fact put a Green Party ticket on the Michigan ballot every Presidential year since 2000, when it gained ballot access. In 2004, GPMI voted to make sure that a ticket could be put on the Michigan ballot even if GPUS did not nominate one – and empowered its delegation to vote to pick that ticket if needed.

Our delegate plan (submitted on the due date of March 11, 120 days before the PNC begins) empowered our State Central Committee (SCC) to select delegates (and alternates as available and approved) before the state convention June 20. As noted under (1) above, a preliminary invitation was sent out to all GPMI members on April 12, and a final invitation on May 1; we took applications for 30 days (until May 31) before beginning to review and consider applications June 1-12 and voting on them June 13-19. The convention ratified the SCC vote on June 20, and a working group followed up on June 21 to identify delegates and alternates, considering both the raw vote of the SCC and the need for diversity in representation of both GPMI members and citizens of Michigan.

We were able to fill all of GPMI's allocated delegate and alternate seats, and no vacancies exist as of this writing. Formal approved minutes of the convention will not be available until September, but partial minutes signed by convention secretary Daniel Martin-Mills and a report on the working group meeting by its chair Rita Jacobs document the selection; changes before the PNC will be reported.

John Anthony La Pietra, signer of this document, is both a GPMI state party officer (Elections Co-ordinator) and a practicing attorney admitted to the State Bar of Michigan. Committee Manager Rita Jacobs is likewise also a SBM-barred attorney. GPMI trusts that the signatures of one or both of these officers on this, as on all previous versions of the application, are adequate certification. As in previous years, we note that there has never been any controversy over who is authorized to represent GPMI at any previous GPUS Presidential nominating convention, and none is expected this year either.

As shown above, MCL 168.686 says the chair and secretary of GPMI's State Central Committee need to certify our Presidential ticket to the Secretary of State – effectively, the Bureau of Elections – the business day after either the national or state convention, whichever is later. (As of this date, that certification will be due to be filed by **Monday, July 13**, since the Bureau is now open for filings every business day – at least by appointment.)

Note that the statute does not require either the two candidates or any GPUS official to sign anything to put the ticket on the Michigan ballot. However, GPMI *does* need to get the residential street addresses (not PO boxes) of both candidates on the ticket – and their names as they want them to appear on the ballot – and we need that information no later than the end of the GPUS convention, so we can include it in the Certification of Nomination which must be signed by the party chair and secretary and turned in to the Bureau of Elections the Monday after the election.

(On another note, MCL 168.42 requires us to certify our list of Presidential electors to the Bureau of Elections the day after our state convention ends. But that has been done before the GPUS convention, and it too required no information or assistance from GPUS.)

Minutes from GPMI Nominating Convention regarding the Selection of Delegates for the PNC

Discussion regarding the selection of delegates: The Elections Coordinator explained that the SCC was required to select the delegates and alternates for the Presidential Nominating Committee (PNC), but did not reach quorum within the time allotted for voting. However, there were four ballots received on the final day of voting after the noon cut-off. If those votes are included, it would constitute a quorum of the SCC.

Lou Novak moved to have the convention attendees approve the inclusion of the four ballots received after the cutoff so the votes would constitute a quorum of the SCC, and be used to select the delegates to the PNC. His motion was supported by Robin Laurain, Rita Jacobs, and Tom Mair. The motion passed by consensus. Rita Jacobs, Committee Manager, requested volunteers to meet with her the following day to make the final selection of the delegates and alternates based on the voting results from the SCC. Jim Becklund and Frank Foster, Jr. volunteered. The voting results of the SCC were uploaded to the ZOOM chat. A discussion was held about the reporter for the delegation. John Anthony La Pietra received the most votes, and said he did not want to serve as a reporter, and suggested that a woman should do that. The woman on the list of delegates who had the most votes was Amy Slepr, but she had left the meeting. No further action on it was taken during the convention.

Report of the Final Delegate Selection Working Group for GPMI

During the State Nominating Convention, convention delegates were invited to take part in a special meeting the following day to make a final selection of delegates and alternates to the PNC based on the votes of the members of the State Central Committee.

The meeting was held at 4:00 p.m. on June 21, 2020 via the Green Party of Michigan ZOOM account. Present at the meeting were: Rita Jacobs, Committee Manager of GPM: Jim Becklund, Chair of the GPMI State Nominating Convention of June 20, 2020; and Frank Foster, Jr. a delegate to the GPMI State Nominating Convention from Genesee County.

We reviewed the applications submitted by Green Party members for delegate and alternate delegate positions. We agreed to select the delegates according to the voting that was done by the GPMI State Central Committee. The basic order of SCC voting results was preserved, with the top 15 vote-getters selected as delegates and the next 15 as alternates. We broke ties at the dividing lines in favor of improving the gender balance of the delegation. Our selections agree with the final delegate list on the GPMI application for delegate credentialing.

I certify that the delegate selection was done in accordance with the GPMI convention rules and plan for selection of delegates, and the delegate selection in the application for credentialing is a correct list of the selected delegates and alternates.
