



### **Statement of Facts**

#### **[In support of Felony Complaint and Arrest Warrant]**


On August 7, 2025, the Licking County Sheriff's Office received a CyberTip through the Internet Crimes Against Children (CyberTip 211597954). The CyberTip Report was generated through the Electronic Service Provider (ESP) MediaLab/Kik on May 7, 2025, and reported that 4 files of child sexual abuse materials (CSAM, commonly referred to as "child pornography") had been uploaded on April 28, 2025. The Cybertip reported the Kik account screen name and display name associated with the upload was "se3xfynd"; with a verified email address of solowolf42@outlook.com. The cybertip report Detective Bowman received included records from Microsoft, showing the subscriber information had a listed name: Baphomet Mourningstar, as well as listed State of Ohio and postal code of 43080 (Utica, Ohio). Additionally, a date of birth was listed as 6/3/2002, and a phone number, and billing address 11095 Stout Road NE, Utica, Licking County, Ohio 43080. The documents relating to billing identified Rose Kohsman, Gabe Kohsman, and Timothy Ross as all associated with payments. Kik records provided in the Cybertip also showed the account was registered on April 28, 2025, at 3:16 A.M. with a Motorola device utilizing an Android operating system. Detective Bowman reviewed the Cybertip files and observed they contained prepubescent females in states of nudity and engaged in sexual acts.

On December 5, 2025, Detectives Bowman and Lee conducted a knock and talk at the Stout Road address and were greeted by the Defendant, Gabriel Kohsman. The Defendant confirmed his phone number and email address, both of which matched the records, agreed he has lived at this address for 4-5 years, and reported his date of birth is 3/6/2002. The Defendant acknowledged he has used Kik, however he no longer does, and first claimed it had been years since he last used the application. The Detectives informed the Defendant the Kik account with his email had been involved in the upload of CSAM, and the Defendant admitted he had participated in the viewing

and trading of CSAM. While speaking to the Defendant, he agreed to allow the Detectives to view his cellular device - a Motorola Stylus 5G with a red case. The Detective located multiple applications commonly associated with CSAM collection and trading. When asked about whether there would be CSAM on the device, the Defendant admitted there would be "maybe 1 or 2" and stated they would likely be within his Telegram or Discord applications.

A conviction of violation of Ohio Revised Code sections 2907.322, and 2907.323(A)(1) will result in the Defendant being classified as a Tier II Sexual Offender. A violation of Ohio Revised Code section 2907.323(A)(3) will result in the Defendant being classified as a Tier I Sexual Offender. Any Felony of the second degree conviction has occurred after March 22, 2019, thus the Defendant is subject to an indefinite prison term of one half of any prison sentence imposed.

This is the only charge that the Licking County Prosecutor is requesting the defendant be held on related to the incident number 25-32921
