2. I declare: I first met Megan Rutter in the summer of 2022 at Mall of America with Steven Eisner. We were in Minneapolis for a video gaming convention. I had already heard things about Megan Rutter from other people that were negative however I went into meeting her with an open mind because Steven Eisner is one of my best friends and I wanted to support the relationship he had. Upon meeting Megan, they were very nice and kind to me and we all ended up having a good first day. However the problems others had mentioned to me began after that. That night we did mini-golf at the Mall of America, and as we were playing, Steven let me know that Megan thought I was playing too aggressive. I toned it down for Megan but then they got upset that I was hitting it too softly as if to mock them, which was not the case. We also ended up doing an Escape

Room later in the week with about eight people and as we were playing Steven had come up to me to tell me things Megan had accused me of. Megan said I was being loud and aggressive during the Escape Room when all I am doing is contributing to the game. This had ruined the day as I felt I could no longer play with my friends. I noticed during my time in Minneapolis with him, they were very clingy with him and would seem to be upset anytime I was hanging out with Steven. Steven was nothing but understanding and was always considerate towards Megan. I ended up learning that Megan had already chosen to not like me before meeting me. A person I had never interacted with before then already chose to not like me. Megan is the type of person who blames anyone for random stuff and has a victim complex. They do not take any accountability and these were the negative qualities I was warned of before meeting them. If I had not experienced them myself, Megan would have had the benefit of doubt in my mind. I do not believe Megan Rutter to be a mentally stable person or trustworthy. They are a very manipulative person. I have known Steven Eisner since 2015 and first met him in the summer of 2016 in Minneapolis at the same gaming convention. He was nice to me online before then but even greater man in person. There were times we would get in disagreements but they were always resolved without any issues or getting upset with one another. For as long as I have known Steven, I can say with certainty that Steven is not an abusive person and that any abuse began with Megan Rutter and manipulated by them.

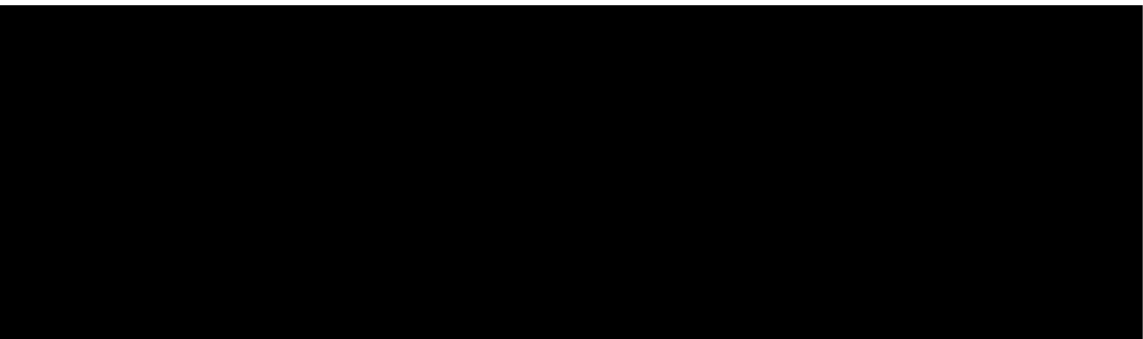

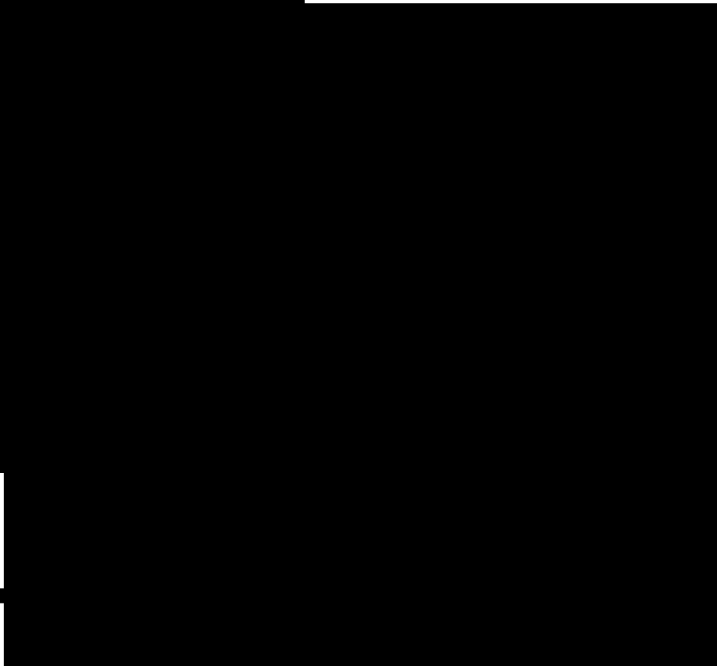
