1. I am (age) [REDACTED] years old and I am the (check one): Petitioner, Respondent, Other

2. I declare:

That I have known Steven Eisner since 2020. In the last year or two, Steven and I have become very close, talking on the phone multiple times per week, texting, and sharing what is happening in our lives like best friends do. Over the years that I have known Steven, he has been in two serious relationships (Bridget Gabriel and Megan Rutter).

Not only have Steven and I had conversations regarding how both of our relationships were going, but I have also been able to spend some time with Steven and his partners in person at various gaming events (SGDQ, AGDQ). This usually included things like having meals together, mini golf, escape rooms, mirror mazes, etc. For one event, my husband and I shared a room with Steven and his partner at the time, Bridget. There were no issues during the time we shared a room. In fact, I remember hearing a lot of giggling coming from their side of the room.

Over the last few months, and specifically since Megan's achilles injury, Steven and I have spent more time on the phone, mainly because he was in the car more - running errands, picking up food for both of them, etc. I can remember two instances specifically in which Steven was ordering McDonalds for both he and Megan, especially as one involved a very funny McFlurry situation. I also recall him taking many trips to Walmart to obtain items like Megan's prescriptions, feminine hygiene products, and a new wireless keyboard that Megan needed. Upon returning home, Steven presented Megan with all of the items which included a McFlurry

from McDonalds, and the wireless keyboard. It sounded like Megan thought perhaps Steven had spent too much money on the keyboard (~\$17), and Steven very calmly explained that it was the cheapest one they had. I was not able to hear Megan's exact words. After that, I specifically remember him saying to Megan that he was going to go downstairs to relax (that is where his 'office' was located), but before doing so, he asked her if she needed a refill of water or anything else that he could get for her. There was another trip where Steven went to the pet store to obtain some mice, as that is what Monroe the snake needed every two weeks. Steven seemed stressed due to carrying the weight of the household, but based on each interaction I heard via the phone, it appeared as though Steven was gracefully assisting Megan in her recovery.
