## Details:

On 11-4-2022 around 1321 hours, RPD Dispatch received a call on non-emergency from the phone number 775-475-3290. The caller identified themselves as Sean Daldry, claimed they were staying at SureStay Plus located at 1981 Terminal Way Reno, NV, unknown room number, and made threats to set off a bomb. The caller stated their motive for setting off the bomb was to disrupt Antifa and the Republican Party. The caller stated they would set off the bomb in a couple of hours.

It should be noted that SureStay Plus is directly across the street from Reno-Tahoe International Airport located at 2001 E Plumb Lane Reno, NV.

The caller also stated they killed a female who was inside the hotel room.

The first officers initially dispatched to the CFS were RPD Officer Duralde, RPD Officer Sanford, and myself, RPD Officer Bohr. RPD Sgt Dunn was notified of the CFS.

Several phone calls were attempted by myself and Sgt Dunn to 775-475-3290 during the initial response but no one ever answered.

RPD Officers Sanford and Duralde arrived on scene roughly the same time (approximately 1341 hours) and I arrived on scene a few minutes later, 1345 hours.

When I arrived on scene, Officers Sanford and Duralde were inside the hotel lobby at registration attempting to gather information.

We learned Sean Daldry was registered to room 235. He checked in on 11-2-2022 and was scheduled to check out on 11-7-2022. The room was booked through a business called Corp Lodging, possibly "CLC Lodging". We did not have any further information from registration related to Sean.

Due to the nature of threats, officers began making plans to evacuate rooms.

- I used my work issued cell phone and texted 775-475-3290 at 1357 hours. I said, "Hey is this Sean? I need to

talk to you ASAP".

- At 1358 hours, I received three responding texts from 775-745-3290 stating, "LISTEN HERE I AM GOING TO KILLS JEWSG - GET AWAY FROM HERE - I AM A NAZI".

- At 1359 hours, I texted, "Are you able to call me please? I am concerned about you".

- At 1400 hours, I received three texts stating, "NO - GET AWAY FROM ME I HAVE CHILD PORN ON MY PC I AM NOT GOING TO GET ARRESTED - I WILL SEND CHILD PORN IN THIS TEXT IF YOU DONT STOP".

Also around 1400 hours, Officer Sanford requested a CINT response and more officers to assist in evacuations.

- At 1401 hours, I texted "I heard you have a bomb, is this true?"

- At 1402 hours, I received a text stating, "YES".

- At 1402 hours, I texted, "Did you kill someone or hurt someone? If so, who? I want to help you."

- At 1403 hours, I received a text stating, "I DONT KNOW I AM SEEING PEOPLE ALL I KNOW IS THAT I AM ARMED".

- At 1404 hours, I texted, "Are you willing to let me help you?"

- At 1404 hours, I received a text stating, "ONLY GOD CAN HELP YOU".

- At 1405 hours, I texted, "Have you been drinking?"

- At 1405 hours, I received a text stating, "YES".

- At 1405 hours, I texted, "Can I get you an ambulance?"

- At 1406 hours, I texted, "I'd like you to talk to a doctor. Please let me help you."

- At 1409 hours, I texted, "Let's talk. I want to know what's going on with you."

- At 1411 hours, I texted, "Sean, please talk to me. I am concerned for you. I am someone who will listen to you."

- At 1411 hours, I received four texts stating, "I WILL GO AFTER THE AIRPORT - THE AIRPORT - MY TARGET - BOOM BOOM".

- At 1412 hours, I received a text stating, "MAYBE I HAVE EXPLOSIVES THERE".

- At 1412 hours, I texted, "Why do you want to hurt people?"

- At 1412 hours, I received five texts stating, "ACTUALLY YOU KNOW WHAT I DO - HAHAAAA - BOOM BOOM AT THE AIRPORT - NEARBY - BOOM BOOM".

- At 1413 hours, I received two texts stating, "THIS WILL WIN THE ELECTION - I AM ANTIFAA".

- At 1412 hours, I received a text stating, "FIND THEM OR SHOOT ME OR I WILL SHOOT MYSELF HAAAA".

At 1413 hours, I updated dispatch the subject was making threats about a bomb at the airport and to notify airport police.

- At 1414 hours, I texted, "Why do you want to hurt people? I don't think you're a bad person. Something must really be bothering you."

- At 1414 hours, I received a text stating, "LOOK HERE, I AM A PEDOPHILE I GROOM UNDERAGE GIRLS ON MESSAGING APPS. MY FRIEND FOUND OUT AND HE THREATENED TO REPORT ME TO THE POLICE, I ALSO WANT TO INFLUENCE THE ELECTIONS. I HAVE NOTHING TO LOSE".

- At 1416 hours, I texted, "That sounds really stressful. I can't even imagine. I can imagine you feel hopeless."

- At 1417 hours, I received a text stating, "I AM SICK AND TIRED OF PRETENDING TO BE A MINOR

ATTRACTED PERSON I AM A PEDOPHILE OKAY SOCIETY DISCRIMINATES AGAINST US, THIS IS MY SEXUALITY THE LGBTQ+ COMMUNITY DOESN'T ACCEPT US NO ONE DOES".

- At 1419 hours, I texted, "What are you trying to accomplish today?"
- At 1421 hours, I texted, "Have you thought any of this through?"
- At 1423 hours, I texted, "What are you "armed" with Sean?"
- At 1425 hours, I texted, "Please talk to me. What are you trying to accomplish? What are you armed with? I am worried."
- At 1427 hours, I texted, "It must be hard to feel unaccepted or misunderstood :("
- At 1430 hours, I texted, "Please talk to me. I want to listen to you."
- At 1432 hours, I texted, "There are a lot of people who are scared. Since you are not replying, I am hearing talk of your wifI being shut off and I don't want to lose our communication. I know you're hurting, please talk."
- At 1436 hours, I texted, "What are you doing?"
- At 1438 hours, I received two text messages including a hyperlink, "I am here <https://files.catbox.moe/atdie5.mp4>  
- check the video"

I clicked the link and it was a 5 second video. It looked like the recording was taken from a cell phone. The first second showed a white male adult with a hat and glasses (later identified as Sean), possibly from the front facing camera of a cell phone. The camera switched from a front facing camera to the exterior camera which showed several RPD police vehicles parked out front the SureStay Plus. The video had a circular frame around the screen.

- At 1439 hours, I received three texts including another hyperlink, "here's me again <https://files.catbox.moe/xb2i0f.mp4> - YOU WILL NOT CATCH ME - HAHAHA

I clicked the link for the second video. It was a three second video with the same circular frame. It showed a white male adult, mid 30's, dark hair, facial hair (later identified as Sean), and he said, "I'm done. Sorry that took forever".

At 1439 hours, I notified dispatch that the subject sent me a video of him watching us from outside the hotel.

At 1440 hours, Officers noticed a subject south of the hotel near the parking lot who matched the description of the subject from the video.

- At 1441 hours, I received three texts stating, " THE FIRST VIDEO IS FROM A FEW MINUTES AGO - THE SECOND IS FROM TODAY - HAHAAHAHAHAH".

At 1441 hours, RPD Officers detained that subject, later identified as Sean Daldry. The location officers detained Sean was consistent with the location where the first video sent/texted to me.

- At 1442 hours, I received a text stating, "FUCK YOU".
- At 1445 hours, I texted, "Why are you doing this?"
- At 1445 hours, I received three texts stating, "YOU KNOW WHAT I LOOK LIKE NOW I AM AT THE SCENE - CATCH ME - HAHAAHAHAHA".

These messages were sent to me after Sean was detained by officers. We began trying to determine if multiple people were involved instead of just Sean.

Officers were able to identify an associated vehicle to Sean, a white 2022 Ford van bearing plates 462ZIX/AR. Subject Julio Cabias was inside the van and officers detained him. Officers learned he was staying in room 231. Officers later learned Julio was not involved and he was released from his detention.

Bomb Squad and SWAT responded.

RPD Officer Wassdorp worked on obtaining video surveillance of Sean, backtracking from the time he was detained by officers.

Officer Sanford worked on obtaining a search warrant related to our investigation which he consulted with Michael Bulenbaker (ADA) and was later granted by the honorable Judge Scott Pearson at 1657 hours. The warrant was granted based upon probable cause to believe Sean Daldry committed the following crimes: murder, bomb threats, possession of explosive device, and possession of child pornography. The search warrant was granted for room 235 of the SureStay Plus and the white 2022 Ford Van (462ZIX/AR) and limited to the body of an unidentified female, bomb making materials, tools, wires, evidence of child pornography to include paper material and electronics. The search warrant ended up not being served due to the facts and circumstances changing and leading officers to believe Sean was the victim of a swatting incident which will be detailed later in the report. The warrant was submitted with case paperwork.

My contact with Sean:

I advised Sean of his Miranda Rights which he acknowledged and agreed to talk with me. I spoke with Sean near the grass area where he was detained. I offered multiple times to speak with him at the main station but he did not want to go to the station and he wanted to speak there.

Sean denied murdering anyone, making bomb threats, having child pornography, etc. Sean gave me verbal consent to look through his phone. I asked Sean about the text messages and the videos sent to me from the location we detained him. Sean stated his phone number was 205-600-1970. I called his phone to verify that was the correct number and it was. I had a suspicion 775-475-3290 was possibly a burner phone number or a number generated from a messaging app.

Sean said he used the app "Telegram" to message a girl from Albania. Sean said he was in a long distance online relationship with her. He had never actually met her in person. Sean said the only person he sent those videos (link 1 & 2 sent to me from 775-475-3290) to was that female through the Telegram app. Sean showed me how the Telegram app worked and how videos were sent. I was able to confirm he only sent both videos to her via Telegram app. He told me how to save a video on Telegram, stating you had to hold down the video, some options would pop up, and one of the options would be saving the video as a file on the phone. This would be consistent with how the video files were sent to me. I was also able to confirm Sean sent his location to the female. Sean told me it's not uncommon for him to share his location with her, especially while he was out of town working. Sean did not share his room number with her. This would be consistent with the CFS not having a room number to check. I showed Sean some of the text messages between me and whoever I was talking to on the 775-475-3290 phone number. Sean did not believe that was the female from Albania and thought she might possibly be providing someone else his information and they were doing the swatting on her behalf. When I was reading the text thread between the two, it looked like they were in an argument for the prior few hours and Sean was saying very vulgar and demeaning things to her, which revenge could be a possible motive for the swatting.

While I was doing my investigation with Sean, RPD Officer Leonard learned Milwaukee Police were investigating a swatting call at the same time. Someone claiming to be named "Patrick" using the same phone number 775-475-3290, said they shot their black boyfriend. Their investigation turned out to be unfounded.

Ultimately EOD was able to clear the area of any explosives, SWAT was able to clear the room, and this incident appeared to be swatting. The suspect of the swatting is currently unknown.

Sean's phone was returned to him. Guests were able to return inside the hotel and roads were reopened.

I took screenshots of my text message conversation and uploaded them into Axon Capture (15 photos).

At the time of the investigation, I did not ask much identifying information about the female from Albania so around 2230 hours that evening, I called Sean on the phone to follow up with him. He said that he had not talked to her and there was no new information to report. I asked him what her name was and he told me Eni Dukha. He stated she was in her early 20's but did not know her date of birth. He said he was not at his hotel room so he didn't have information nearby but I asked him once he got back to his room, if he could email me any additional

## Narrative

On 11/04/22 I responded to 1981 Terminal Way for an anonymous tip which consisted of a bomb threat.

Upon arrival I met with Sgt. Dunn who asked me to begin reviewing video surveillance in the attempt to locate the subject's vehicle. I then located the hotel manager (Teresa Kees) who took me to her office where I reviewed the footage. While reviewing footage I recognized the subject due to him possibly being sitting in front of the hotel near the southeast corner of the driveway, where he was detained. The subject was thought to be messaging Officer Bohr about the threats and had just sent him a video of officers setting up the perimeter on the building. Officer Bohr asked me to review footage again to confirm that the male we had detained was in the area from which the video was filmed. The video depicted the subject walking to the corner of the parking lot at approximately 14:30 hours where he was seen holding something in his hands facing Officers. The then walked west towards the edge of the grass where he sits on a rock and began to play on his phone which was at approximately 14:37. After Officer Bohr received the video and the subject was identified through video surveillance checking in, and still wearing the same clothing he was detained. A citizen's link was sent to Teresa and the video was uploaded into AXON capture.

## Narrative

On 11/04/22 at approximately 1400 hours, Officers were dispatched to 1981 Terminal Way for a report of a possible bomb threat. The call stated that DALDRY, SEAN had killed his spouse, the body was in his room of 235 and he was going to set off a bomb.

Officers then went and spoke to the front desk and confirmed that a DALDRY, SEAN was registered to room 235. But, they did not have any information in his booking that would give a vehicle description or plate.

Officer Broadway searched through social media sites and found a potential subject match with the same name and from the same general area that the subject was from. He then contacted the local agency to see if they had any recent contact with him and could provide his information.

Due to the lack of information regarding the subject, Officer Bohr asked me to gather intel. I was able to get the name of the company that booked his room for his employer, Wachter Enterprises. After calling the general number for the company I was eventually sent to Human Resources and was able to be connected to an employee (EWELL, DENBY) who was able to provide me with some information.

SEAN and his coworker CUBIAS, JULIO were assigned to work a job in Reno. They were assigned separate hotel rooms and assigned the same vehicle. The vehicle was a 2020 White Ford Transit 350 Van (462ZIX/Arkansas). According to DENBY, he had contacted fleet management and was able to confirm the GPS coordinates of the

van, showed it to be at the hotel.

DENBY was also able to provide me with a photograph of SEAN through his work identification card and his personal identifying information.

While I was gathering the information, the subject was still sending text messages to Officer Bohr. The messages were stating that this incident was the end for him and he had child pornography on his computer.

The Crisis Center that had created our call for service, informed officers on scene that there was a similar call for service in another state, in the general location of where the other DALDRY, SEAN was located on social media.

According to Officer Bohr, there was a link to a video that showed our subject to be behind officers that were already on scene. Police vehicles could be seen in the background.

Officer Bohr then had SEAN in handcuffs.

I was then assigned with Officer Broadway to clear the remaining half of the third floor that had not been evacuated.

When I returned, Officer Sanford was in the process of applying for a warrant, because SEAN did not give us consent to search.

EOD then used a bomb dog to sniff the van and alerted to it. EOD cleared the van and Officer Sanford continued to apply for the warrant for the car and the room.

The warrant was granted. EOD then went and cleared the hotel room. As that was happening, other officers learned that the other SWATTING call occurred through the same crisis call center, using the same number and started while our subject was in custody.

SEAN was then released by other officers on scene.

Due to SEAN being released for the Bomb Threats, it was concluded that he was likely a victim of a SWATTING call. So Officer Sanford, Officer Broadway and I did not execute the warrant.
