

Response to Accusations

I will be addressing multiple claims made throughout both docs and reposts by perpetrators of the Myagenesis' (Mya's) pedophilia accusation against me. Despite making many public responses on Twitter (never known as X) with both admission of guilt and the counter document, they have long been ignored.

Additionally, I would like to note that the title of the accusation document is a direct ripoff from the document titled "DeadDang is a mess." which was released an hour prior to Mya's. To me, this suggests Mya was waiting for the opportune time to use the discourse of an actual real life predator in order to boost viewership of her accusation against me.

How we met

In september of 2017, there was an experience called roblox called "Roblox Odyssey" which was developed by the user Phenite (later known as Elidile/drazil) at the time, and I would later join its community server in hopes of seeing how development went from that point, in this server was Myagenesis. At the time, Mya was seemingly regularly getting in trouble for breaking the rules, though eventually she would add me after she was banned from the server, and our friendship developed from that point forward.

This came before my termination as DunclubDuncan as a direct result of Protest Simulator's deletion, and then later making a new account to become DuncanDunclub, my current account. As trust developed between Mya and I, and as she got more involved in Slam Dunc Studios, I was still creating RR34 content on the side as my NSFW twitter alt called "big_wiggles", albeit not as much as before.

What happened between us

Seeing similarities in build quality between my main account and NSFW alt, Mya came to a personal conclusion that I was BW, which at the time, I had denied. Instead I tried to convince her (and others who had the same assumption) that "big_wiggles" was simply someone I affiliated with rather than being my alt. Regardless, Mya took the opportunity to showcase her RR34 creations to my main account. Seeing that she made such content, it was a foolish assumption on my part that her making adult content meant that she was an adult herself. Mya also chose to join the big_wiggles discord server I had made on the alt, which had rules against underage users joining it. This only further cemented to me that she was an adult.

It was a while of back and forth RR34 sharing before I caved and admitted to being big_wiggles, which she still assumed before my admission. From that point, we developed a personal bond which eventually escalated into erotic roleplaying. The both of us willfully engaged in the behavior, even making private RR34 content based off what we did. I even helped her with directly confronting the user GiantMilkDud utilizing evidence Mya had collected against her, which would eventually lead to a partial GMD Corp Ban to the DB games.

It later occurred that while this was happening, Mya was trying to engage in similar manners with other members of Slam Dunc Studios, including some of my personal friends at the time, being rejected and eventually booted from a personal friend server due to how excessive it got. She gradually became more toxic and had friction with the Slam Dunc Studios discord server members until, effectively, I was the only one who could tolerate her. She even went as far as to poke fun at two of my friends being used by a predator known as "brickmin". Shortly after this, I had begun to dissociate from RR34 and ceased erotic roleplaying with Mya, as I didn't find joy in doing either.

On the 8th of August, I made an open (and admittedly cringy) announcement in the Slam Dunc discord declaring that Mya is to be permanently banned since all users had gotten sick of her, and finally myself as well, given her excess toxicity and disregard for other victims of pedophilia. Mya had admitted to being a minor after I had banned her from Slam Dunc Studios, in which I angrily called her “Irredeemable” before blocking her.

In response, she started to use our past relationship to frame me as a pedophile, attempting to convince others that I “knew her age” the entire time, with no evidence to back this up. Lacking the trust of many members in Slam Dunc and associated communities such as Databrawl, her first accusation was met with little attention. Then she released a second document soon after another was making the rounds.

I did not have any prior knowledge of Myagenesis being a minor during our relationship.

The Document Released

On July 8th, 2019, the Roblox Twitter Community, alongside the Roblox Developer’s Conference, were shaken up by the reveal of a confirmed sex offender who went by the Roblox username of “DeadDang”, or as some knew as “Theover”. The reveal document was a collaborative effort between me, some members of /reg/, past exes of Theo, and his irl victim. Theo declared to /reg/ right before the doc came to public light “I’ll see you all in hell” before removing himself from the server.

The user OnyxOnline then posted the [expose document on Theo titled “DeadDang is a mess.”](#) The Roblox community at large saw this and were rightfully horrified, leaving many people in a state of shock, including /reg/ itself.

Approximately an hour later, Myagenesis made a reply under the tweet featuring the document, encouraging people to read [her own document of a similar title: “DuncanDunclub Is a Mess.”](#) This was a deliberate move to try and ride the wave of attention in order to boost her claims against me, and at the time, I was too in a state of misery and disgust to form my own argumentation against her claims. All I could do is try to explain everything to the best of my ability to /reg/, which she utilized after obtaining screenshots from someone in the server in small updates to her doc, attempting to use them as a means of “proof” of pedophilia.

The members of /reg/ were already in a state of shock when someone who they knew for a long time was outed as a predator, and seeing this second one targeted at me made them understandably unforgiving in their decision to kick me out after my desperate ramblings. Almost no one was willing to listen to me aside from a select few, and even then, they looked down on my actions.

Aftermath

I spent the next week apologizing and admitting what had happened between me and Mya to friends and whoever still allowed me in their servers, but in large part, I was greatly isolated from people and communities I once knew. 11 days after the members of /reg/ calmed down, they eventually reinstated me as a member, understanding on their own that what Mya had put out for the world to see was a farce. I was still scrutinized for being a “horny dumbass” but that’s a given.

Some time later I was contacted by another RR34 creator who went by Athena at the time. They were wanting to interview both me and Myagenesis, as the RR34 community was having an internal debacle having to deal with the “More Body Types” model I made in November of 2019. I agreed to the interview, which would later become the [Counter Document against Mya's claims](#).

I would later repost this counter doc where it best be applied; personal inquiries, public twitter posts, etc. For a time I thought this would finally put an end to false accusations made against me. At least that’s what I thought, until a YouTube content creator known as PrisonMateLuke decided to revive Mya’s document in video format, adding nothing to what the document claimed, and refusing to respond to my twitter DMs. Interestingly, Mya had joined PML’s community server to not only thank PML, but try to convince members that he in fact contacted me.

SudoMesh and xtriel later joined PML’s discord server as a direct confrontation to PML regurgitating Mya’s claims, and some of its moderators were in agreement of it being a farce until PML himself decided to respond in the chat. When asked why he never responded to me, he simply said “I don’t talk to pedophiles.” This shows that PML was not willing to listen, as his video was already published and racking in views.

There were additional instances of other people trying to revive attention for Mya’s accusation who were not even aware a counter document existed, or simply refused to accept evidence against the claims. That includes [one that was made as of writing this](#) (May 21st, 2024) which once again refuses the prospect of any evidence presented in the accusation doc being false.

This has been an ongoing cycle for nearly 5 years by now, despite numerous attempts to let the public know my side of the story. I have repeatedly been ignored on each occasion.

GMD Affiliation

Mya had a very deep hatred for the user known as GiantMilkDud for a long time, and it was something that she regularly spoke about even before we knew each other. I was willing to help Mya get at GMD, and even went as far as to ban the group “GMD Corporation” from playing Slam Dunc Studios’ experiences on June 27th, 2018. This ban was partially lifted to only affect its staff, however, as it prevented the majority of players who enjoyed both Slam Dunc and GMD experiences from being able to play Databrawl.

As for general association, it was loose. GMD was in the Databrawl server at a time and made uncomfortable art that would eventually lead to them being removed. I didn’t like being around someone who was regularly accused of being called a creep for their own behavior, and eventually chose to dissociate from them too. I’m not here to confirm or deny whether or not GMD is a pedophile herself, that should be left to those who want to focus on that situation.

I have never worked with GiantMilkDud in an attempt to defame or harass Myagenesis, nor have we had any form of collaboration for anything.

Admission of Wrongdoing

I’m not a blameless person, I will admit, as I have been involved in lewd behavior in the past. There are some truths to these accusations, such as my past experience of being the RR34 creator “big_wiggles” and the fact that Mya and I engaged in both collaborative RR34 builds and some erotic roleplaying, but that’s where the validity of the accusation ends.

Mya involved herself in the RR34 scene way before she knew who I was, and presented her own lewd creations to me before I admitted to being BW or even being in the RR34 scene, all of which while she was a minor. I had wrongly assumed that, because she was involved in RR34, that she was an adult like myself at the time. It wasn’t until I backed off from doing RR34 that she admitted to being underage, and immediately upon learning this, I decided to cease communication.

She had already been sexually deviant with other members of Slam Dunc Studios including, but not limited to, my personal friend group at the time of this situation happening.

Summary

Myagenesis is accusing me of being a pedophile due to past behavior between me and her. Additionally, she claims that I have directly worked with GMD (GiantMilkDud) in order to harass her off the platform. The situation has been reviewed by a third party and it was concluded that both me and Mya were at fault for what transpired; Me for not ensuring she was an adult, and Her for acting as an adult and engaging in adult activity while underage.

To put simply, while her accusation of me being a pedophile is wrong, I am not without blame. I apologize for what I did.

Closure

To this day, even though I admit to showcasing gross behavior in the past, those days are behind. It's been nearly 6 years since Mya and I dissociated, 5 years since this document has festered, and has been repeated by different talking heads between now and its inception. During all of this, I have made previous responses with the same admissions and counterpoints, and this is meant to be a final response from this point forward on the Mya situation.

I will do what I've been doing this entire time. Moving on, and not letting my past mistakes eat me alive. I will continue to develop Databrawl and any future projects I see fit, and I will continue to rail against this accusation for as many times as it continues being repeated. While I regret what I've done and the people I've hurt, including Mya, know this;

I'm not going anywhere.
