The defendant is charged in this court with one (1) count of Assault on a Peace Officer or Judicial Officer, in violation of 45-5-210, MCA. The defendant appeared before the Court on July 29, 2024, was advised of his rights, the charge(s) pending against him and the possible penalties he could face. The defendant stated that he understood his rights. The defendant requested a court appointed attorney and was assigned one. The Court ordered the Defendant held on a bond of **\$25,000.00** and ordered the defendant to abide by the following conditions upon release.

The defendant shall not:


1. Leave the State of Montana
2. Possess any drugs or alcohol or enter bars or casinos.

The defendant shall:

1. Notify the Court and County Attorney of any change of address or phone.
2. Maintain weekly contact with his attorney when assigned.
3. Remain law abiding by obeying all local, State and Federal laws.
4. Waive extradition with regards to leaving the State of Montana. The Defendant agrees to be extradited back to Montana if he violates any release condition.
5. Appear in the Justice Court on Friday, August 16th, 2024, at 2:00 pm for a Preliminary Hearing.
6. If the Preliminary hearing is waived by the Defense, the defendant shall appear in the First Judicial District Court on Tuesday, August 20th, 2024, at 8:30 am for an arraignment.

IT IS THE ORDER OF THIS COURT that any non-compliance with the above conditions of release will result in a **no bond warrant** issued in the name of the defendant and he/she will be arrested and brought before this Court to answer.
