

## **Community Alert – Concerning Behavior of Christian Peterson (Alias: Foxypaw)**

I am writing this document to bring serious attention to an individual known online by the alias **Foxypaw**, whose real name is reported to be **Christian Peterson**. This individual has been involved in alarming and predatory behavior across online platforms, most notably **VRChat**, and has a pattern of manipulation, deception, and abuse.

### **Key Information:**

- **Name (Reported):** Christian Peterson
  - **Aliases:** Foxypaw, and potentially others
  - **Known Platforms:** VRChat, possibly Discord, and other VR-based social platforms

#### 1. **Full Admission of Predatory Behavior**

#### 2. **Attempted Evasion and Account Deletion**

Following this admission, Christian Peterson attempted to cover his tracks by deleting several of his online accounts. He also proceeded to **block both The Godfather and** after being confronted about his behavior.

#### 3. **Use of VRChat and Other Social VR Platforms**

Christian is an active user of VRChat, where these interactions reportedly occurred. Given the nature of VR social platforms and their frequent underage user base, this raises **extreme concern for the safety of minors** interacting with him.

#### 4. **Manipulative and Evasive Tactics**

After being called out, Christian not only denied further allegations but attempted to disappear entirely—classic behavior of someone trying to **escape consequences**. This includes trying to remove digital traces, distancing himself from accounts, and avoiding

those who speak out.

### **Purpose of This Document:**

This document serves as a **community alert** and a **call to action** for platform moderators, trust & safety teams, and broader online communities:

- **Christian Peterson must be banned permanently** from platforms like VRChat and any other community where minors or vulnerable individuals are active.
  - Communities must be made aware of his known aliases to **prevent re-entry under new identities**.
  - The proper authorities and platform safety teams need to **investigate the situation further** to ensure there are no additional victims and that existing victims are protected.

I urge platforms like **VRChat**, **Discord**, and others to take this report seriously. We cannot allow predators to find safe haven behind usernames and anonymity. The safety of others—especially minors—**must come first**.

### **Section 1: VRChat Activity & Known Alternate Accounts of Christian Peterson (Foxypaw)**

This section is dedicated to documenting and exposing the online presence of an individual operating under the name **Christian Peterson**, primarily known by his alias **Foxypaw** within the VRChat community.

Christian has been active on **VRChat**, a platform known for its large and diverse user base, including minors. Based on multiple witness accounts and user reports, Christian has maintained a **primary account** and at least several **alternate (“alt”) accounts**, which he uses to **bypass bans, avoid detection, or continue interactions** after being blocked or reported.

### **Primary VRChat Account**

- **Main Username:** **Foxypaw** (*subject to slight spelling or casing variations, such as FoxyPaw, foxypawvr, etc.*)

    - Known to use **avatars with childlike or animalistic features** to attract younger users or deflect suspicion
    - Reportedly uses a **voice changer** to further mask his identity and avoid recognition

### **Known Alternate Accounts (Aliases and Suspected Identities)**

## Concerns Regarding Alt Account Usage:


The use of alternate accounts by Christian is **intentional and methodical**—primarily used to:

- **Evade bans or blocklists**
- **Regain access to individuals** who have already cut off communication with him
- **Disguise his identity** during public or private interactions
- **Maintain control over interactions and perception** without accountability


This behavior is **manipulative and deceptive by design**, making it critical that **platform moderators and the community remain vigilant** and aware of the signs.

All of this information has come from people who are terrified of this individual, and who have suffered emotional and psychological harm as a result of his actions. They have asked for their identities to remain confidential, and I am committed to protecting their safety while bringing these allegations to light.

### **ATTENTION: CALL FOR SURVIVORS & WITNESSES**

We have identified a **total of 133 victims**, with confirmed ages ranging from **12 to 15 years old**, in connection to a series of disturbing acts committed by a known predator.

If **you are one of these victims**, or if you suspect that you may have been **targeted, manipulated, groomed, or exposed** to inappropriate behavior by this individual — **please do not stay silent.**

We stand **for the voices that were silenced**, for those who were **manipulated into secrecy**, and for those who may still be **living in fear or confusion.**

You are **not alone.**

You are **believed.**

And **you deserve justice.**

If you were:

- Contacted or approached online or in person by this individual
- Pressured into inappropriate conversations or behaviors
- Groomed, manipulated, or threatened into silence
- A witness to any behavior that made you or others feel unsafe

**Please reach out to us.** We are here to **listen**, to **support**, and to **take action.**

Even if you're unsure whether your experience "counts" — it does.  
Even if it happened years ago — it still matters.  
Even if you feel afraid — **you are not alone.**

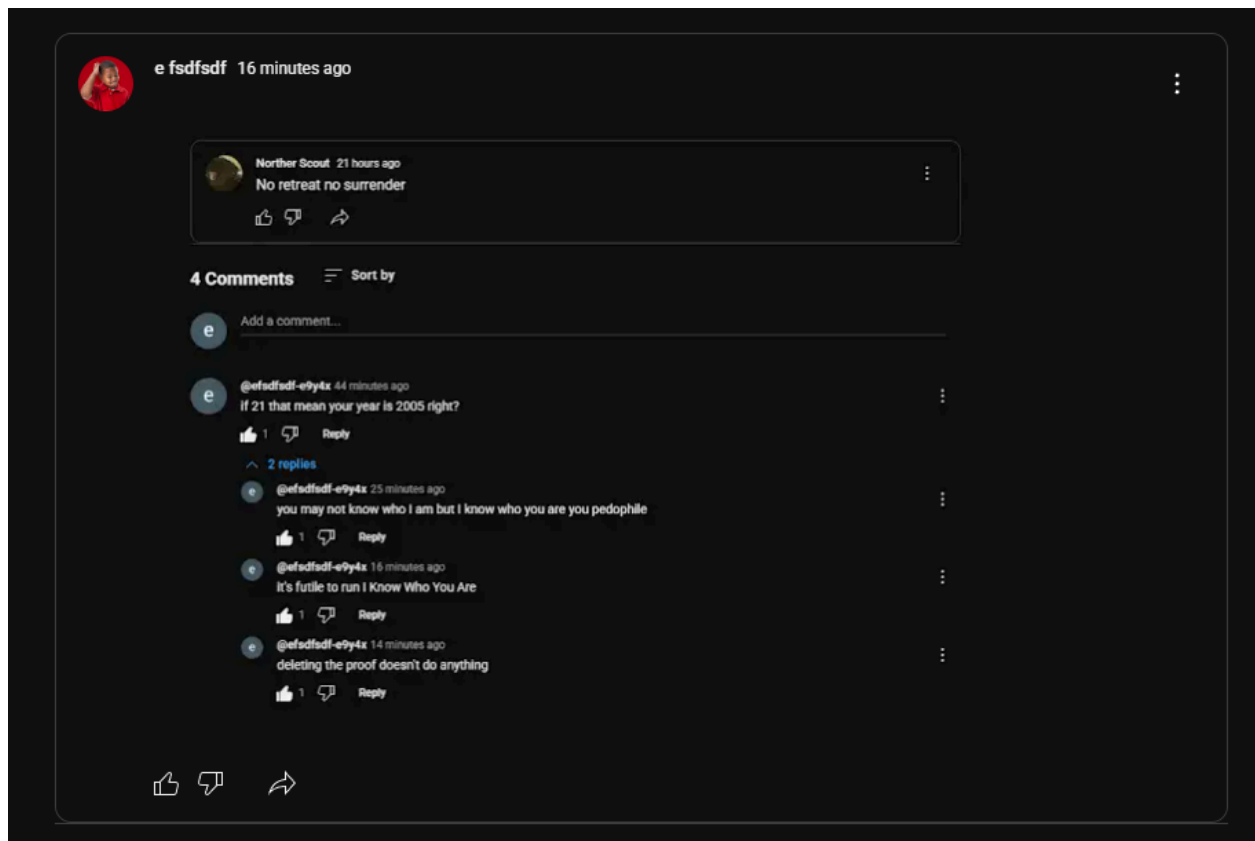

by now he probably changed his username to run and probably requested all of his information to be deleted.

We are currently in the process of **gathering and linking all available screenshots, images, and visual evidence** connected to this case. These materials serve to verify patterns of behavior, support victim testimonies, and expose the extent of the deception.

Please note: **This section will be updated continuously** as more evidence becomes available, ensuring transparency and accountability. Future additions may include **chat logs, deleted posts, account screenshots, timestamps, and other relevant media** tied to the individual's actions across multiple platforms.

This is only the beginning — **more proof will follow**.

As anticipated, the individual in question **deleted the original account** that posted the exposing video in an attempt to erase evidence and avoid accountability. Shortly afterward, they attempted to **create a new account** to continue hiding and distancing themselves from the situation — but this tactic **did not go unnoticed**.

Despite efforts to cover their tracks, these actions only further demonstrate an intent to **evade responsibility** rather than face the consequences of their behavior.


**Northern Scout** — these are the known accounts you've used or attempted to wipe clean in order to conceal your identity and history. Your attempts to disappear or start over won't erase the harm you've caused, nor will they silence those coming forward.

We have documented these activities and are actively tracking patterns of behavior across platforms. Hiding behind new profiles won't protect you — **accountability is coming.**


Additional information, including further documentation, witness statements, timeline breakdowns, and verified interactions, **will continue to be updated over time.** As this investigation progresses, **we are committed to releasing every piece of relevant evidence** to ensure full transparency and clarity.

We are also closely tracking **suspicious account activity.** There have been multiple attempts by the individual to **alter usernames, delete content, and create new profiles in an effort to avoid detection and accountability.** Each change has been logged and archived, reinforcing a clear pattern of **evasion and deception.** These actions are being thoroughly monitored and will be reflected in future updates.
