ENTRY OF GUILTY PLEA

I, Gabriel Kohsman, am the Defendant in the above referenced case and I am being represented by my attorney, Lisa Tome. My constitutional and statutory rights have been explained to me by the Court and by my attorney. I have reviewed the facts and law of my case with my attorney and now wish to withdraw my plea of "Not Guilty" and enter a plea of "Guilty" to the following charges. I understand that by pleading guilty to the offenses specified below, I am making a complete admission of guilt that I committed these offenses and that I am waiving any and all constitutional, statutory and factual defenses which may exist.

I. CHARGES AND POTENTIAL PENALTIES

In addition to the possible penalties set forth above, I understand that there is a mandatory prison term of N/A and/or a mandatory fine of N/A. Because there is a mandatory prison term, I am not eligible for community control or judicial release during that portion of my sentence.

G.K

I understand that I am pleading to an offense that carries an indefinite sentence and will receive both a minimum and maximum term. I also understand I will be released after I serve the minimum term, unless the Ohio Department of Rehabilitation and Corrections determines that I remain in prison for bad conduct and that my term could be extended to the end of the maximum term imposed by the Court.

G.K

I understand that if a prison term is not imposed, I could be placed on a term of Community Control supervision for up to five (5) years instead of prison. Further, I understand that if I violate the requirements of my Community Control supervision, my Community Control sentence could be revoked and I could face more restrictive Community Control sanctions and supervision, or I could be ordered to serve a prison sentence.

G.K

I understand that restitution and other financial costs could be imposed in my case. I understand that for drug crimes my driver's license may be suspended for up to 5 years.

G.K

I understand that I am also subject to the following additional sanctions: Tier II Sex Offender Registration Every 180 days, for 25 years

G.K

I understand this is a sexually-oriented offense for which I will be required to register with the Sheriff. The Sheriff may be required to tell my community of my crime and address.

G.K

I am not under the influence of alcohol, drugs, or medication. I am currently taking the following medication(s):

II. PLEA AGREEMENT

G.K

I am entering this (these) plea(s) as a result of a negotiated agreement reached by my attorney on my behalf and the Licking County Prosecuting attorney's office. This agreement is as follows: Dismiss counts 5 and 6
No agreement on Sentencing and forfeiture of electronics involved in the case

G.K

I understand that if the Court imposes a jointly recommended sentence that is authorized by law, that sentence is not subject to review on appeal.

G.K

I am aware that if I am currently on probation, parole, or post release control this plea may result in revocation proceedings and any sentence imposed for the charges listed above could be consecutive to the sentence I could receive for having my supervision revoked.

G.K

No promises or threats were made to me as an inducement to change my plea.

III. POST-RELEASE CONTROL SUPERVISION

I understand that if I am sentenced to prison, I will be subject to serve a period of Post-Release Control supervision by the Adult Parole Authority after I am released from prison. I understand that the following periods of Post-Release Control are applicable:

Any felony sex offense

Mandatory five-year term PRC

F-1

Mandatory minimum 2 years PRC, up to maximum of 5 years

F-2

Mandatory minimum 18 months PRC, up to maximum of 3 years

F-3 (cause or threat of physical harm)

Mandatory minimum 1 year PRC, up to maximum of 3 years

F-3, F-4, F-5

Up to 2 years PRC, as determined by Parole Board

I understand that if I am on Post-Release Control and violate the conditions of my Post-Release Control, the Adult Parole Authority could impose a prison term as a sanction each time I violate my Post-Release Control, for a maximum cumulative prison term of up to one-half of the originally stated prison term.

I understand that if I am convicted of a new felony while on Post-Release Control, in addition to being punished for the new felony, the Judge could impose an additional consecutive prison term of one (1) year, or whatever time remained on my Post-Release Control term, whichever is greater, as a maximum.

IV. WAIVER OF RIGHTS

I understand by pleading guilty I am waiving, or giving up, a number of important constitutional rights. These rights include:

G.K

the right to have my guilt or innocence decided by a jury of twelve (12) people, or a judge, after a trial.

G.K

the right to require the prosecutor to prove my guilt, beyond a reasonable doubt, on every element of each offense I am accused of committing.

G.K

the right to confront and have my attorney cross examine or question any witness who would testify against me.

G.K

the right to present evidence and call witnesses, and the right to use the Court's power to order witnesses to appear in Court and testify on my behalf.

G.K

I understand that if my case went to trial no one could require me to testify, and if I chose not to testify, no one could comment on my decision not to testify as proof of my guilt.

G.K

I understand that if I am not a citizen of the United States, pleading guilty or no contest to the offense(s) may have the consequences of deportation, exclusion from admission to the United States, or denial of naturalization pursuant to the laws of the United States.
