Aaron is my ex-husband and we have three children together. After Aaron and I got divorced, Aaron married his current wife, April. Initially, April and I had a good relationship, and she and I were able to communicate well. However, that changed after Aaron learned April had confided in me that Aaron was abusing her. There is a history of domestic abuse between Aaron and April. In May-August of 2022 at Charlotte's dance recital, April confided in me that she was being abused by Aaron. April told me that Aaron was head butting her and squeezing her until she couldn't breathe. April also told me that Aaron told her to "crawl back into the hole that is Litchfield." I was scared for April and I cried with her. I wasn't able to sleep. April and I also sent the enclosed text messages regarding the abuse.

After Aaron learned that April had confided in me regarding the abuse, April's attitude and behavior towards me changed drastically. April began making false accusations against me and defaming my character, including online and on her broadcast show, all of which

caused me to fear for my safety, security, and privacy. As such, I told Aaron that I no longer felt comfortable communicating with April and that all communication regarding the children and co-parenting needed to stay between Aaron and me. Aaron and April have harassed me for months and demanded that April be included on our co-parenting communications. Aaron also demanded that my husband (Haylen) be included on our co-parenting communications. I told Aaron that I did not agree to include our significant others and that, instead, the communication needed to stay between Aaron and me as the parents, and then we can each share with our significant others what we want or need to. In response, Aaron and April have sent many harassing messages to me directly and to others about me and continue to harass and defame me online. I have made it clear that I do not want to have contact with Aaron unless it is about our children and that I do not want Aaron and April to speak about me or the children or any of my family members online or on their broadcast show, but they continue to violate my privacy and invade my boundaries which has had a substantial adverse effect on my safety, security, and privacy. Enclosed are copies of the harassing messages that Aaron and April have sent to me and others about me.

Aaron is also verbally abusive to me. For example, Aaron sent the enclosed messages to me on August 16, 2023. As you can see from the messages, Aaron's communications to me are hostile, aggressive, threatening, and accusatory. My attorney has sent many letters to Aaron's attorney to address Aaron's abusive behavior. Nonetheless, issues with communication continue to occur.

In February 2023, Aaron was engaged in online fights with many podcasters, and the fights involved me and the books that I have published as an author. Aaron and April went on their online broadcast show and made a lot of defamatory statements about me. They called me "Evil," and a "Piece of shit," and threatened to go after me legally or go after my book deals, etc. Aaron and April claimed that I had defamed them online, which was not true. In reality, a man who Aaron does not get along with posted about one of the books that I published online, and I "liked" his post. It had nothing to do with Aaron or April.

Aaron had a falling out with his family, primarily his parents, so I facilitate the relationship with our children and Aaron's parents during my parenting time. Aaron and April have been extremely upset with me about this and have attacked me via text messages. Aaron and April have also verbally attacked me and harassed and defamed me online and on their broadcast show about the situation. There are video clips and recordings that I have of the harassing and abusive behavior after Easter of 2022 when I brought the children (during my parenting time) to Aaron's side of the family, as well as Thanksgiving and Christmas. In turn, on their broadcast show, Aaron and April talked about his parents dying and his feelings because of the anger.

A misdemeanor violation may result in a sentence of up to 90 days in jail and/or a fine of \$1000.00. Some repeat violations are gross misdemeanors that may result in a sentence of up to one year in jail and/or a \$3,000.00 fine. Other violations are felonies that may result in a sentence of imprisonment for up to five years and/or a fine of \$10,000.00.

Federal law may prohibit shipping, transporting, possessing or receiving firearms or ammunition while this order is in effect. 18 U.S.C. § 922(g)(8).

If the court grants this Harassment Restraining Order for a period of up to 50 years under Minn. Stat. §609.748 subd. 5, the Respondent must wait 5 years to seek modification of the Harassment Restraining Order.
