Suicidal Subject/Swatting/McCoy

On 04-11-20, I, Detective Sgt. Jordan McCoy, was working for the Marquette County Sheriff's Office. At approximately 10:52 AM, I was contacted by the dispatch center who stated they had received a phone call from Josh Brown, at phone number 703-995-8926, who is a Crisis Intake Worker, for Beacon Health Options, Associated with the National Suicide Prevention line. Brown advised dispatch he had been communicating, electronically with Judith R. Tomlinson, F/W DOB 11-06-45, of W4921 CTH Z, Westfield, WI, phone number 608-697-7913. Dispatch advised that Judith had stated she had shot her husband and his girlfriend because he has been cheating on her and she had a gun to her head and would shoot any law enforcement that arrived at the residence, further stating she wanted to end her life. Dispatch said Brown did not have a callback number, only an IP address for the computer that he was communicating with of 87.249.134.68, port 52776.

Myself and other units from the Marquette County Sheriff's Office went en route at 11 AM and arrived in the area at approximately 11:14 AM.

After a perimeter and observation location was set for the residence, I did attempt phone contact with the in house number for Judith of 920-787-7142, however no one answered. We were able to also locate a phone number for Judith's husband, Thomas G. Tomlinson, M/W DOB 01-11-49, of the same address, phone number 608-697-7912. After multiple unsuccessful attempts, I was able to speak with Thomas on his cell phone and he advised he was at the residence with his wife and they were both okay and I asked them to step out and speak with us. A short time later both Judith and Thomas exited the residence and followed commands until it was determined that they were not armed. Both Judith and Thomas were very polite and cooperative while we spoke. Both Thomas and Judith said their son, Patrick S. Tomlinson, M/W DOB 04-18-80, phone number 608-566-9287, had called them approximately a year ago and told them that he had been involved in some type of dispute online and warned them about the possibility they may be "swatted". Judith said they contacted the Marquette County Sheriff's Office when they received this information from Patrick to make us aware, however according to Judith, she was asked "what's swatting" when speaking with the dispatcher. Judith went on to explain that her son Patrick had been swatted in excess of 20 times in the Milwaukee area and had made numerous complaints with the Milwaukee Police Department and also with the FBI.

Judith allowed me to go with her inside where we continued to talk. The residence was well kept and no sign of a disturbance was noticed. I had Judith go on to the computer in their residence and on the website, ipchicken.com, identified their IP address to be 184.97.55.58, with their internet service provider being Bright Speed through Centurylink. Judith also confirmed that she had not been in communication with anyone at the National Suicide Prevention Line. All units then cleared from the scene.

Later on the 11th of April, I did place a phone call to Josh Brown, the Crisis Intake Worker for Beacon Health Options at phone number 703-995-8926, and left a message for him to call me in order to obtain the chat logs or whatever type of communication had occurred.

Upon returning to the Sheriff's Office, I did search on maxmind.com for the IP address 87.249.134.68, which showed that it was registered to the internet

service provider DataCamp Limited with a domain of datapocket.com. Using the search.org website, for the ISP's, it lists DataCamp Limited in Miami Florida, with an email address of abuse@datacamp.co.uk. Detective Sgt. Ropicky assisted in the investigation and stated he had been communicating with the email address of abuse@datacamp.co.uk, and was advised that even though it was exigent circumstances that he would have to email security@datacamp.co.uk to receive information. I also went to datapocket.com and found they are a provider of a VPN Service.

Lt. Aaron Williams sent an email on the 11th of April, stating he had spoken with an FBI Agent in the Milwaukee Office, Heather Wright, who was requesting any information we had regarding the call. Williams advised he was informed by Wright that they were currently conducting an investigation and they did believe that VPN's had been used for prior incidents with Patrick Tomlinson as the victim.

A copy of this report and any supporting documentation that may be received from the Beacon Health Option worker Josh Brown, will be forwarded to FBI Agent Wright for review.

This case is inactive pending further information.





Alarm/Klump

INITIAL INFORMATION

On 04-12-2023, I, Deputy Klump, was on duty for the Marquette County Sheriff's Office, operating unmarked squad, dressed in full Department uniform. At approximately 1039 hours, the dispatch center received contact from Simplisafe Inc., who was reporting an audible alarm, motion detected, but no zone was given. The key holder was a Thomas Tomlinson. The dispatch center advised they were having trouble reaching him. The incident was occurring at W4921 CTH Z.

Also responding was Deputy Matt Krueger. It should be noted at this address on the previous day, there was a swatting call at the residence where it was reported that a female, identified as Judith R. Tomlinson, F/W DOB 11-06-45, had killed Thomas. Through investigation it was determined that was not true and it was to be a prank or fake type call.

Upon arrival, myself and Deputy Krueger approached the area on foot and upon doing so, Judith came out of the residence advising she did not know what was going on and she was having trouble dealing with her Simplisafe Alarm and Thomas was down in Portage at Therapy. She needed no assistance from us but we did offer our assistance in trying to resolve the issue with her alarm. I did speak briefly with Simplisafe and they advised they were just previously on the phone with Judith trying to resolve some of the issues.

Myself and Deputy Krueger cleared from the scene.

DISPOSITION

This case is considered closed as a false alarm, believed to be faulty equipment.

INITIAL INFORMATION

On 04-21-2023, I, Deputy Klump, was on duty for the Marquette County Sheriff's Office, operating unmarked squad, dressed in full Department uniform. At approximately 1022 hours, the dispatch center received contact from Thomas G. Tomlinson, M/W DOB 01-11-49, who resides at W4921 CTH Z. He was reporting that there was a neighboring house he believed to be abandoned and the door on the house was broken in when he drove by this morning. He did not see any strange vehicles and does not believe anyone was still there. There was also a motor home on the property.

ARRIVAL

I arrived and made contact with Thomas who advised the house had been vacant for approximately 3-4 years and during that time the owners were attempting to fix it up and they lived in the Illinois area the last he knew, but he does not have any contact information for them. He advised due to the recent issues he had with his swatting call, along with issues with his alarm issues, he would feel better if the residence was checked.

Myself and Trooper Hart, 431, of the WI State Patrol, responded and arrived at W4838 CTH Z. During that time I did note there was a white screen door to be open on the front of the residence. Upon closer inspection the screen door appears to be just be dilapidated and finally falling apart and open. The main door was locked with cobwebs attached to it. We performed a 360 around the entire residence, did not observe any signs of forced entry and the residence appeared secure. We cleared from the residence and informed Thomas of our findings.

DISPOSITION

This case is considered closed and unfounded.

INCIDENT INFORMATION

On April 22nd, 2023 at approximately 0202 hours I, Deputy Gorr, was dispatched to a Suspicious call located at W4921 County Road Z in Westfield, WI. A male, who went by the name of Patrick, said he just shot his mother with a 12-gauge shotgun. The phone number associated with this 911 call was 323-366-5709.

INITIAL CONTACT

While responding to this call Sgt. Sukowatey noted that this residence had been the victim of many prior calls of "swatting." Even with this information I safely pulled over in the area of County Road Z and County Road JJ and made my squad AR-15 rifle condition 1 (round in the chamber and on safe). Marquette County Dispatch called the owners multiple times and they finally answered saying everything and everyone was okay. The owners and victims of this "swatting" are Thomas G. Tomlinson and Judith R. Tomlinson. Even with this information I had Marquette County Dispatch advise the homeowners to come outside when I arrived. I arrived and observed the elderly couple come outside. At no point did I point my squad rifle at them. I immediately recognized them both to be in good health and not injured. I approached and they both knew exactly why I was there.

I asked them if they knew who did this and they said "Patrick" or someone Patrick was involved with. Thomas and Judith said they had already reported this to the FBI and made many reports about it. I was trying to gather more information; however, a higher priority call came out near Oxford, which I had to go to. No one was injured or hurt in this call and they were victims of "swatting." I cleared from this call of service.

On 11-25-2023, I, Deputy Goodwin, was on duty for the Marquette County Sheriff's Office, when I was dispatched to a suspicious call at W4921 CTH Z, in the Town of Newton, Marquette County, WI. Dispatch informed me that they had received a call from the crisis line, stating that a male subject at that residence had found his wife cheating on him and had shot her and her boyfriend. I knew from prior calls there, that this was possibly a swatting call, since it had happened numerous times before, coming in the same way and saying somewhat of the same circumstances.

I arrived on scene and made contact with Thomas G. Tomlinson and Judith R. Tomlinson. Everything was okay at the residence and they were both fine and well. The call had come through crisis line and went contacted by dispatch they informed it had come through a web chat and not a phone number, so we will not be able to trace the caller.

At this time this case will be closed.
