On May 18, 2021 I was working for Spokane Transit Authority as a Securitas Officer on Road Patrol.

I was when a coach operator informed me that there was a "large man yelling and being aggressive." I observed subject 1: Werner Lucas (Identified via RMS) yelling at nearby patrons. I observed several patrons moving away from Werner while looking frightened and upset. I contacted Werner, instructing him to stop yelling. Werner started yelling at and insulting me, using phrases similar to "you're racist, misogynistic, and ageist." Due to Werner erratic and aggressive behavior, I informed Werner that he will not be able to ride the buses and that he needed to leave the property. Werner departed property while continuing to yell.
