The undersigned Officer under oath states on information and belief that the defendant committed the crime(s) of:

COUNT 1: ELECTRONIC COMMUNICATION HARASSMENT, a Class B Misdemeanor, in violation of Section 76-9-201, Utah Code Annotated (1953, as amended), in that on or about December 15, 2019, in Orem, Utah County, Utah, the defendant did, with intent to intimidate, abuse, threaten, harass, frighten, or disrupt the electronic communication of another, (a) make repeated contact by means of electronic communications, regardless of whether a conversation ensued, or after the recipient requested or informed the defendant not to contact the recipient, the defendant did repeatedly or continuously contact the electronic communication device of the recipient or cause an electronic communication device of the recipient to ring or to receive other notification of attempted contact by means of electronic communication; (b) make contact by means of electronic communication and insult, taunt, or challenge the recipient of the communication or any person at the receiving location in a manner likely to provoke a violent or disorderly response; © make contact by means of electronic communication and threaten to inflict injury, physical harm, or damage to any person or the property of any person; (d) cause disruption, jamming, or overload of an electronic communication system through excessive message traffic or other means utilizing an electronic communication device; or (e) electronically publish, post, or otherwise disclose personal identifying information of another person, in a public online site or forum, without that person's permission.

COUNT 2: ELECTRONIC COMMUNICATION HARASSMENT, a Class B Misdemeanor, in violation of Section 76-9-201, Utah Code Annotated (1953, as amended), in that on or about January 14, 2020, in Orem, Utah County, Utah, the defendant did, with intent to intimidate, abuse, threaten, harass, frighten, or disrupt the electronic communication of another, (a) make repeated contact by means of electronic communications, regardless of whether a conversation ensued, or after the recipient requested or informed the defendant not to contact the recipient, the defendant did repeatedly or continuously contact the electronic communication device of the recipient or cause an electronic communication device of the recipient to ring or to receive other notification of attempted contact by means of electronic communication; (b) make contact by means of electronic communication and insult, taunt, or challenge the recipient of the communication or any person at

the receiving location in a manner likely to provoke a violent or disorderly response; © make contact by means of electronic communication and threaten to inflict injury, physical harm, or damage to any person or the property of any person; (d) cause disruption, jamming, or overload of an electronic communication system through excessive message traffic or other means utilizing an electronic communication device; or (e) electronically publish, post, or otherwise disclose personal identifying information of another person, in a public online site or forum, without that person's permission.
