Who must attend?

All parties must attend the settlement conference and have authority to settle the claim, and may be accompanied by a lawyer or articulated student, except the defendant need not attend if

- (a) the claim results from a motor vehicle accident,
- (b) the defendant is disputing the amount of the claim but not liability, and
- (c) a person appointed by the Insurance Corporation of British Columbia attends instead of the defendant.

What should the parties submit?Each party to a claim must submit to the registry all relevant documents and reports they wish to rely upon **at least 14 days** before the conference, and **serve them on all parties 7 days** before the conference.**What is the purpose of the settlement conference?**

There are two main purposes for a settlement conference:

- (a) to encourage settlement of the case, and
- (b) if settlement is not possible, to help the parties prepare their cases for trial.

Notice of Settlement Conference

What happens if someone does not attend?

The judge may dismiss the claim or make a payment order or other appropriate order against a party who does not attend a settlement conference.

IMPORTANT INFORMATION ABOUT YOUR SETTLEMENT CONFERENCE

How do parties submit documents for the settlement conference?

In accordance with Small Claims Rule 7(5) all relevant documents and reports must be submitted to the court registry 14 days before the conference and served on all other parties 7 days before the conference. Parties must also follow and Practice Directions issued by the Chief Judge of the Provincial Court posted at: <https://www.provincialcourt.bc.ca/>.

Each party to a claim must submit documents relevant to the settlement discussion in advance of the conference. Materials must be:

- (a) limited to one (1) package of reference documents, such as invoices and contracts, per party for the settlement conference;
- (b) clearly labeled indicating court file number, settlement conference date, and submitting party name(s); and
- (c) if submitted electronically, must be submitted as a PDF with pages numbered consecutively.

The settlement conference is not the trial. The documents submitted by a party should contain only key materials for the settlement conference and any report required under the Small Claims Rules not all of your evidence. Electronically submitted reference documents will be automatically deleted from the system two days after the scheduled hearing. If the hearing is in person and you submitted documents to the registry, they will be returned to the party(ies) after the conference concludes. If you need assistance in converting your reference document(s) into PDF format, refer to <https://www.wikihow.com/Convert-a-File-Into-PDF>.

What do parties need to know about attending the Settlement Conference remotely?

If your notice indicates that you are to attend remotely, the hearing will be conducted virtually and all parties, including the judge, will attend using the Microsoft Teams audio- and video-conferencing platform. Do not attend the courthouse in person for your settlement conference. Parties will receive remote appearance details 24 hours prior to the appearance, this notification is sent to you by email. If you are unsure if your email address is current contact your local registry or complete and file Form 38 Address for Service including your most recent information.

Microsoft Teams allows participants to join the conference using video or audio from a desktop, laptop, tablet, or smartphone, or to dial-in to a proceeding from a telephone. If you are appearing by video, please ensure that you have downloaded Microsoft Teams or have the latest version of Google Chrome or Microsoft Edge.

If you received this Notice by mail and intend to appear using video or audio from a desktop, laptop, tablet, or smartphone, and you did not provide an email address for service, please file an Address for Service (Form 38), with the court registry that includes your email address and the court registry will send you the MS Teams meeting invite 24 hours prior to your appearance.

The link and dial up information you receive by email may be shared with your lawyer if you have retained counsel; and with your client, if you are counsel.

Please do not forward or share the MS Teams link or dial up information to any unauthorized parties. The settlement conference is a conversation between the parties, their counsel (if represented), and the judge and only parties and their counsel may appear at the conference unless otherwise permitted by the case conference judge.

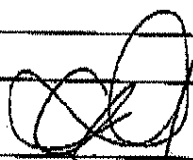
