

You can deny everything, or you can admit to everything; either way it's still going to follow you for the rest of your youtube career. **The only difference is that if you are lying about anything right now, the truth WILL come out in the future and we will have to go through all of this all over again.** It is in your best interest to be honest with me and the general public.

At this point I believe the truth is somewhere in the middle. I don't think that entirety of the logs with snake thing are faked. I have evidence from numerous people showing that at least **some** of those message are real.

If you are lying about any of this, and I, and many others, can easily prove that it is a lie; it makes you look guilty of **everything**. People will likely never trust you. But if you admit to those easily demonstrable things, apologize to the general public for initially lying, and tell them that you are doing your best to "do better", it might at least give people some hope for you.




