## Why are we releasing this now

Taking accountability and talking about our role in how this fucked up. We endangered a minor.

## Introduction

Hello. This document was created by two individuals personally involved in archiving tweets and being schizophrenic. The situation began when Lex broke up with her boyfriend. After the breakup, Lex made numerous claims and began with a multitude of allegations including accusing Jake Weddle of being a potential pedophile/groomer. Lex never reported it to law enforcement or had the child's consent in talking about this. We would also make this claim later on as we were told there were multiple minors and our concern was if there was then our prior defense could be wrong. We still fucked up and we should have called Jake Weddle out regardless because even if it was just Snow, it was still wrong.

Lex publicly criticized the minor's presence on the [r/mrbeastsnark subreddit](#) without attempting to contact her directly or getting the minor banned from the subreddit to protect her from harassment. Jake Weddle exacerbated the issue by continuing to engage in direct messages (DMs) with the minor, failing to address the situation responsibly, and allowing it to escalate unchecked. If Lex or Edna genuinely believed grooming was occurring, the ethical response should have been to reach out to the minor, understand her perspective, obtain relevant communication logs, and involve her in decisions about how to handle the information sensitively as well as contacting her parents.

This is why we contacted the minor, listened to her side, and worked with her to gather evidence. We had the minor stream the full DMs from start to finish and secured a locally downloaded copy for verification. Please note that this document has been in development for a few months. Therefore, there may be some discrepancies between the dates in screenshots and other materials. We will do our best to clarify when things were screenshotted as they appear.

That said, we should also be honest. We—or rather I, aka ThreadIsDead—were soft on Jake Weddle, giving inconsistent statements to other parties and engaging in unethical behavior, not only to attain information but also to prevent others I viewed as malicious from knowing what information I did or did not have. We failed at that and we do believe we should be called out for our own actions and our mishandlings which we will say we did fail Snow after the fall of MIB. We did endanger Snow because it was our responsibility to protect her and we did fail at that. We are guilty of endangering a child for personal dramas. We are not innocent.
