Parlo is friends with a UTTP member, defender, who is also a pedophile and a groomer, yet Parlo turns a blind eye to this. This document thoroughly goes through these allegations.

Before Parlo tries debunking this simply by saying “FPS is a UTTP member and that alone ruins the credibility of the document,” that is just not true at all. Sure I may have done similar things to Parlo in the past, but that does not mean I am just throwing out accusations to try and tarnish his reputation.


Chapter 1: The backstory

Parlo's connection with defender began in November of 2023, after Parlo had made his first video including the UTTP.


In February, the next year, Parlo had uploaded a video about the UTTP, the video actually featuring defender grooming girls into self harm. Since defender was extremely irrelevant at the time, it was very niche knowing that he had got girls to cut themselves. How did Parlo know? Maybe because defender told Parlo.

I know this because I had front row seats and defender literally bragged about it in the RetroUTubeTrollPolice Team discord server.

I do not have screenshots of him bragging about it in January and February last year when the RUTTP existed, but I do have screenshots from recently:



Why does Parlo make videos on the UTTP?


He continues to make more videos on the UTTP, as he earns an extortionate amount of ad revenue (seen as the UTTP videos on most occasions get more views than his other videos), and in return, defender gets promotion for the UTTP. Defender has admitted that Parlo only made the July 2024 UTTP video to milk The Amazing Digital Circus again.



Chapter 2: Proof of their friendship

Parlo has on various different occasions claimed that he is not friends with defender and has also said that he would be more than willing to expose defender if he is truly a foodist pedophile groomer, so why hasn't he yet?

He's also tried to cover his tracks and delete all evidence of their friendship, but it was too late. A youtuber named Underman105T covers this situation extremely well, his video including a recording of Defender being in Parlo's roblox friends list, and Parlo saying various different slurs: [📺 The Dark Truth Of @ParloYT's Dox Of @Potemer](#)



Not long after this video was published, Parlo unfriended defender in an attempt to erase evidence.

Why would he do this? Maybe because he doesn't want people to know that he's best friends with a foodist UTTP pedophile.

And here's a screenshot of Parlo acting friendly with defender, while he acts hostile with every other UTTP member, an example being when I added him on discord and his first message to me was "What the fuck do you want?"



The only reason defender spoke bad about pedophiles was because this conversation was in a group chat rather than direct messages.

Parlo was also in defender's discord server, defender's domain. This server also had pedophiles in it, one of these pedophiles being an individual named reginmyre. Reginmyre is known for being in various different "com" groups like 764, slitbunnies, harmnation and starved summer. Reginmyre had a role in the server, the "do not fuck with" role. This is relevant because Parlo had the same exact role.





And here's proof of Parlo being in defender's domain:



This is proof that Parlo had the “do not fuck with” and “ascosciates” role, as you can see in the domain, the channel was named #private-general.

Parlo also allied with defender to take down a minecraft server named JennyCraft.

Parlo would clearly not be okay teaming up with any UTTP member, seeing the hostility that he displays to all of them, except for Defender.

Defender was not shown much in Parlo's UTTP videos compared to me, Glen or even reginmyre, and even when he is shown, it is often in a positive manner, like in Parlo's video about the UTTP from August 2024, showing defender in a voice call with another UTTP member named Joshua Pena, speaking about how they hate pedophiles (despite defender being a closeted pedophile himself).


As well as this, in some of Parlo's videos about the UTTP, he uses screenshots that he could have received only through Defender, such as screenshots of private DM conversations between his supposed “close associate” offender (also possibly a Defender alt), and UTTP Emperor of Anime Sucks.

In addition, **EVERY** single one of Parlo's UTTP videos that speak bad about defender have been mysteriously privated. He can lie and say that he privated them to avoid strikes, but there


is nothing reportable in those videos and if they were, they would have been struck down already. And, most of his videos are already about exposing supposed “pedophiles”.


Chapter 3: Illegal shit done by defender that Parlo brushes off

In one of Parlo's first UTTP videos, he mentions the fact that the UTTP raided a 2k member The Amazing Digital Circus fan discord server. He also mentioned how a UTTP member recorded the raid and uploaded it to youtube. This youtube video featured a picture of Ikea's genitals. Remember, Ikea is a minor. Defender is the one who solicited this picture and told the UTTP to spam it. How come Parlo did not mention defender in that segment in his video? Because they are friends.

Grooming


Defender sent an e-girl to groom and manipulate the youtuber HairyTwinkle2929. At the time, Parlo was engaging in drama with Hairy, so clearly defender sent that e-girl to force Hairy into confessing to what he did to benefit Parlo. Have a look at this twitter thread:

Other shit


Defender was friends with a UTTP member named Miami, real name being Yaddyel Florentino, son of Leydi Florentino, who raped a kid in a voice call with his camera on. He continued to be friends with Yaddyel, even after this incident.

Defender also admits to nearly coercing someone into suicide.




Chapter 4: Promoting the UTPP

Not too long ago, Parlo made a youtube video about the UTPP and The Amazing Digital Circus drama (<https://www.youtube.com/watch?v=SVvHZ6JuDv8>). But this drama never happened. It is about a quite literally non existent raid. Sure, Glen tried to start the raid, but quite literally **ONE PERSON** participated in it. An attempted, and failed raid is not a good reason to make a video on the UTPP, unless your sole goal is to earn ad revenue, promote the UTPP and expose children to a foodist website (SkbidiForums) where they will be exposed to illegal, vile and/or graphic content and possibly even get groomed. If he did not want that, he would've censored out the SkibidiForums url in his video just like SomeOrdinaryGamers did in his recent video about comment bots spamming cp.



The singular person who participated in the raid, and who was shadowbanned.
Oh and if I may add, because he was shadowbanned, literally nobody knew about this raid except for UTPP members. How would Parlo know? Maybe because defender told him!

As well as this, the KrisSkulls twitter account hijacking in Parlo's UTPP video from June 2024 was not done by any discord UTPP member, rather it was done by a larper (as can be seen in the chatlogs). This is another instance of defender giving Parlo random bullshit to talk about in any of his videos.
