

# Peptides Memoirs in Space Station 14

Written by Peptide, Credentials and preface:

- Previous top 10 contributor to Wizden, starting in February 2021, One of the first mappers on SS14 besides PJB (Saltern) and Timrod (Packed). I created the first medium to high pop map NSS Pillar as well as Split Station, wrote the mapping wiki and maintained it till 2024 and helped countless mappers get into SS14 who are responsible for some of the maps you love now.
- Previous Game Admin from around December 2021 till around 2023 when I stepped down, again one of the most active admins during the 2022 period alongside Pancake and a few others who we taught, outlasting quite a few of those which will be touched on later.
- Owner / Founder of Singularity Network, Previously just Nuclear 14. I started Nuclear-14 in July 2022 because I was fed up with how disjointed it was contributing to Wizden. Having some maintainers impose their gameplay design and bias and at other times leave it as a free for all so my PRs would get countered the next week. I raised my issues with multiple people but change started to happen too little too late. Despite the discord for Nuclear14 / SiN starting in July 2022 we didn't manage to launch the alpha for Nuclear14 until August 2023 due to personal commitments and lack of contributors.
- For further context, I never intended to start a community in SS14. I ran communities on minecraft and more on Gmod successfully from around 2009 to around 2015 from DarkRP and TTT to openaura / clockwork / nutsript with the latter being a minor contributor. I left that all behind due to life commitments and just wanted to contribute and make a difference in SS14. I actually stumbled across RE:SS3D first then quickly realised the 3D Spess game wasn't the best format and then quickly discovered SS14 so started piecemeal contributing here while working away from home.

At the time of writing it's now the end of January 2025, I was banned from Wizden discord in November / December 2024 for being outspoken about the handling of things and for asking difficult questions, or just because PJB now hates me, more on that later. It will likely be February 2025 by the time this comes out.

I will lay out everything as logically and as verbatim as possible. I honestly don't have sides in this and historically there has only been one person in this project I did not get along with, and they got removed after I stopped contributing, only after they had driven many contributors away from the project. To lay my cards on the table, the only other person I now dislike is PJB, for how they've acted throughout this process and how they seem to have made up their mind of me and will do everything they can to not see things for how they might be.

I am not your typical internet dweller or "game developer". I'm a late 20s British guy who works in Engineering and Construction. I'm passionate about tech, I enjoy gaming and I'm also passionate about inspiring students to get into STEM careers which is what I spend a lot of time doing when I'm not working or raising my young family. I've never frequented 4chan, I played SS14 on paradise station for a few years, years ago and I barely even frequent reddit anymore because life is too short to be terminally online. It's very likely I have

ADHD but I don't let things like that define me and I definitely don't have autism. Tl:Dr, looking at me you wouldn't think I run gaming communities, like roleplaying or do amateur game development.

And a final note before I move onto the next section. I never wanted things to go the way they have. Dividing the community isn't good for anyone and for the longest time I actually wanted to be a maintainer / PM for Wizden to help them steer the ship in the right direction, but that never came to be. I have zero allegiance to anyone and to expand on me not being terminally online, I barely have the bandwidth to keep up with my own discord server, nevermind two or three or more. I check the EE council or other places when I get a ping or when I need help with something or to complain about something. These are barely social spaces for me and I have been openly critical of the way Wizden handles things for awhile now, as I think was my right as a senior contributor who had felt neglected or ignored more than once.

I have never harassed or condoned the harassment of anyone and the screenshots that I have seen that have me in them are either coincidental that I was having a conversation at the same time as someone else, me having a jibe at Wizden the organisation for how they have handled something or reacted which has impacted me, or commenting again on something that has directly impacted me by a specific person. This is not harassment, if you can't take legitimate criticism or actually discuss disagreements then the internet is not the place for you. Hiding behind your powers when someone disagrees with you or your friends is not the way to go, have an open conversation and understand each other.

And a final, final note, I was never involved with Nyanotrasen / Nyano. I was actually staff at Wizden at the time and was fully on Wizdens side. I'll cover all this drama in detail later but this misinformation that I was involved in, comes from people who I don't even know and never saw active during my time at Wizden?

# Timeline of Events

Note: Some of the dates and information might be fuzzy since I got banned and lost access to some channels in Wizden. I will try to cross reference and check info where possible.

Dates / Events in [light blue](#) are things I was witness to but probably not involved in.

- February 2021 - Start contributing to SS14. I do a few PRs learning yaml up until April and then I take a break till December due to having a baby.
- December 2021 - I start contributing again and quickly hit the 100 hour playtime requirement to apply for admin. I become admin in December and then all of my playtime past 100 hours is admining for Wizden which is over 400 hours. I'd usually admin while contributing in the background. A lot of my contribution to this date was fixing things and adding content that was still missing. At this time in SS14 we had Saltern and maybe Packed and barely any content or prototypes.
- February 2022 - NSS Pillar V1 comes out. The first mid to large pop map. Lots more fixes, new roles added to the game, started maintaining packed station too.
- April 22 - Split Station comes out, another large pop map met with mixed feelings, the entire idea was to do something radical and for testing of grid splitting as a feature.
- [April 22](#) - Nyanotrasen (Nyano) is formed by Rane. Daemon is the host. I have zero involvement as I believe forking at this early stage to be a waste of time and believe people should be contributing to Wizden to progress it faster. I have zero interaction with Nyanotrasen and have only spoken to Rane and Daemon through contributor chats on Wizden and Daemon was staff on Wizden for a period.
- June 22 - I raise it with PJB in DMs the need for a map maintainer or a PM solely responsible for Yaml and content direction. This is ignored. They later appoint Emissé as the map maintainer despite saying we don't need one and have too many maps? Emissé is great but I have always felt a bit scorned that I wrote the mapping guide and helped so many people get into mapping but it seems Emissé was favored, power to them, but I hope it wasn't favoritism by the project team.
- July 22 - I start Nuclear14 (later to become singularity network) as mentioned because I'm fed up of the PR back and forth and want my own creative control to merge things and enact my vision of gameplay. This is more or less a placeholder and not much work actually gets done on it until later.
- [August 22](#) - Seija, a Wizden admin, is removed from staff. We are given very little info about this but we later learn from leaks they are accused of pedo related stuff. This is one of the catalysts for all drama that ensued after to this day.
- [November 22](#) - Todd Howard, another Wizden game admin is removed from Wizden and banned. Seemingly for being volatile towards Wizden staff. At this time they are

an admin in Nuclear 14 despite the server not actually being up for nearly another year.

- April 23 - Related to the November incident, in now deleted DMs with Freeman which was a Wizden PM at the time, I ask if there is any issues with having Todd Howard on our staff because I'd rather be in the clear and not be dehubbed for having a blacklisted person on staff. They say they will raise it internally and I hear nothing back. Go to November 23 for why this is relevant and August 24.
- April 23 - I continue contributing regularly up until this point.
- April 23 - I message PJB for the second time, explaining that I'm concerned with how the project is being ran and certain people who are being promoted and the lack of community engagement or communication around the promotions. I ask for some transparency on what the project manager (PM) role actually does and express I don't think Moony should be in that position after having driven many contributors away from the project and being a terrible communicator (Add to the fact they were underage when they were on staff and seemingly were kept on because they were a competent coder? Or other reasons? As of writing they were removed from the project?) This message to PJB goes ignored.
- April 23 - Nyano is dehubbed at some point after surpassing 1000 discord members and being the second most popular English server behind Wizden. Details [here](#) and [here](#) from wizden. There's enough stuff in there but from my perspective a lot of the "harassment" (In quotations because I was not involved so I'm just taking peoples word for this, some of it obviously is but let's mention the what first) was in retaliation to Seija being removed from staff and the supposed hypocrisy around that involving Smugleaf. I have personally never said a bad word against smugleaf and have only had good dealings with them, talking about RSledit and Colonial Marines etc and generally through contributing. This is not my drama to discuss, this is my observation from the outside looking in knowing what I know about Seija getting kicked off staff and ultimately quitting the game hard because of the torment they got over it, whether right or wrong again I don't know the full picture so I won't comment.
- August 23 - Nuclear 14 Alpha which is a wave defence mode finally releases.
- November 23 - I receive a DM from MetalGearSloth (MGS) regarding Todd Howard, an ex Wizden game admin and at the time our discord admin lead, telling me why he was removed from staff. This came about because someone realised I hadn't actually been told and it seemed to slip through the net. As far as I could tell this was all just assumptions again with no evidence and was related to Seija which again wasn't exactly communicated effectively. MGS left it at "up to you what you want to do". Due to lack of any actual evidence and just the odd message from a Wizden PM I ignored it as I had a good reason to. I asked for clarification again in August 24 and was told the same thing with no evidence. Todd was later removed from staff in October 24 for an unrelated reason (volatility towards other staff).
- March 24 - I have a few closed PRs here at which point I stop contributing because of the sheer friction of it.

- April 24 - I update the mapping wiki since it's been largely untouched with new features in its entire time existing apart from my update. I still have an open draft to this day which was also opened in April to further improve it, but since I've given so much to the project and received little recognition and quite the opposite, I won't be contributing further without proper recognition.
- July 24 - I message PJB for the third time ever in DMs reporting a Russian fork for violating our licensing and making changes which were not public on the Github. They tell me how to get evidence and so I go and get evidence. They then speak to the server and they supposedly comply which is great. No issues with this whatsoever. In other public channels I discuss license violations (Admin / host / community bus I can't remember) and suggest there should be a mechanical way of enforcing licensing because me having to police it is a ridiculous waste of time. The Russian fork goes back to breaking the license again pretty quick but I can't be bothered to keep chasing it up. They eventually shut the server anyway.
- 22 October 24 - A number of staff realise they have been banned from RMC and their discord. I notice I have been banned too. I reach out to Whisper but get ignored. I reach out to DrSmugLeaf and get ignored, again despite talking periodically with them between April 23 and July 24 on things like contributing and RSI Editor. If there was legitimately an issue then isn't it best to talk about them first or at least make the person aware rather than using enforcement action from your friends (more on that next).
- 01 November 24 - Singularity Network receives its first strike. At the time I had no idea what was going on and the evidence was non-existent. I assume it's because some people in our community started being vocal about being banned from RMC and or trashing Wizden which was against our rules. I discuss it with PJB in DMs to be given no real answers. I was stuck in traffic on my way to work when I read this and was actually taken aback by receiving it and the wording in the message being horrid. Again from all previous conversations with PJB and others I had no idea this was coming. Despite feeling this way I deliberately did not share the screenshots with anyone except our maintainer chat because I knew it would cause even more uproar and trashing. Because of deteriorating relations later on I share this with the staff and some key contributors as they're asking more questions about why we got a strike, and this does cause a lot of emotion towards PJB / Wizden with some people but again this is not made public at this time. I later saw comments about betraying PJBs trust by releasing that DM and to that I have to say A) It was extremely unprofessional and not warranted so people need to see that for themselves to believe it. B) This was an official warning from the project and as such should not be treated as private information. If they want to sprinkle extra abuse into that message that's on them.
- 09 November 24 - I reach out to PJB because of a message they put in the Wizden maintainer chat (see below). I reach out, see below).

- 10 November 24 - There's a mass staff walk out at Wizden by head admins and game staff over the way things are being ran and other reasons. As ex staff I actually still have access to the staff-off-topic channel that this was all first discussed in. I spend a few hours offering constructive comments and trying to get to the bottom of what the actual roles and responsibilities of PMs are, as I've asked many times. I was finalised on writing a massive message on how nobody is to blame and how to find a way forward (I've worked in hundred million pound construction projects for years, I know a thing or two about effective project management), then I was removed by PJB because apparently ex staff are now no longer welcome in the ex staff chat, another disregard for my time and effort in their community. See below, I again open up and offer to help but am met with "be glad I didn't deem it necessary to ban you from the Discord entirely".  
I again ask for evidence and am met with more asshole comments until we finally get to an actual reason which is "Having ODJ on staff", which is in no way related to the strike we received? So we're getting a strike for having ODJ on as a mapping contributor for historic issues they have with him. I again end the string of messages with offers of support and suggestions to improve their community and am told that any apologies and such are not aimed at us.
- 16 December 24 - I received a message from PJB saying to get VMSolidus (VM) to contact them otherwise our servers will be dehubbed. I don't speak for VM and I fail to see how this is a dehubbable offence, without strikes or what rules it breaks? Again misusing power to get what they want from people. I'm told that by being in their discord server that I'm complicit and endorsing their actions. (again, I only go there when I need technical support or the odd time I'm pinged for an opinion. It's also possible for more than one conversation to be going on at once in discord and to not be involved in the others). I again get met with the ultimatum and respond by asking what compensation I get for the torment they have caused me because they fail to seek advice or take it.

At this point I have no reason to believe they will stick to their word and won't just dehub us all anyway at a later date, given we've had strikes and now this over nothing, and despite having no allegiance to Einstein Engines (EE), I would rather get dehubbed for literally not breaking the rules to show the types of people who are running the hub, than step down from an organisation I really don't care about being in. Ultimately this will hurt my community's growth which is negligent, but I think it's something worth standing for. Dehubbing ensues, doesn't seem to affect our numbers too much but will affect our growth. We make our own hub and start making joking names about what to name our new launcher.

At this point I'm very passionate about the damage PJB is doing to the project, but I opt to let it go to focus on making something better from this dumpster fire of a project that I've spent years of my life contributing to. Over the past few months there's been two or three occasions that have bothered me to my core and made me wish I never found this game and tried so hard to make it better or spent countless hundreds of hours contributing to it, and it was all entirely avoidable. That was until now in late January 2025 where I see more misinformation being spread about me from people who have no idea or should know better but choose not to question things. So I felt I needed to set them straight.

Below will be all the evidence to go along with the timeline as well as specific instances of misinformation that I have rebuttals for.


# Evidence

All evidence will be denoted Figure E(x). Since google docs is terrible for image citation / labelling I'll also denote things like DMs differently sometimes for my sanity e.g. Figure E-name-1, starting with PJB since it's the most commonly cited DMs.

Where possible I will omit or redact messages from the other party that may be sensitive or that they might not want shown, but I'm fully open to releasing them all as I've been fully professional and cordial in all correspondence.


## Figure E-PJB-1

Oh discord, you didn't say the start of a budding friendship or something else cheesy.



My first ever message directly to PJB in 2022 asking for Grafana access for logging reasons or something. They give me grafana access, I say thanks then we have no more DM communication till the next evidence.


## Figure E-PJB-2



This message was in relation to a lot of uproar in the cartography channel about the way things were being handled by the project and its representative maintainers.


This is my first time making it plainly clear I'd be interested in helping the project out to a higher degree either as a maintainer for content and maps (yaml and mapping) or as a project manager to help coordinate and communicate. At this point I've likely written the mapping wiki and guided many new mappers as well as probably being in the top 10 contributors at this point for lines of code (due to mapping) as well as volume of PRs doing yaml and sprite porting.

We chat for an hour and I mention all the maps currently in production and some of the issues we have as mappers and ultimately it gets shrugged off as we have too many maps. Not long after this Emisse is appointed as the Mapping Maintainer despite me getting told its not something they want, fine, things change. This chat ends with my message here:

My next direct message to PJB is almost a year later. This is around the time of the Nyano dehubbing.




Not redacting this as I stand by it. I'd have to rack my brain on who was driven away from the project by Moony being terrible at communicating with contributors and very abrasive, but they reminded me of working with Swept in the early days of SS14.

I've since cleared out my DMs but I had a conversation with an old long-time SS14 PM who has since moved on and they also did not agree with this decision and it was hard to find many people who did. It seemed like a clear line of favouritism and really blurred the purpose of having maintainers and project managers separate. Moony was a good coder, I won't deny that so worthy of the maintainer role, but representing your project seemed like a big red flag.

Add to that that Moony was appointed to the staff team while underage which was against the Wizden rules, and they were more than open about this in the staff chat at the time when I was a game admin with them.

My other general concerns are communication. When bringing on lots of new project managers the community and wider team want to know the appointments are sound with sound reasoning and experience (if applicable). It's super jarring taking a break or just coming onto discord and seeing lots of new colourful names of people who now have a big influence on the project and not knowing who they are.

## Figure E-PJB-4



Again another year plus gap between correspondence after that last message went unanswered. This time I raise an AGPL violation for our codebase with PJB. We chatted briefly on the 8th about it briefly on how to prove it. I return on the 23rd of July with evidence and PJB sorts it out with them and says they're considering striking them for breaking the license in the first place.

Not long after the codebase goes back to violating it again and I try to resolve it with the hosts again as I did the first time but ultimately they close the server. I lost interest in bringing this to PJB as I had already made my stance clear at this point in other public places that I don't think I should have to keep an eye on the hub to detect every license violation. Which you'll see used against me in R3 and further which is a misunderstanding on PJBs part.

Here is where the hub strike occurs, again the first message since last communications.



Yes at times I've got pissed off about how things have been ran but that's because I've had a stake in this for years, and the final straw meant I just went and did my own thing, and I try not to get involved in anything unless it harms my community.  
  
I don't have time to be checking in on everyone else when I barely get a day a week as it is to focus on my own community. It was barely a few months ago we had to explicitly add to our rules "No Drama". Only yesterday we reminded people of that, we've timed out staff and removed staff. Not a single thing points towards us being malicious  
  
And agreed. We'll keep on top of it and you shouldn't hear from us again

This is the full communication for that day, as stated elsewhere I received this totally out of the blue and read it while driving to work. At this point do we need to point out the systematic slandering of myself and my community instigated by a small group and parroted by the many. I'd like to ask any of these people so far if any of them have an actual instance where they've interacted with me and got the impression I'm anything I've been accused of? Including all of the old Wizen maintainers and admins I worked with.


## Figure E-PJB-6



For continuity, this is the next message sent with the previous and next messages / dates visible. As you'll notice no messages have been deleted or edited in this chat.

This was my message reaching out to clarify that I don't actually have an issue with Wizden, explaining why I went to do my own thing and ultimately reaching out to tell them I understand how they're feeling and offering some self help advice. I'm really a terrible guy I know.



The day after. Speaks for itself. This is in relation to the mass admin walk out and me still having access to the staff-off-topic channel in Wizden as I'm ex staff and that is allowed. I was offering advice and questioning how things got the way they are, trying to genuinely help and was removed.

Notice how most of my messages go ignored and they remain on the line of hostility. Towards the end we start to get some real truth in the matter (well sort of, still need a list of the communities plural that I've harmed, more on that in the forum rebuttals). But specifically the people they care about. Again plural, I can only assume this whole thing is about RMC but who knows and again, no harassment of any kind there.

Timestamps show this is the next message. PJB leads again with an attack on me. I then get a lesson in human empathy from the person who ignores most of my communications and especially when I've shown above and beyond levels of empathy reaching out to them to help and support on multiple occasions even after getting abusive messages like fuck yourself with a rake or pathetic piece of shit. I guess I'm an idiot for trying.


We then finally get to what I think might be the point of the strike, which is truly bizarre given the reasons given for the strike. As a reminder I've been painted in this conversation and others as some sort of ring leader perpetuating harassment against multiple communities and involved in it myself, and now we get to the fact ODJ at this time was a head mapper in Singularity Network, which as we specifically delineated in our org chart is a contributor role and not a staff role.

ODJ was appointed as head mapper in January 2024 and I can't remember if they lost that role or what during their time with us but they didn't actually start mapping until around July 2024 if discord messages serve. They've had various levels of involvement through our history which I won't deny, but from what I know their main issues are around the Nyano dehub time which again was around April 23. Their actions are their own and I've made it clear the rules apply to everyone so nothing has happened related to Singularity involving them that I know of. As previously stated we removed Todd for being volatile towards another member of staff and ODJ received the same warning to a lesser degree hence retaining their role. As far as I can tell the whole drama is between them and one or two key Wizden staff members, and as previously stated originated from Wizdens handling of dismissing a staff member and onwards.

So to me I categorise things like that as a personal drama between people. Can it evolve to harassment? Of course it can. I don't claim to know all of the facts, but equally because Wizden leadership weren't transparent with the facts and still don't take proper accountability or transparency then you wonder why some people perpetuate what they know? Again, I am not condoning any harassment here, just speaking from what I know. Anyone spreading misinformation or causing drama in my community will be removed. Yes we have had lapses sometimes as every community does, specifically when we get targeted by people and emotions start to run high. But that doesn't stop me from keeping standards and removing things that cross the line. I removed some just today on 01/02/2025 in fact and warned the user.

PJB continues to throw stones at me personally in this conversation and so I point at them to fix their own mess first. Having maintainers and project managers who cause so much stress and hurt for other people and they're allowed to stay, not to mention the people getting out for similar allegations they lay at other people as mentioned at the bottom. I recall in hosting chat when MetalGearSloth said that publicly about Todd and PJB had to tell them to redact the name because it is effectively slander.

Continuation of the conversation.


I make the point again that I'm willing to talk about the issues at hand.

The message I'm referring to I thought was about their health was a message they sent in the maintainer chat below labelled Figure E1. Again, I've tried on many occasions to help over the years to avoid this exact situation from occurring. Maybe it wouldn't have worked but who knows, since I've tried my best to offer support and even in this conversation but no, they have to point out that I'm not worthy of an apology. Now that I don't have access to the staff off topic chat anymore I can't offer the evidence but it was regarding them being stressed.

At the bottom of my main message I reference some past project managers who have left the project for various reasons but it being mismanaged down the toilet is potentially part of that. I spoke with Paul about similar issues in the past and he agreed and I started contributing around the same time as Mirrorcult and felt we always had a similar vibe for ideas on gameplay. They were my head admin when I was there when it first became a thing and I was surprised to see they had left as PM when I came back recently.

Again I offer advice to help them overcome the situation.


My final messages continued on. This is later referenced in RF3 in which this is me being given "a chance to leave with evidence clearly presented and he chose to side with the harasser".

As you can see this is a clearly evidenced message with a choice of leaving. No, in fact this is a threat with zero evidence and a demand to get someone to contact them otherwise there are consequences. I'm not a messenger, I don't speak for EE, I'm not a member of SimpleStation who are the organisation owners of EE.

I have never endorsed anything, just not refuted it again as we have covered in other evidence here. Despite that I actually did forward on the message to VM and the council (so complied but still got dehubbed) and as stated elsewhere I don't respond to threats, so was willing to get dehubbed because of that. Not for being a part of EE.


My last message is a jibe back given this whole conversation history you have now viewed. On two occasions sending horrible messages causing me stress and anxiety and not wishing I never devoted so much of my time and energy to the SS14 community, often at the expense of my own relationships. (My partner loves to tell me that I talk to strangers on the internet and to "get off that game" when I'm coding or something).




1. I was never involved with Nyano and again was staff at Wizards Den at the time, long before you were even involved in this project.
2. My involvement with SSMV was also miniscule. I was interested in the prospect of decentralised auth because I've long been a proponent of decentralisation for a number of reasons not just limited to the wizden auth going down periodically and dooming us all. I had never contributed there and over its lifetime I have advertised my server there but that's about it. I don't know Skye and have had zero dealing with any drama they have been involved with.
3. Name any more drama I've been involved in other than the EE fiasco which again, I have no allegiance to them. They're simply our upstream codebase for two forks and I only chose them for that because of their loadout system. It's not that deep.
4. If PJB wants to send official communications through DM and append them with abusive messages and to quote them, harassment, then I don't think its bad to A) share that message of dehubbing with my team at the highest level, not at game admin level, and later to share it to contributors after they lost all my respect for being abusive. To this day it is still a surprise they sent those messages. PJB has some sort of personal issues with me and I can only speculate why. And you expect me not to share the latter ones to show how utterly horrid they have been to me? The only way to prove it is to show the receipts. A lot of people are still blind to it and wont ask questions.



I then talk about a licensing issue we had which was resolved by PJB. At no point in this picture am I saying it was not resolved or Wizden did not help? What I'm referring to is being told its stupid to try mechanically police license violations and automate detection. This was in July in hostbus. Aka checks and balances. I then talk about some other irrelevant stuff in that picture. This is oniks talking about his personal DMCA for his codebase and nothing to do with me or EE for that matter. It's just coincidental they post it in this chat full of people who may be interested. I couldn't care less. I find DMCA's pretty pointless and I'm extremely jaded about licensing now.



We have barely communicated outside of public channels so calling me affiliated with whatever they get up to is a stretch.

My comments about harbouring two misfits is also a bit of a joke as I’m referring to ODJ and Todd Howard, people who at this point have been pretty quiet in the community and the latter I was still to receive anything about that was evidence.

I then reaffirm that I have no idea what any other community is up to because I have my own community to worry about.

The Emissive evidence on the left is then cut extremely close together that it almost looks like the same conversation, and is so low res it took me ages to read any of the words to find the context, so see that below in Figure 4.3

Again additional context either side of the sliced messages. Parky who is part of simplestation / parkstation is asking VM and Death how far they got on setting up alt infrastructure aka hub or launcher, not sure.

I then say we can spin up a hub anytime, which isn't bad and is what Wizden wanted us to do? I also say we can fork SSMV anytime, but in actual fact I personally don't want to do that work if I don't have to.

I then make the observation on this channel not being private, which then my next message is me confirming I knew it wasn't. I'm not a moderator or admin of the EE discord so I have no idea of knowing what the setup is. Not that it matters.



Oh boy, a juicy one.



### Firstly at Bhijn, where to even start.

- We have never been involved in hostility towards other servers. Some of us have made both public comments on how certain servers administer, which is not “hostility towards other servers”, especially if it's private, and is the sort of stuff every server including Wizden does, public and private.
- “Servers” plural. Please list the servers who we have been hostile towards? It's fairly public; we assume it's RMC and by extension Wizden as you can see from the timeline above. Again, nothing hostile towards their staff specifically, just the way they operate which we disagree with, but that's their prerogative, and it's fine for people to disagree with you.
- Thirdly, if you have an issue with someone, it's good practice to reach out to them and let them know you have an issue. I thought I had a good relationship with a number of people involved including the RMC leads but apparently not.
- I am not responsible for what some of my staff do or say when they play on other servers, see my previous comment, if you have an issue or a suspicion then bring it to me. I have a number of examples of people raising issues with me and taking it extremely seriously to the point of removing a number of previous staff. At the same

time, what happens on your server is up to you to administer and we won't take baseless accusations or peoples personal drama seriously, you can ban them in your place and be done with it. I'm not your police force.

- We're pretty sure we know who your source is. It's not hard to know and we still can't think of anything that they might have "leaked" that could be "harassment" or "hostility". Again, hostility is something public and known. Please show me receipts of hostility. And just to add, see R1. At what point is leaking internal private conversations a breach of trust and at what point do you start applauding a whistleblower? Double standard much?
- Back to my previous point on who it is. Despite it being a breach of trust I'm willing to let it slide on whoever the leaker is provided you're able to provide the actual evidence for us to discuss. Again we're pretty certain of who it is and they still haven't been removed so take that as the assurance. Furthermore, if you simply ask for clarification on a point then you will receive it, rather than assuming the worst of people. Conversation is key.


**Now onto my personal harasser, PJB.**

- Not fun banding around that word is it.
- I am not Frontier, maybe you're confusing me with license violations that Checkraze have brought to you, easy mistake to make I guess but better to think before you speak?
- I did bring license violations to you which you did help resolve. Thank you. The process still wasn't fun however and my comments in the EE chat are not relating to you, but rather to the hostbus discussion as detailed in Figure R3. Not once did I say in that screenshot that you did not help, I'm saying I felt very dismissed when I suggested in hostbus that we attempt to mechanically monitor license violations to make detection easier. But somehow your raw hatred for me makes you jump to a totally off and worse conclusion and call me names yet again? I really need to know at what point you started to dislike me and why, again simply asking for clarification would have got it but we all know what ASS-U-ME does.
- So back to my first point in this section. If we go by your definition of what a harasser is, I have exhibited zero of these tendencies. If you use the American English dictionary definition then the majority of people on the internet are annoying, that doesn't mean I feel harassed everytime I read their messages. If we use the English Law definition as per the cambridge dictionary, both linked below, then I have at no point verbally abused you at least not to the extent and manner that you have to me. <https://dictionary.cambridge.org/dictionary/english/harassment>

And yet still I consider myself able to bury the hatchet, despite the distress you've caused me on a number of occasions. Which I especially don't think you would after this document is released and to be honest I don't see much benefit when I know you'll still hate me.

- I've been mentioned a lot of times in a lot of places over the past year, apparently people like sharing the messages I get sent from prominent figures in the community.
- See Figure R3. I had no idea that CSAM was going to be used in that DMCA request and additionally I was not responsible for the DMCA or involved in any step of that process. I don't even think the DMCA was sent on behalf of the council? It was a DMCA claim between whitedream and Wizards Den for failing to take down licensed materials? Who knows.
- The assumption was to take over wizden too? Really? See above for my perceived reason for the DMCA claim. It isn't to "take down" Wizden and nobody has any intention of "taking over". What a wild claim that would literally be impossible? Yes there's a lot of talk in the EE discord about making an alt launcher and a lot of jokes around what to name it and to be a competitor with the SS14 launcher, but that would be unrelated to the DMCA?
- "Prior actions of his community". Again, useless comment and again if we want to talk about actions of communities then Wizden has its own skeletons.
- Figure R6.1 below shows the first time I was made aware of CSAM in the DMCA, which was a day later(?) The reason for mentioning it seems sound from Oniks though? It's not my DMCA or community so I'm not going to ask questions or assume they're lying? I'm literally not getting involved other than sending a few messages around the subject in the council chat. And pinged multiple times is a stretch. The council was pinged for the first message, then again for this one. So one ping after the CSAM allegation was made. Maybe again if we had a hostbus or similar that actually functioned then we could talk about our issues and resolve them instead of issuing strikes without discussion or resorting to DMCA's. Transparency is key.

Hetzner came back to me regarding my abuse report of Wizden hub - and they've sent out Wizden proper letter to their inbox that they cannot ignore any longer. Abuse report was regarding two things:

- 1) DMCA-d content being hosted by Sunrise and ignored messages regarding disabling it from being accessed, AGPL licensing violations in general.
- 2) CSAM violations regarding underage player-oriented NSFW servers in form of Lust Station (they literally have ad on youtube that is not nsfw tagged and such other stuff)

Github has been also informed of my willingness to continue pursuing action against Sunrise , and because they're in Russia and, basically, out of reach of international/EU law per se - I've requested arbitration on their behalf or extension of the blocking of the content up to a month. Haven't received reply yet but this is a very good precedent anyway.


Hello again Powder (powderuuf on discord). For everyone reading this now, Powder was taken on to Singularity Network as a moderator, which is our trial admin position. They joined our discord on the 07/05/2024 and were later banned from our discord on the 18/05/2024 which we will cover.

They applied for an admin position on the 9th of May which is still public [here](#). In hindsight this was an extremely short time in the community and they should have been told to wait at least a month or two of being active before applying for a staff position, but I recognised they seemed to be very active and passionate about helping and at the time it seemed like a good idea. Do note, our Lead Admin at the time Skorn abstained from the vote due to having previous history with Powder at parkstation. Skorn remained objective and impartial and the remaining admins voted to let Powder join the team. Very quickly they made members of our team feel uncomfortable with the messages they were sending as shown in RF2.1 below until all members who originally voted for them to join the team quickly did a u-turn and didn't want them in the team anymore. Skorn as lead admin was the one to break the news to Powder.

I was on holiday at the time trying to relax on a Beach while simultaneously dealing with Powder who was threatening me in DMs. During this conversation they seem to be fixated on how this affects their reputation, to which I let them know this would all be kept private but they themselves started to share they had been let go and lied to about their assurances coming to Singularity. I reaffirmed this was based on them not bringing drama here which they did, as multiple people had messaged me to detail what they had actually been removed for in other places.




So to summarise this section, if you really do hold evidence of harassment by me or against anyone else then please publicly post it and prove it. Otherwise stop slandering me and my community in public forums over topics you have zero involvement in. You have shared your evidence with others and they also can't see any wrongdoing so at a point just admit you've got it wrong.


None of the things you list apply to either the Nyano dehub or the EE dehub. I could maybe understand "rash decisionmaking" with hindsight, but the fact of the matter is that I believe all decisions ended up in the best interest of the community regardless.

"Best interest of the community". Really? This chain of events has drastically split the community. You can pretend that EE is a minority of people and that they're all horrible so you'll be better off without them, but the effects are much further reaching than that.

Firstly, the Nyano dehubbing scared off just about every SS13 community that was even considering coming over here. Secondly, Goob, Frontier and a selection of other servers make up the majority of the EN speaking servers that aren't Wizden. Your own servers are in disarray due to mismanagement that your head admins felt enough to walk out on, so this large section of the community you are spitting and pissing off will feel less likely to stick around. Remember I was on your side during the nyano dehub. Some of what's gone on is

warranted, but the way it's handled is always absolutely poor and some of the people involved point blank should not be public facing representatives of the project. As I've previously warned.



Parrot the harassment line at me all you want and dehub yourself. SS14 as a project would be better off without official servers is a line I've said before but we know that's not realistic.







Instead of compiling a supposed mountain of evidence, the courteous thing to do and the most productive in a cooperative community would be to raise the concern first thing in a neutral semi public setting like the hostbus, or better yet, tell server owners to attempt to resolve the issues themselves as a first port of call before you get involved.

If the evidence is overwhelming in the first instance and absolute, then sure, issue the strike as the first communication. So immediately those things don't correlate in our instance as you say there's a mountain of evidence. If this was obtained over time by a mole or informant then again, look in the mirror and act first with communication rather than waiting to try and incriminate people more.

In that conversation I explain how we've already taken steps to better ourselves. We held an emergency staff meeting to find out what's going wrong. We got rid of problematic staff and warned others, and we introduced core values to better hold ourselves accountable outside of just having rules and staff etiquette. We tell you this in that chat and you say good. Your


