(STATEMENT ON BACK)

NATURE OF COMPLAINT:

On Friday, July 12, 2024, your affiant reviewed National Center for Missing & Exploited Children (NCMEC) cyber tip number 196072486 through the Internet Crimes Against Children (I.C.A.C.) database. Upon reviewing the assigned case file, your affiant found that the reported content of 18 images was uploaded to MediaLab/KIK.

Per Google, MediaLab, a Santa Monica-based holding company for various internet brands, announced it would acquire Kik Messenger. The app, which had hundreds of millions of users at its peak, allows people to chat anonymously and is particularly popular with teenagers.

On July 3, 2024 MediaLab/KIK reported to NCMEC that a user uploaded apparent child pornography. MediaLab/KIK provided a date of incident as June 29, 2024. MediaLab/KIK also provided the IP address used to make the uploads. MediaLab/KIK provided an IP address of 73.205.124.158 for 18 uploads. The photos were uploaded from June 8, 2024 at 04:01:47 UTC through June 29, 2024 at 00:31:30 UTC.

The photos were provided to your affiant for first-hand viewing. Upon personally viewing the uploaded content, your affiant determined that the photos depicted child pornography. The following is a description of the photos:

- **File name: 910e4fe8-4809-4a41-a434-346ac711546e.mp4-** is a video that is 21 second long and does not have audio. The video is of a prepubescent female that is approximately 14 to 16 years-old. The prepubescent female has brown hair, wearing a necklace around her neck. The prepubescent female is laying back on a bed. The prepubescent female has her legs spread, is fully nude, exposing her nude vagina, anus, and breasts. The prepubescent female is stimulating her vagina with her left hand while her right hand is stimulating the nipples of her breasts.
- **File name: 329f200a-cc4e-4513-99a1-86c68daad293.mp4-** is a video that is one minutes and 36 seconds and has audio. The prepubescent female is approximately four to eight years-old. The video is of a prepubescent female that has brown hair that is tied in a pony-tail, and is wearing a white shirt. The prepubescent female appears to be sleeping in a bed and has a white blanket up to her neck, exposing her head. Standing above her is an adult male that is nude from the waist down exposing his penis and testicles. The adult male is masturbating over the prepubescent female as she sleeps. The adult male ejaculates semen onto the prepubescent females face. The semen travels down her face onto her lips. The female starts to awake and wipe the semen from her lips with the white blanket. The video then stops.
- **File name: dd184f43-aa8d-4c2b-983b-ab869d44263c.mp4-** is a video that is six seconds in length and does not have audio. The video is of a prepubescent female that is approximately six to ten years old. The prepubescent female is wearing a

blue shirt and has brown hair. An adult female is next to the child exposing her right breast. The prepubescent female puts her mouth on the adult's breast.

- **File name: 792c85ab-5ffe-4c60-8b98-106257481adc.mp4-** is a video that is 50 seconds in length and has audio. There are two prepubescent females in the video; one prepubescent female is approximately six to eight years old and the second prepubescent female is approximately 14 to 16 years old. The six- to eight-year-old prepubescent female is wearing a pink shirt and has brown hair that is tied into a pony-tail. The 14- to 16-year-old prepubescent female is nude from the neck down, exposing her breasts. The 14- to 16-year-old female has brown hair. Both of the females are kissing on the lips. Both females utilized both of their tongues to conduct a "licking" motion onto each other's tongues. The six- to eight-year-old female grabbed both of the 14- to 16-year-old females breasts then continued to kiss.
- **File name: 3b521c2a-22bc-46fb-8256-b66e2e9c4264.mp4-** is a video that is 35 seconds long and has audio. The prepubescent female is approximately six to eight years old. The prepubescent female has purple/brown hair. The prepubescent female is sitting on a bed with her legs spread. The prepubescent female is completely nude and has her nude anus, vagina, and breasts exposed. The prepubescent female is stimulating her vagina with the fingers of her right hand then inserts her finger of right hand into her anus. This video was uploaded twice and has the same file name.
- **File name: ccbe718a-c44d-4c93-98b1-8d9637230d23.mp4-** is a video that is 14 seconds and has audio. The prepubescent female is approximately six to eight years old. The prepubescent female has brown hair, wearing a black sports bra and a plaid skirt. The prepubescent is on the floor on resting on her knees and arms for support. The prepubescent female then turned away from the camera, and starts to crawl away. As the prepubescent female crawls away, her nude buttock, anus, and vagina is exposed.
- **File name: a4f4c7b6-6eea-4c0b-9c79-fc303576acca.mp4-** is a video that is 56 seconds and has audio. The prepubescent male is approximately four to six years old. The prepubescent male's face is not shown and is nude from the waist down exposing his erect penis and testicles. A female's hand is observed masturbating the prepubescent's erect penis.
- **File name: cbaaad99-8d5b-4dcf-949e-2c8eabd6294b.mp4-** is a video. The video showed a female potentially underage. The female is observed showing the camera her buttock and make her buttock jiggle. Due to not being able to observe the females face or pubic region, it is unknown the age the female may be.
- **File name: ccd296ac-be8d-4076-ae9f-6216177c2505.mp4-** is a video that is 20 seconds and has audio. The prepubescent female is approximately 12 and 14 years old. The prepubescent female has brown hair and is laying on a couch. The prepubescent female is completely nude. The prepubescent female has her legs spread exposing her nude vagina, anus, and breasts. The prepubescent female has

a white fluid that is on her pubic and inside of her vagina. The fluid appears to be male semen.

- **File name: d050d3e8-ccd8-40c5-9394-27f5257ebaba.mp4-** is a video that is 40 seconds and has audio. The video starts out as normal non pornographic video. At 11 seconds in the video, it switches to a prepubescent male and prepubescent female. The prepubescent female is approximately 14-16 years old. The prepubescent male is approximately eight to ten years old. The female is nude from the waist down exposing her buttock and pubic area. The prepubescent male is nude from the waist down exposing his penis. The male and female are standing facing each other. The male is making a back-and-forth motion in the female's pubic area. The female turned around and now has her buttock in the male's pubic area. The male is making a back-and-forth motion. The female goes down onto both of her knees and performs oral sex on the male's penis.
- **File name: dec4117b-db9c-424a-8f24-5146184a5c42.mp4-** is a video that is 20 seconds long and has audio. The prepubescent female is approximately 12 to 14 years old. The prepubescent female has brown hair and is wearing a white sweater. The prepubescent female is laying on a bed with her legs in the air exposing her nude vagina. An adult male is nude from the waist down has his nude penis inserted into the prepubescent female's vagina. The adult male inserts his penis repeatedly into the prepubescent female's vagina.
- **File name: 2d968e56-3487-4acc-bfef-c98b9e110b6c.mp4-** is a video that is 44 seconds and has audio. The prepubescent female is approximately 14 to 16 years old. The prepubescent female is lying on a bed on her back. The prepubescent female is completely nude with her legs spread exposing her nude vagina, anus, and breasts. An adult male is standing on the floor in between the prepubescent female's legs. The adult male is completely nude exposing his penis and testicles. The adult male's penis is inserted into the prepubescent female's vagina and is inserting his penis rapidly. The prepubescent female is stimulating her clitoris with the fingers of her right hand. The adult male exits the prepubescent female's vagina and she is left lying on the bed. The prepubescent female sits up on the bed while the male is standing next to her with his penis and testicles exposed. The prepubescent female masturbates the male's penis with her right hand then conducts oral sex on the male's penis.
- **File name: 69ae9c61-cc00-402b-a3bc-e81836249c0f.mp4-** is a video that is 27 seconds long and has audio. The prepubescent female is approximately 10 to 12 years old. The prepubescent female appears to be in a closed room. The prepubescent female has brown hair, braces, and is wearing a black hooded jacket and black/pink short. The prepubescent female appears to be talking to the camera and is heard saying "I will make it up later, I promise. For now, I can't do a whole lot, cause I feel like I'm ready to just fall." The prepubescent female then steps back from the camera and raises her black hooded jacket, showing her breasts that are covered by a black bra. The prepubescent female then states "I hate this bra, anyway." The prepubescent female uses both of her arms/hands to reach around her torso. The prepubescent females take her bra off and exposes both of her breasts.

- **File name: 9a6d253e-5382-41ca-8a14-efdf41a1d7bd.mp4-** is a video that is 15 seconds and has audio. The prepubescent female is approximately 10 to 14 years old. The prepubescent female is lying back on a bed. The prepubescent female is completely nude. The prepubescent female has her nude vagina, anus, and breasts exposed. The prepubescent female has a hair brush inserted into her vagina and is re-inserting the hair brush into her vagina rapidly. The prepubescent female stimulates her right breast with her right hand.
- **File name: 81907366-0d95-4314-9dd1-41b50adfb8cf.mp4-** is a video that is 33 seconds and has audio. The prepubescent male is approximately six to eight years old. The prepubescent male is standing and is nude from the waist down exposing his penis and testicles. An adult female is sitting down on her bent knees and is facing the prepubescent male's pubic area. The adult female is nude from the waist up and has her breasts exposed. The adult female is performing oral sex on the prepubescent male's penis. The adult female stops giving oral sex then starts to use her tongue to lick the prepubescent male's penis and testicles. The adult female then proceeds to go back and give the prepubescent male oral sex.
- **File name: bf5d01d9-ff5b-4f7f-9617-a23ec2f18e14.mp4-** is a video that is 27 second and has audio. The prepubescent female is approximately six to eight years old. The prepubescent female has brown hair and is kneeling on a bed. The prepubescent female is completely nude. The prepubescent female is underneath a male dog that is erect. The prepubescent female is conducting oral sex on the dog's penis.
- **File name: 321d1cc7-d935-4926-a5a8-a6c74e26dd69.mp4-** is a video that is 37 seconds and has audio. The prepubescent female is approximately 10 to 14 years old. The prepubescent female is completely nude and is laying on a bed. The prepubescent female's breast, buttock, and pubic area is exposed. The prepubescent female is lying in between an adult male's legs. The adult male is nude from the waist down with his penis and testicles exposed. The prepubescent female is performing oral sex on the adult male's penis. The prepubescent female stops performing oral sex and masturbates the adult males penis with her left hand.

On Friday, July 19, 2024, your affiant received a legal return from Comcast Cable, which provided the following address: 1511 38th Avenue, Vero Beach FL.

On Monday, July 22, 2024, your affiant advised Detective McKenzie to respond to the address to conduct surveillance. During this time, Detective McKenzie utilized his agency issued smart phone to check the WIFI service in the area and found that they were all locked.

Your affiant received a notification from NCMEC regarding a potential secondary cyber tip that may be linked. Your affiant reviewed the cyber tip, cyber tip number 196596578. Inside of the cyber tip, your affiant located the email address of yodedi8181@nolanzip.com, a username of clickclockticktock, and an IP address of 73.205.124.158. This IP address is the same as the first cyber tip. The cyber tip gave an

incident time/date of 07/06/2024 at 05:35:06 UTC hours. The cyber tip was reported by NCMEC at a date and time of 07/17/2024 at 23:59:35 UTC hours.

The cyber tip received advised that 14 images were uploaded to MediaLab/KIK. The photos were provided to your affiant for first-hand viewing. Upon personally viewing the uploaded content, your affiant determined that the photos and videos depicted child pornography.

On Friday, July 26, 2024, at approximately 0650 hours, the Indian River County Sheriff's Office Criminal Investigation Division and members of the Special Weapons and Tactics Team executed an ICAC search warrant at 1511 38th Avenue, Vero Beach, FL. Paula Mccorkle, Phillip Mccorkle, and Michael Mccorkle were located at the residence. Det. McKenzie read the search warrant to all parties. Your affiant read all parties there Miranda Warning.

Your affiant spoke with Phillip. Your affiant questioned Phillip if he remembered his Miranda Warning your affiant read him; Phillip agreed. Your affiant informed Phillip again why your affiant was at his residence. Your affiant informed Phillip that the cyber tip gave an app that was used, which was MediaLab/KIK messenger. Your affiant questioned Phillip if he watches pornographic material. Phillip agreed and advised that he has used KIK in the past. Phillip advised that he is a part of some groups that post anything that you want; the posts have consisted of bestiality, and incest. Phillip identified his cellphone being a black Samsung and informed me of his passcode. Phillip identified his computer in his room and also gave me the passcode to it as well. Phillip advised he had an old computer also and gave me a potential passcode to it. I advised Phillip that the Sheriff's Office is going to search through all of the devices. Phillip advised your affiant that we will find a material that he identified as "Lolicon." Phillip described "Lolicon" to be drawings of "young girls". Your affiant knows "Lolicon" to be a genre of fictional media which focuses on young- or young-looking girl characters, particularly in a sexually suggestive or erotic manner. Your affiant asked if the "young girls" is under the age of 18. Phillip agreed. Phillip advised that all of it is drawn and that none of it is real photographs or videos. Phillip advised he has used KIK in the past on his phone and he advised that he has observed child pornographic material but has not downloaded it. Phillip advised that he "traded once". Phillip advised in one of the groups he was involved in, "stuff" was getting posted and someone asked him to "trade for something". Phillip advised that he used something that was posted in the chat already to trade to the other individual. Your affiant asked Phillip what was being traded; Phillip advised that it was a child pornographic video. Your affiant requested Phillip to describe the video. Phillip described the video to be a female and a male. Phillip advised the female was underage and she was conducting oral sex. Phillip advised the male and female were on a bed and she was performing oral sex. Your affiant asked if the female was laying on the bed or in between the male's legs. Phillip advised that she was in between the male's legs. Your affiant asked what race the female was; Phillip advised she was Hispanic. Lt. Pierce asked Phillip how long ago did the trade occur. Phillip advised it was maybe two or three weeks ago. Your affiant asked if there was anything else Phillip wanted to inform your affiant. Phillip advised besides the KIK trade, "which I know I shouldn't of done".

Through the interview with Phillip and him describing the video that he "traded" for, your affiant knows that the video he described was one of the videos that was flagged by

MediaLab/KIK, the video is identified as file name: 321d1cc7-d935-4926-a5a8-a6c74e26dd69.mp4.

The following items were located and seized from inside of the residence:

Items located in the north west bedroom labeled bedroom D:

- (1) HP all in one computer with mouse, keyboard, and power cord, SN: 8CC6040LYD, located by Det. Manace, labeled as 1
- (1) Lenovo all in one computer with mouse, keyboard, and power cord, SN: 30J517D09, located by Det. Manace, labeled as 2
- (1) Black Samsung cellphone with power cord, IMEI: 350091127462575, located by Det. Manace, labeled as 3
- (1) Seagate hard drive with cord, SN: NJ0DB7WA, located by Det. Manace, labeled as 4
- (1) Black LG cellphone with power cord, located by Det. Manace, labeled as 5.

During a forensic review of Phillip's Lenovo computer, the following images/videos of generated child pornography were located. Each image/video is a generated animated representation of prepubescent children engaged in sexual activity. Some of the images/video depict life-like representations while others are more game like graphics.

1. **File name: 261454abc019fe05.jpg** – is a photo depicting an animated representation of a prepubescent female child lying on her back fully nude with her breast exposed as the animated representation of an adult male is inserting his penis into the child's vagina.
2. **File name: 6153459 - bakanimator cosplay Marvel Resident_Evil Resident_Evil_2 Resident_Evil.jpg** – is a photo depicting an animated representation of a prepubescent female child standing fully clothed as the animated representation of an adult male fully nude stands behind the child, with his erect penis between the child's leg, the animated representation of an adult male is ejaculating.
3. **File name: sample-3a34eddd0db0ef1693e376782fe696c6.jpg** – is a photo depicting the animated representation of two prepubescent female children, the photo shows the animated representation of an adult male with his penis in the both female's vaginas. At the bottom of the photo the two animated representation of the female children, and knelling with their breast exposed covered in semen.
4. **File name: sample-c58905bfa4f25857842cd93eea99cf5d.jpg** – is a photo depicting the animated representation of a prepubescent male child with his penis exposed. The child is being held by the animated representation of an adult male as the adult male inserts his penis into the animated representation of a prepubescent child's anus.
5. **File name: a5e71ef4dac0ee93 (1).jpg** – is a photo depicting the animated representation of a nude infant female lying on a nude prepubescent female child

as the representation of a nude adult male inserts his penis in the animated representation of the infant child's vagina.

6. **File name: sample-bc851bf657ae4ece14c4da02893c910a.jpg** – is a photo with four drawings, one in each corner. They are depicting the animated representation of a prepubescent female child in the nude, with the animated representation of a nude adult male. The child is depicted in one image with the adult male's penis in her mouth. In another image the animated representation of a prepubescent child is depicted engaging in sexual intercourse with the adult male, with his penis in the child's vagina.
7. **File Name: 1c3d3c176cf81326796182b81bdc042b.webm** – is a video approximately six minutes and eight seconds in length. The video depicts an animated representation of a prepubescent child in the nude lying on her back, with her breast and vagina exposed. As the video plays the text appears which reads "I was stripped down to my underwear and stripped naked.... The teacher is really like a monkey.... Every time he sees a child, you get an erection and lusts... Don't you have any morals as an adult." During this time an animated image of an adult male comes into frame holding the child by the waist with his erect penis over the child's vagina and abdomen. At 00:50 seconds on the video the text reads "You're making child pornography and distributing it, all over the world so that I can be used as masturbation material for bad adults." As the video continues, the male inserts his penis into the prepubescent child's vagina and engages in sex with the child until the adult male ejaculates on the child body.
8. **File name: 6e06ad532f9c74d84e3a83e6920f90e7.mp4** – is a video approximately eleven minutes and fifty seconds in length. The video depicts an animated representation of a prepubescent child approximately 6 to 10 years of age, the child is shown in the nude in a public bath house. As the video continues an adult male is shown in the nude seated behind the child, with an erect penis masturbating until he ejaculates on the child's back. The male then touches the prepubescent child's exposed breast and vagina, and inserting his finger into the prepubescent child's anus. The video cuts to the prepubescent child performing oral sex on the male's erect penis. As the video continues the prepubescent child is held down by multiple males, and an adult inserts his penis into the child's vagina, engaging in sex until he ejaculates in child vagina. The video continues as multiple males engage in sexual acts with the child.
9. **File name: 1f0eda6a9c8669a2902888ea3262a1d6.mp4** – is a video approximately seventeen minutes and thirty-seven seconds in length. At approximately 01:05 on the video an animated representation of a male who enters the room of a prepubescent child, the male is depicted holding the child down by force and placing his mouth on the child nude breast, as the child attempts to push his face away. The video continues as the adult male exposes his erect penis and forced his penis in to the prepubescent child's mouth. The

male continues to force his penis in the child's mouth, until he ejaculates inside the child's mouth as she cries. The male then forcible holds the child down and inserts his penis into the child's vagina. The video continues depicting three more sexual encounters between the male and the prepubescent child.

10. **File name: 7d41f75c3f86f904c534c33f92fd0c58.mp4** – is a video approximately fifteen seconds in length. The video depicts two animated representations of prepubescent female children, twins sanding in a forest fully clothed. The video cuts then one of the prepubescent female children is in the nude being held by a male around the chest as the male inserts his penis into the child vagina, engaging in sex with the child.
11. **File name: 9faa7969fbc268946c4a42ac0c7b0ed6.png** – is a photo which depicts a animated representation of a prepubescent child in the nude exposing her breast and vagina. There is text around the photo which reads “Careful pedo” “I’m fucking for two” “Jeez you’re hopeless” “Fuckin’ pedophile” “It’s not enough that I’m a kid but pregnant, too”
12. **File name: post-video-33708076.mp4** – is a video with audio which depicts an animated representation of an infant female child in the nude, with her breast and vagina exposed, lying in a crib. As the video continues the male is manually stimulating the child vagina with her thumb as the child is lying on her back, this continues until the male is seen standing with his penis exposed to the child. The male then inserts his penis into the child vagina and engages in sexual intercourse with the child. At approximately 02:27 in the video the image cuts to a second child, the prepubescent child is lying face down in the nude. The video then cuts to the male inserting his penis into the child anus, and having anal sex with the child until he ejaculates into the child's anus.
13. **File name: post-video-33092011.mp4** – is a video 3:17 in length with audio which depicts an animated representation of an infant female child that is completely nude. The child is laying on top of a second infant child that is also completely nude. A depicted adult male is nude with an erect penis rubbing against the infant's vagina. After several seconds into the video the adult fully inserts the penis into the infant's vagina and engages in sexual intercourse. The adult continues with intercourse until then end when white ejaculate is seen coming out of the infant's vagina. The infant's stomach expands with the amount of ejaculate.
14. **File name: post-video-elR0gwJnkrq.webm** – is a video 3:05 in lengths with audio. The video depicts an animated representation of a prepubescent female that is approximately 8-10 years old in a classroom setting. The child starts off clothed but soon has no shirt on exposing both nipples. An adult size hand is seen rubbing the child's nipples and placing a finger in her mouth. The video continues to depict the child holding and stroking an adult male's erect penis. The video then

jumps to the male sitting and the child inserting erect penis into her mouth. The video jumps to the child completely nude laying back on a desk. The male is inserting his penis into her vagina engaging in sexual intercourse with the child. At the end of the video there is white/clear ejaculate coming out of the child's vagina.

15. **File name: post-video-k3R93NnmwaG.mp4** – is a video 1:52 in length with audio. The video depicts an animated representation of a prepubescent female that is approximately 8 to 10 years old. The female is nude with exposed genitals. The first scene depicts an adult male standing over the prepubescent female with his erect penis inserted into the vagina. The male engages in sexual intercourse with the child. The second scene shows the same child sitting on top of the male again engaged in sexual intercourse. The male's erect penis is inserted into the child's vagina. The next scene shows the child bend over with the male standing behind her. The male continues to engage in sexual intercourse with the child as she moans. At the end, the male removes the penis and white/clear ejaculate is seen on the tip.
16. **File name: Lesson1-1.mp4** – is a video 2:43 in length with audio. The video depicts an animated representation of a prepubescent female that is approximately 6 to 8 years old. The child is sitting in a chair drinking from a cup. An adult male walk up behind the child. The next scene shows the child stroking a blurred erect penis with both hands. The male puts a hand on the child's head and the child inserts the penis into her mouth as she continues to stroke it. The child continues to push the penis into her mouth until the end of the video where white/clear ejaculate can be seen coming out of her mouth. The male uses both hands to forcefully pull her head into the erect penis.
17. **File name: Lesson1-2.mp4** – is a video 4:01 in length. The video depicts an animated representation of a prepubescent female that is approximately 6 to 8 years old. The child is sitting on an adult male's lap wearing a dress and underwear. The male has his hand underneath the child's underwear and is rubbing her vagina. The next scene shows the male inserting a finger into the child's vagina as he continues to rub her vagina. The next scene shows the child completely nude bent over with the male thrusting into her from behind. The video jumps to male's penis inserted into the child's vagina engaged in sexual intercourse. The next scene shows the male on top of the child again with the penis inserted into the vagina engaged in sexual intercourse. The last scene shows the child again bent over with the male standing behind her. The male engages in sexual intercourse with the child until the end of the video. Tears can be seen in the child's eyes.
18. **File name: post-video-8JaGbK43AML.mp4** – is a video 14 seconds in length. The video depicts an animated representation of a prepubescent female that is approximately 10-13 years old. The female's nipples are exposed as well as her

vagina. An erect penis is inserted into the female's vagina engaged in sexual intercourse.


19. **File Name: post-video-9PMwkqqXwMB.webm** – is a video 10 seconds in length with audio. The video depicts an animated representation of a prepubescent female that is approximately 8 to 10 years old. The female is nude and being held up by an adult male. The male's erect penis is inserted in to the child's vagina engaged in sexual intercourse.
20. **File Name: post-video-26MP5Wz8DaK.mp4** – is a video 36:23 in length with audio. The video depicts multiple scenes of an animated representation of a prepubescent female that is approximately 10 to 12 years old. The following is a summary of each scene during the 36-minute videos. The child enters a room with an adult male. The child is forcibly bend over a couch and dress pulled down. The male inserts a finger into the child's anus and then inserts his erect penis into the child's vagina engaged in sexual intercourse. The male ejaculates in the child's vagina. The next scene shows the child nude with the male standing over top of her. The male attempts to insert his penis into her mouth but she resists him. The male slaps the child and then holds her nose closed to force her to open her mouth. The male ejaculates into her mouth. The next scene depicts the nude female sitting on the nude male. The male inserts his penis into the child and engages in sexual intercourse. During intercourse the male holds his hand around the child's neck until she appears to pass out. The male carries the female to the bed and again engages in sexual intercourse with the female. The next scene depicts the nude child kneeling down in front of the male as she strokes his erect penis. The next scene depicts the child tied up with a blindfold and gag in her mouth. The male entices the child with food but makes her manually stimulate his penis before she eats. The male uses a pill to drug the child before engaging in sexual intercourse again. The next scene depicts the child masturbating on the couch in front of the male. The next scene shows the male engaging in sexual intercourse with the child on the couch until he ejaculates in her vagina. Several more scenes depict the child masturbating with her fingers and objects (TV Remote). The screen depicts, "New meat for sale Trained/Willing Trusted buyers only (btc.eth)." The next scene shows both the male and female nude on the couch. The female inserts the male's penis into her mouth before engaging in sexual intercourse. Needles and pink pills can be seen on the table next to the child. The next scene shows the male placing a pink pill on the child's tongue. The child appears drugged in the next scene as she masturbates. The male inserts a sex toy into the child's anus before engaging in sexual intercourse and ejaculating into the child's vagina. The screen depicts, "Anal Cherry 4sale Trained! Eth.BTC sher_buy@protinmail.com." The next scene shows the child wearing lingerie and a necklace that states, "Slut." The male brings an older male into the bedroom with him. The older male engages in sexual intercourse with the child. The older male ejaculates into the child's anus. The original male then engages in sexual intercourse with the child. During the intercourse the child uses a pink straw to inhale (Snort) a white powdery substance (Representation of a

narcotic – Cocaine). After the male ejaculates he takes a photo and uploads it to a text chat. The next scene shows an adult female entering the room with the child. The female gets into bed with the child and engages in sexual activity using a sex toy on the child.

31 minutes into the video the subjects change to a different representation of an adult male and prepubescent female. This part of the video shows a prepubescent female that is approximately 8- to 10-year-old female engaged in sexual intercourse with the adult male. The male's penis is inserted into the child's mouth and he inserts his finger into her vagina. The male inserts his erect penis into the child's vagina and engages in sexual intercourse for the remainder of the video. The male ejaculates into the child's vagina. The next scene shows zombies and the adult male sitting a desk. The child is kneeling underneath the desk with the male's penis inserted into her mouth. This concludes the 36:23 video.

Based on the above observations, your affiant believes there is probable cause for Phillip Michael McCorkle for violating FSS 847.011(2), Prohibition of certain acts in connection with obscene materials – Possession without intent to sell (20 Counts).
