PUBLIC RECORDS REQUESTS – INFORMATION SHEET

A request for a copy of a case-related document is considered a request made pursuant to the provisions of the Wisconsin Public Records Law. Wis. Stat. §§19.31-39.

Due to the type of information that is often included in court documents, the Milwaukee Municipal Court must review the document and redact any information that cannot be released as part of a public records request.

Based on that review, the following information may have been redacted from the copy of the document you received:

- Personal identifying information¹ as defined by the Driver's Privacy Protection Act (DPPA), including:
 - Social Security Number (SSN)
 - Driver's license (DL) number
 - Defendant address (except ZIP code, which is disclosable)
 - Defendant telephone number
- Defendant day of birth (not month/year of birth, which is disclosable)
- Medical/disability information
- Witness/victim information

Should you have any questions, concerns or need additional explanation as to the type of information that has been redacted and/or the legal basis for the redaction, please contact the Milwaukee Municipal Court Records Custodian.

¹Please note that the DPPA identifies certain exceptions for specific permitted uses of personal identifying information. If you believe your request may qualify as one of the specific permitted uses, please request a Public Records Request – DPPA Exemption Form. The form may then be completed and submitted to the Court for further review of your request.
