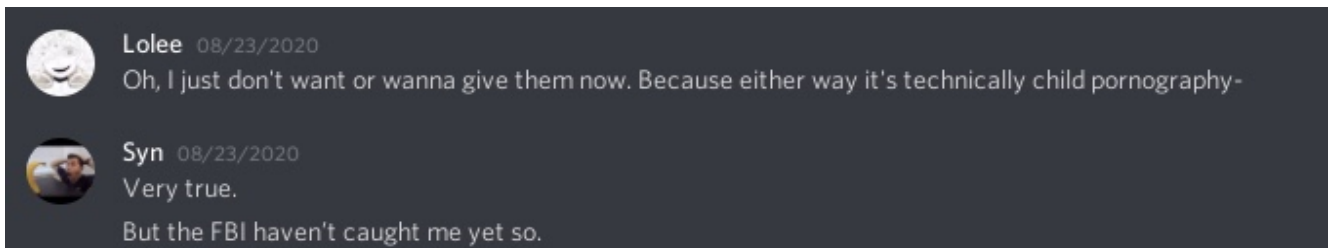


# Schlep is a Fraud

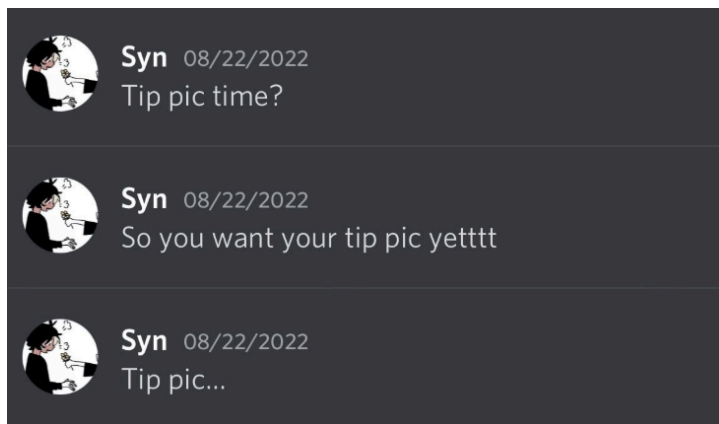
## Schlep associating with a CSAM solicitor

AceTheNarrator is currently working with, and employed by Schlep to be a voice actor for his channel. Schlep is aware of the ongoing allegations against Ace such as child porn distribution and solicitation as well as AceTheNarrator having **allegedly sexually engaged with a 13 year old girl when he was 16**. Schlep was made aware of this as of August 2025, yet as late as [December 10th 2025](#), Schlep was still seen having AceTheNarrator added on discord, while also following him on Twitter. Schlep defended Ace by claiming that people are spreading 'lies' against him.

Even more examples of Syn [Ace] acting extremely sexual towards numerous girls and even pressuring them to engage sexually with him on camera for his own gratification. Many were extremely uncomfortable and felt forced to oblige. Keep in mind regardless of age, this is illegal and a repeat pattern of behaviour that lasted for numerous years, this is made even more concerning with the **multiple examples of large age gaps** being present between Ace and these girls.

# Schlep defending AceTheNarrator

Despite knowing about these allegations for several months, [earliest instance being August 2025], **Schlep continues to associate with, work with and employ AceTheNarrator**. Schlep has attempted to defend Ace's behaviour by either claiming the situation is a lie with no evidence, or once again attempting to claim Ace was a minor when this took place, so therefore it is excusable. This is ironic considering the fact he claimed what CallMeCarson did was illegal when he solicited nudes from a 17 year old when he was 19, yet HE continues to work with a serial child porn solicitor openly who has numerous victims.



Schlep is seen messaging Parlo on 26th August 2025 claiming if he heard anything about AceTheNarrator being 'weird', this proves he was aware of the allegations 4-5 months ago, as of the creation of this document [Jan 3rd 2026].

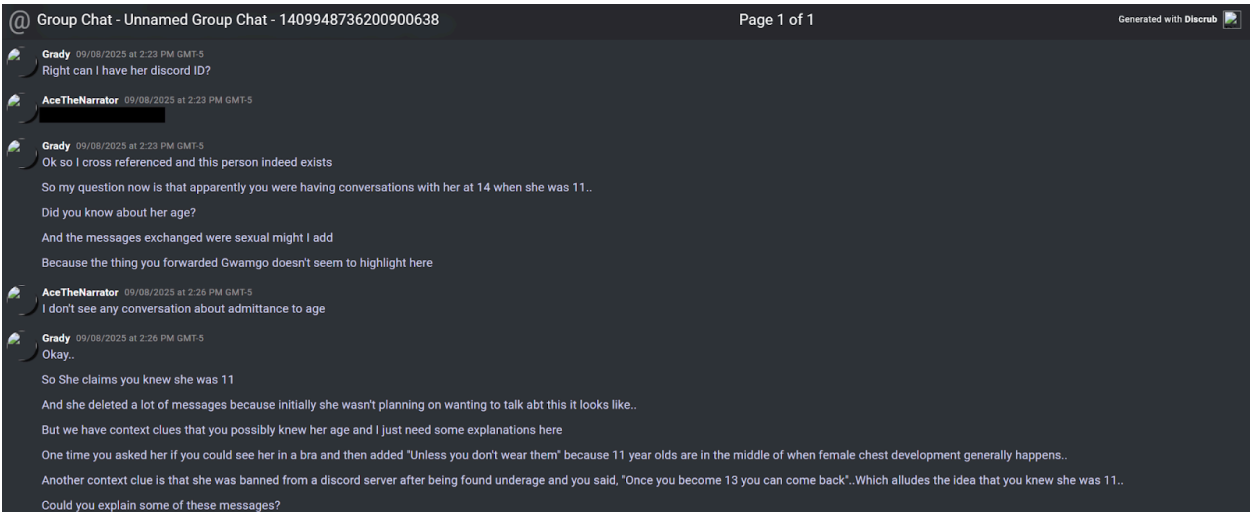
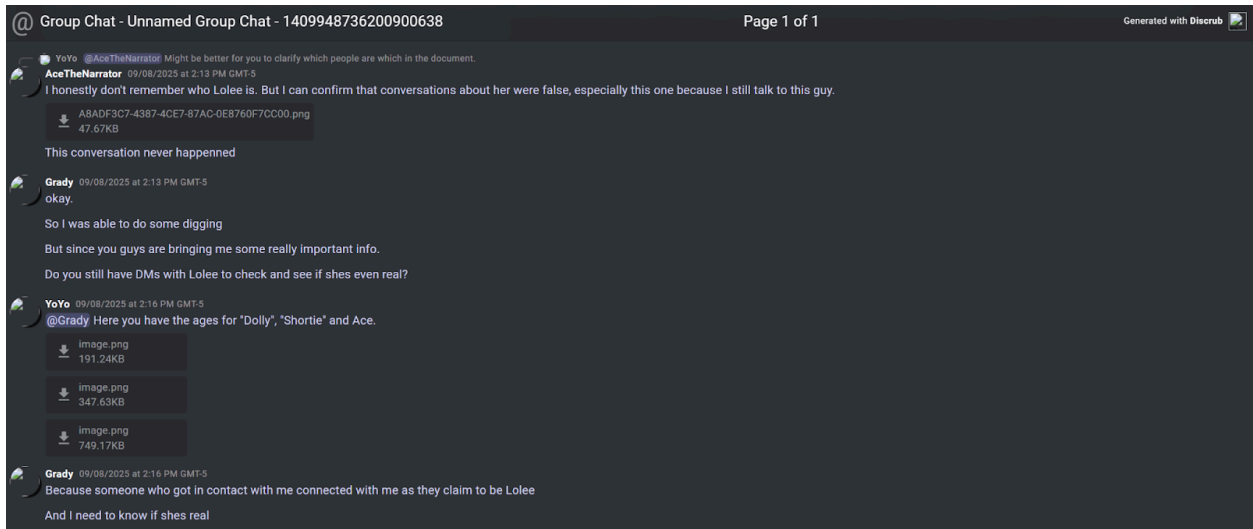
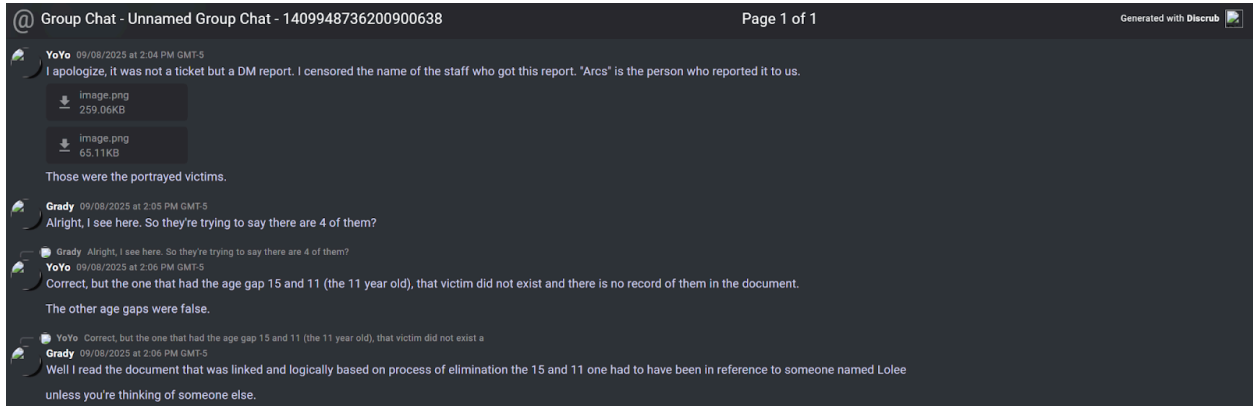


This GC was created on August 26th 2025, in which AceTheNarrator and his associates attempted to reach out to Gwamgo to 'clear' their allegations. **Schlep was present in this GC.**



A user named Grady was added by Gwamgo, in which he confronts AceTheNarrator on his interactions with a user named Lolee.

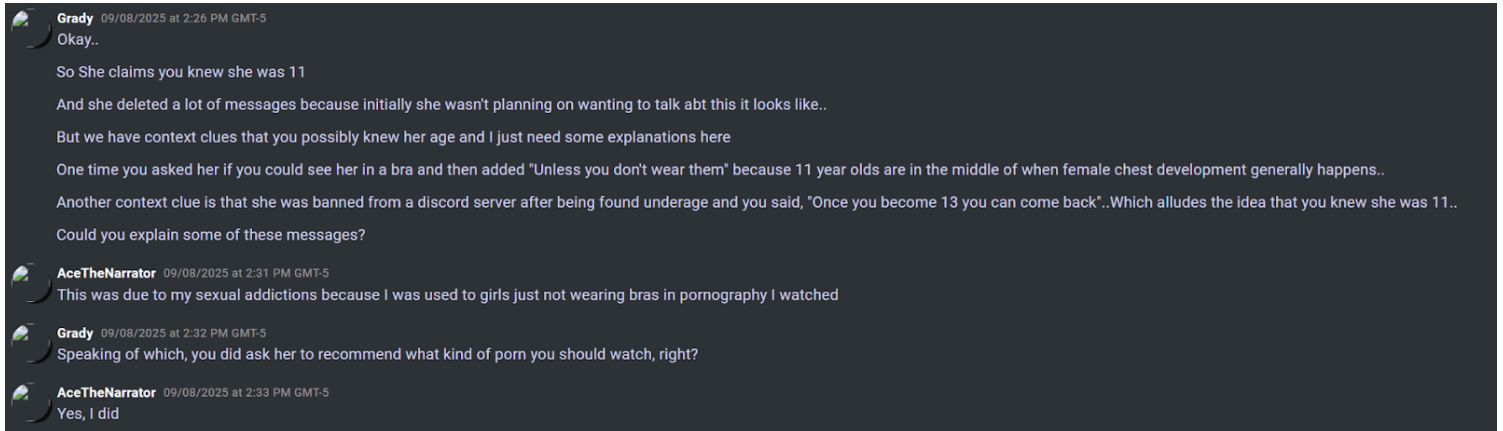

Grady was seen consulting AceTheNarrator on his interactions with the user named Lolee. **Confirming the fact that they did in fact have contact with one-another in 2020. It was also established that all of Lolee's messages were deleted on her end.**

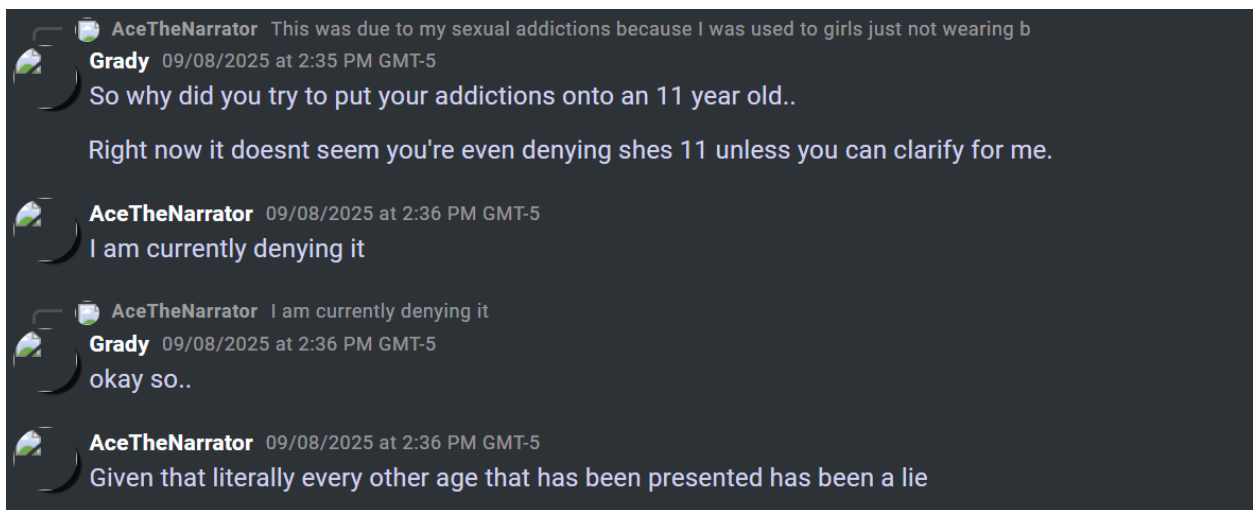
Grady reiterates that Lolee claimed AceTheNarrator knew she was 11 during their sexual messages.

AceTheNarrator is seen **not denying** that he asked to see Lolee in a bra, however stated in response “unless you don’t wear them”.

AceTheNarrator also **does not deny** the fact *he knew Lolee was below the age of 13* during their messages, as she was banned from his server for being underage.

AceTheNarrator also **confirms that he did ask Lolee for porn to recommend him to watch.**

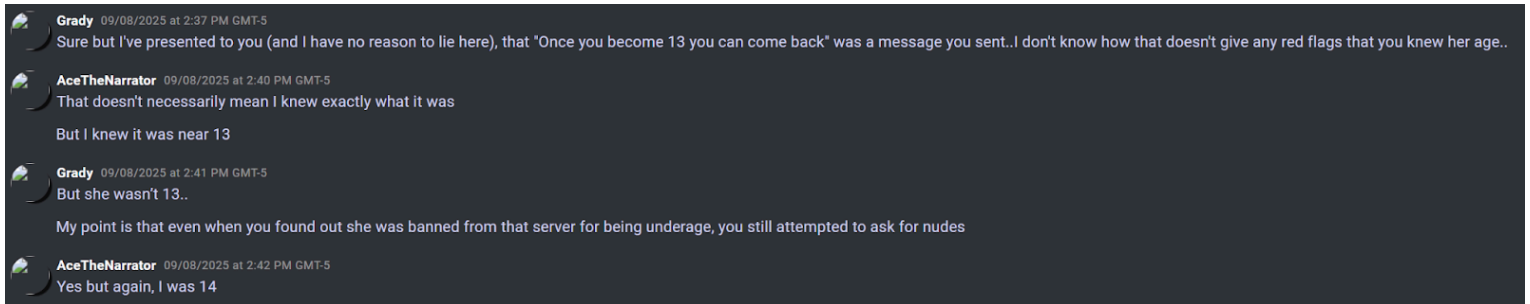

Grady highlights how AceTheNarrator is not even denying the fact that she was 11. Ace then responds that he is ‘currently denying it’.

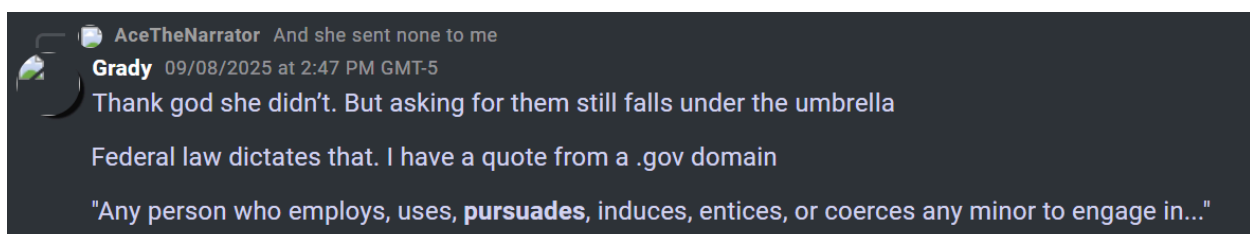
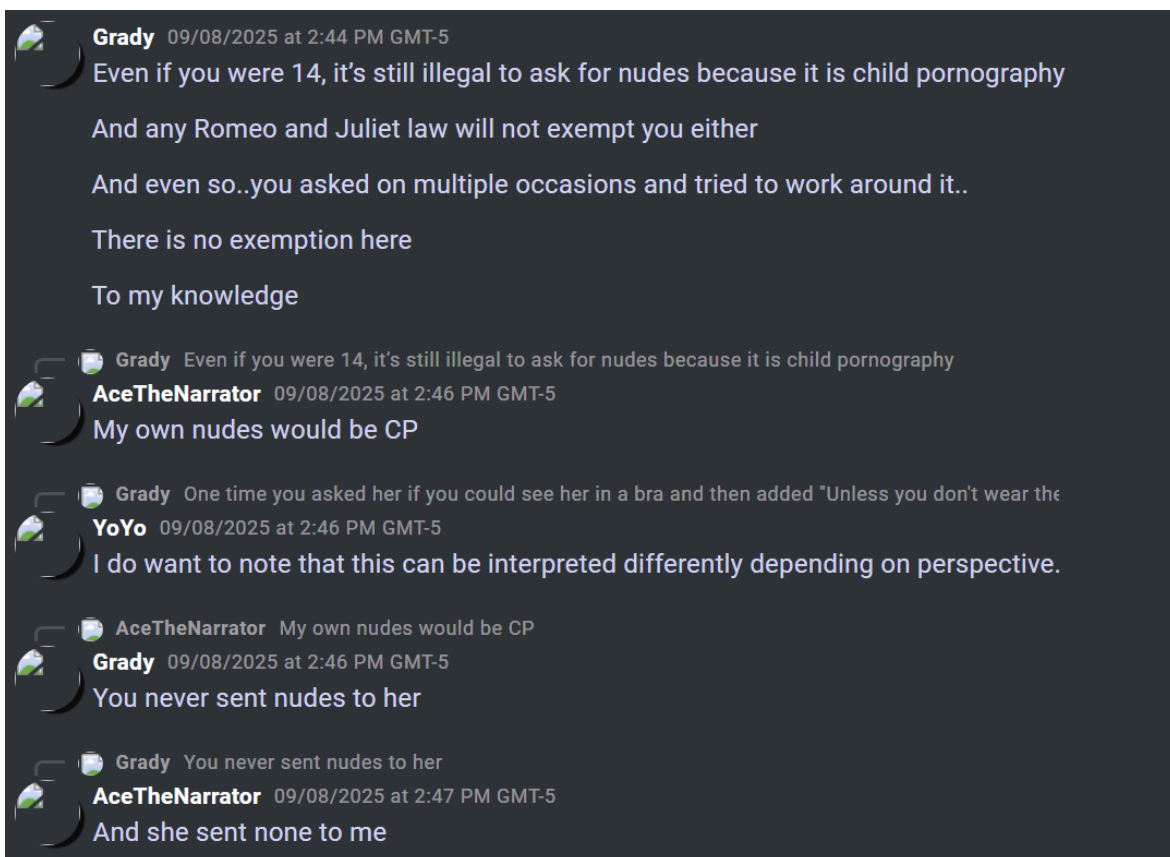

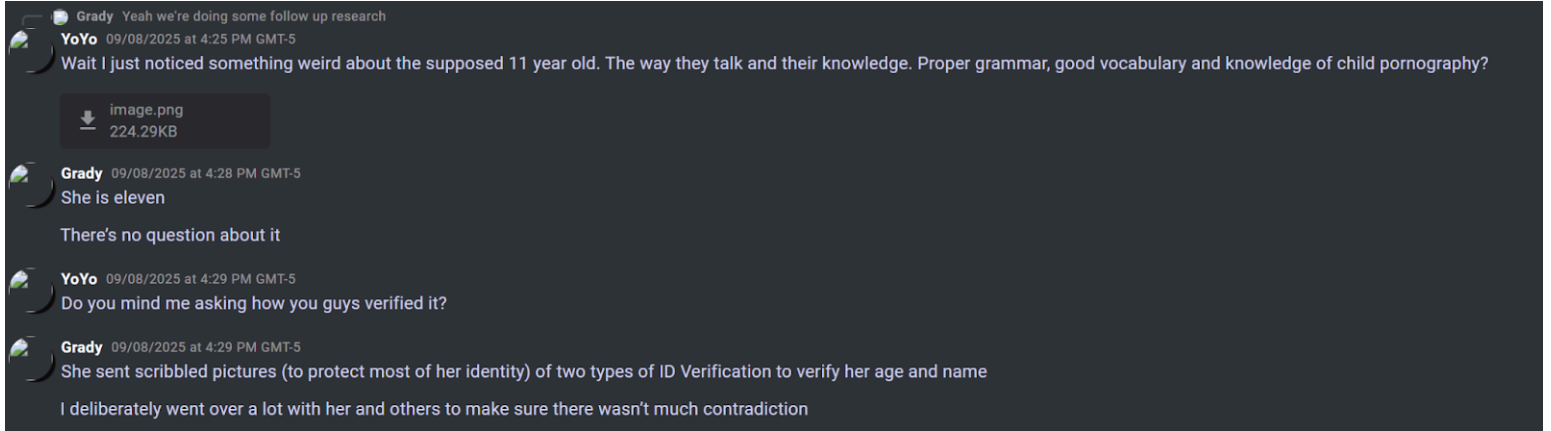
Grady clarifies that it was still illegal for Ace to have attempted to solicit CSAM content from Lolee when she was 11. Despite the fact that Ace never received CSAM, the act of persuading / soliciting a minor into producing CSAM of themselves is a crime.

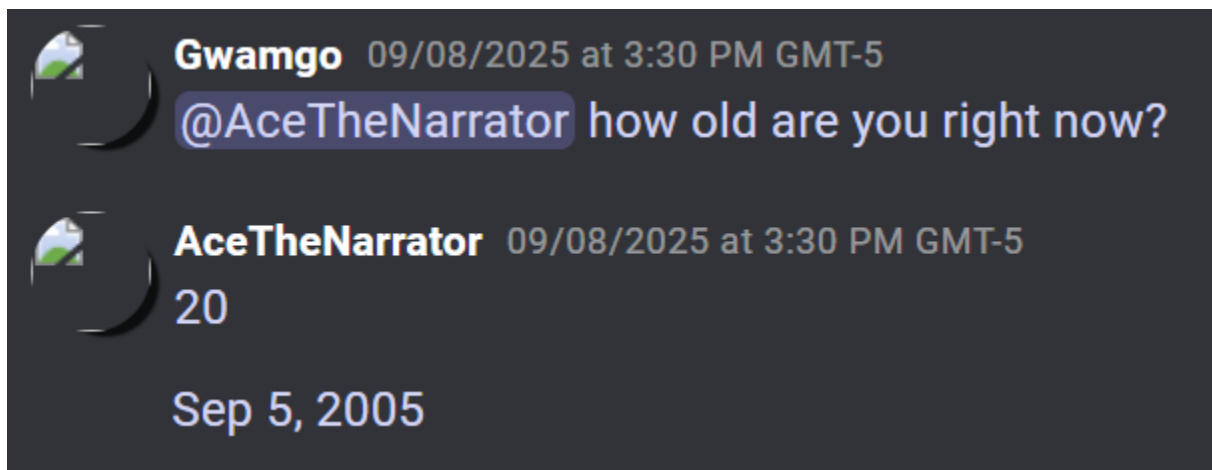
**(a)** Any person who employs, uses, persuades, induces, entices, or coerces any minor to engage in, or who has a minor assist any other person to engage in, or who transports any minor in or affecting interstate or foreign commerce, or in any Territory or Possession of the United States, with the intent that such minor engage in, any sexually explicit conduct for the purpose of producing any visual depiction of such conduct or for the purpose of transmitting a live visual depiction of such conduct, shall be punished as provided under subsection (e), if such person knows or has reason to know that such visual depiction will be transported or transmitted using any means or facility of interstate or foreign commerce or in or affecting interstate or foreign commerce or mailed, if that visual depiction was produced or transmitted using materials that have been mailed, shipped, or transported in or affecting interstate or foreign commerce by any means, including by computer, or if such visual depiction has actually been transported or transmitted using any means or facility of interstate or foreign commerce or in or affecting interstate or foreign commerce or mailed.

Grady confirms that Lolee **was in fact 11 in 2020**, as she had shown him her censored ID with her date of birth in 2025.

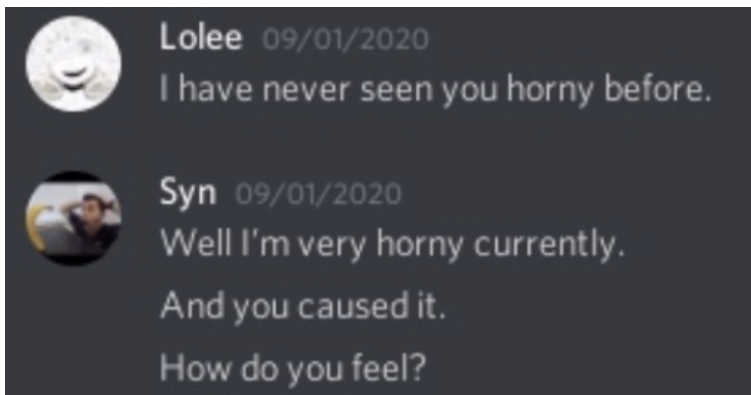
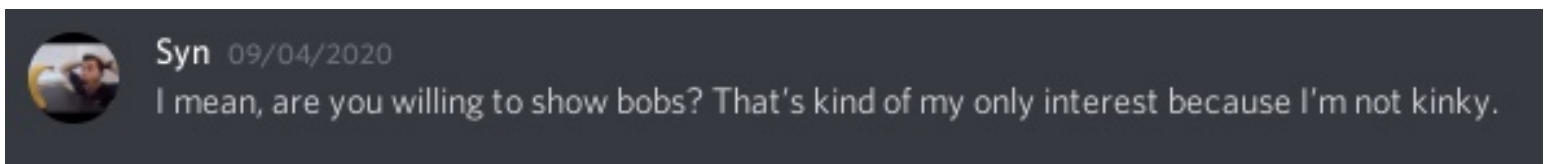

AceTheNarrator was seen throughout September 2020, engaging in inappropriate conversations with Lolee who was ID verified to have been **11** at the time. Ace, **after turning 15** [15th September 2020], was **still seen requesting and pushing Lolee to send CSAM of herself**.

A 15 year old requesting to see sexually explicit content of an 11 year old girl is illegal and absolutely reprehensible, regardless of the fact that the offending party was also a minor at the time. The age gap dynamic between them is disparaging.

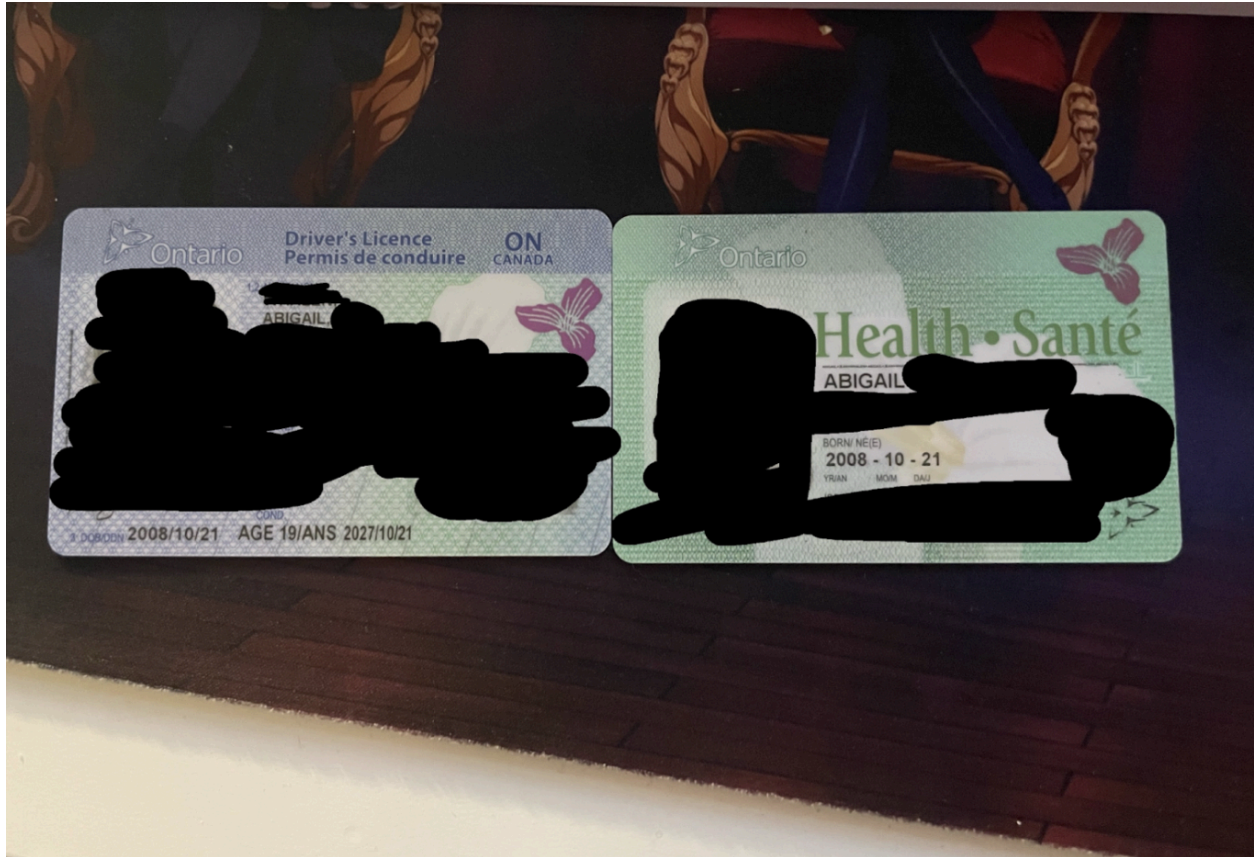

## **Schlep belittling the Potemer Situation**

Throughout 2025, Potemer was called out to large extents for having **orally raped a 12 year old** in 2022, when he was 16. Potemer also had an extensive history of **posting pornography and NSFW in Discord servers** where numerous **13 year olds** were present inside of when he was **16/17. Potemer also continued to engage with the same minor he SA'd when she was 14 and he was 18, further being seen engaging in sexual based topics with her in DM's.**

Schlep **actively knew about this situation**, yet refused on numerous circumstances to use his platform to call Potemer out, this led to Potemer being able to get away with his actions and to this day, continuing to earn thousands of dollars per month completely impeded.

I made a tweet talking about how I felt about regarding people defending Potemer, the person I spoke to often mentioned that you were making efforts to defend potemer and mocked the videos calling him out, they were also super adamant on you saying the specific phrase "its rape" in a mocking tone which really pissed me off considering Potemers mother has been basically spreading misinformation and doxing both Parlo and myself for a solid month now. From what I understand the situation qualifies as statutory child rape, the victim was 12 years old, and the general minimum age for minor on minor sexual interactions to even be considered potentially legal is 14 but that wasn't the case here as potemer was 16 and the victim was 12.  
  
the tweet I made didn't reference any youtubers because I didn't want to discredit any videos that you made, and I didn't confront you earlier since I was told not to mention it to anyone. Ive also heard about Ruben and Travv in relation to the situation, but from what I heard, neither of them were accused of mocking it. Travv actually helped a lot since he was involved in gathering evidence and even got recordings of Potemer trying to silence the victim.

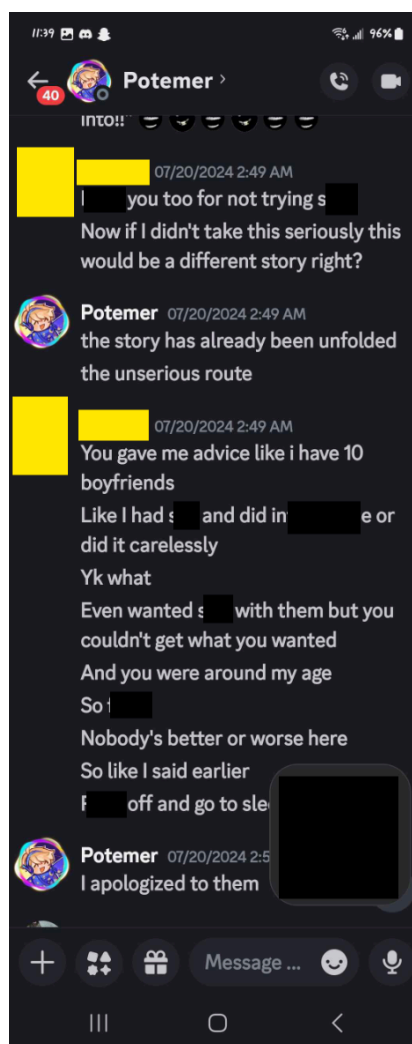
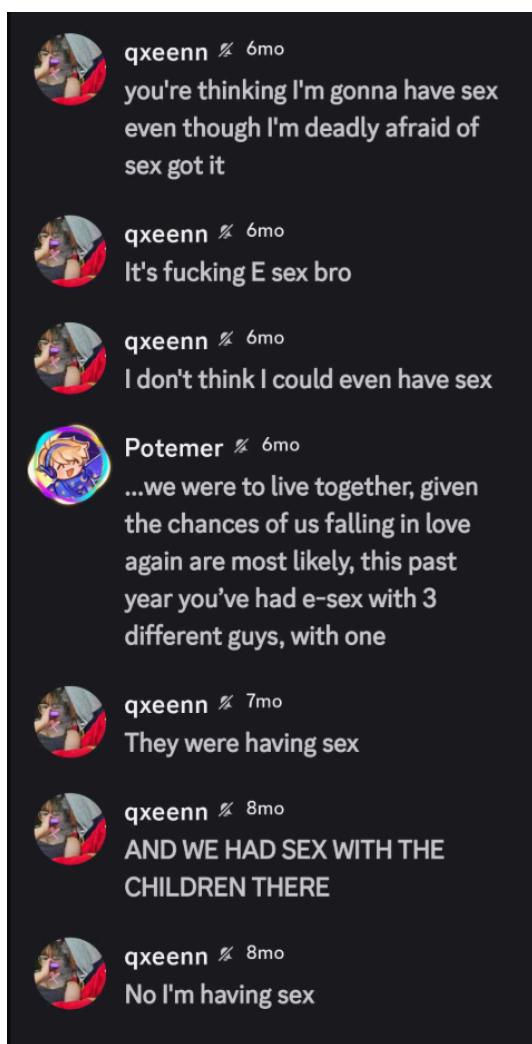

Schlep was seen directly claiming that Potemer engaging in oral sex with a 12 year old girl when he was 16, was **'not child rape'**, while also following up by stating that; *'I think there is a lot worse going on with Roblox... and that's why I'm not focusing on situations like this'*.

Schlep follows a principal where he will not intervene in any grooming or pedophilia oriented situation if both parties were minors at the time. He is complicit in covering these situations up even if there were evident examples of groomer-like / abusive or criminal behaviour. It is especially more concerning that Schlep actively withheld on making a video on Potemer and subtly belittled what he did, as this led way to Potemer continuing to make content on the platform after justified criticism against him eventually died down.

Potemer, despite having been a minor during the SA that took place in June 2022, then continued to sexually engage with his victim until he was **18 years old**, and **she was still 14**. They discussed topics to do with sex in dms as well as Potemer suggesting and grooming the girl to the idea of getting back into a relationship and living with each other. This was while he was an **adult** and she was **14**.

These dms were screenshotted when qxeenn [the victim] screenshared her dms to Parlo in January 2025. Most of these messages were sent in **late July 2024**, when Potemer would have been 18. His date of birth is **June 23rd 2006**.

Potemer has exhibited the exact behavioural mannerisms of a groomer, as he openly conditioned his victim into the idea of being in a relationship again and living together, when he was 18 and she was 14. This is an adult taking advantage of a minor, and Schlep turned a blind eye to this situation.


**Schlep has actively called out adults engaging inappropriately with minors which have smaller age gaps, such as Notive. Notive had a 2 year 10 month age gap.**





The other person developed an elaborate lie about their age, and once Parlo found out, he cut contact. As far as I know as well, no nudes were ever exchanged.

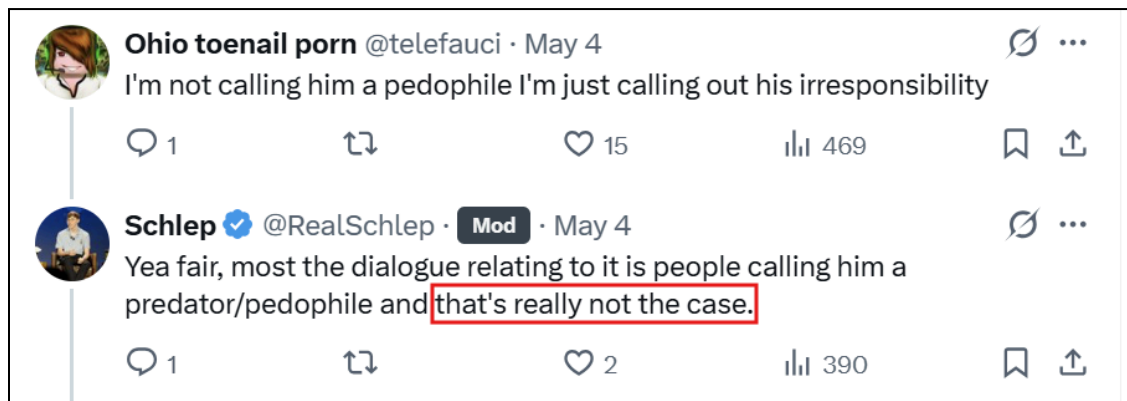
