On February 17, 2017 I responded to 7390 Bain Drive in reference to a disturbance. The complainant, Jason Stokes, advised he and his wife, Jacqueline Stokes, were involved in a verbal disturbance with no weapons being displayed. Call takers were able to speak with Jaqueline and she stated she was afraid of her husband due to threats made that he was going to kill her.

Upon arrival I met with Jacqueline outside on the roadway. Jacqueline stated she landed at Pensacola Regional Airport within two hours of calling the Sheriff Office. Both Jacqueline and Jason are going through a divorce and she and Jason were involved in a verbal argument with nothing physical occurring. Jacqueline stated that a couple weeks prior, Jason looked her straight in the face and told her he was going to wrap his hands around her throat and kill her. Jacqueline did not call the Sheriff Office then because she thought it was going to get better.

I spoke to Jason who stated he and his wife are in the process of getting a divorce and she came home and started arguing. Jason stated Jacqueline signed a lease to an apartment in Pensacola and Jaqueline was in the process of moving some stuff over. Jason stated as far as tonight, no threats or anything physical had taken place. Jason did tell Jacqueline he could kill her about a month prior. Jason was able to take me back to his account of that night and stated he had his right hand wrapped up and had rods put into his arm. Jaqueline slammed her hand down next to his arm and Jason thought she could have broken it if she would of made contact with his hand. Jason stated he would wrap is left hand, which is his good arm, around her neck and choke her.

Both Jacqueline and Jason were checked for active warrants and DVI's with negative results. Jacqueline packed some clothes and voluntarily left the house for the night to stay at her place in Pensacola. This report is for informational purposes only, and I recommend this case to be closed.

This occurred in Santa Rosa County, Florida.
