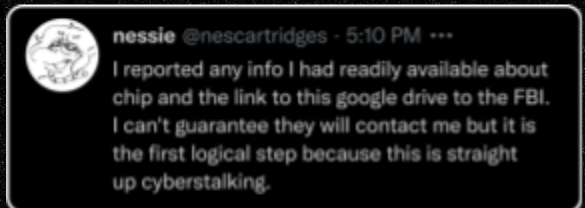
|| **CLAIM:** CHIP COLLECTED PIPCA'S FAT FETISH PORN AND PUT IT ON A GOOGLE DRIVE

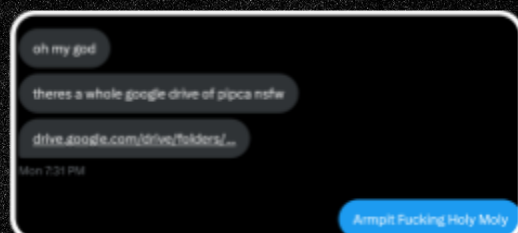

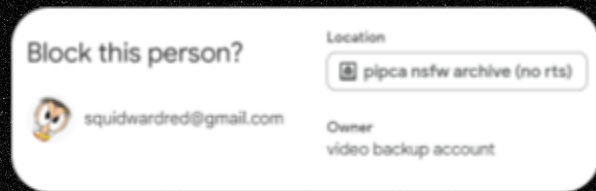


I'll say upfront that I had no involvement in the creation of this Drive. I was sent the link by several different people on Twitter (**EXHIBIT D**). The owner of the account, as well as the people sharing gore, are falsely doing so in my name, which seems to be a running theme here. They have no stakes and view me as a target, just as much as they do Pipca. Beyond taking my word for it, here is concrete evidence proving it is not my account.

NAME INCONSISTENCIES: The owner of the Drive's current name as of today is "video backup account", as seen in EXHIBIT D, however, some screenshots in circulation as seen in EXHIBIT C allegedly show the name as "chip".

While the username now is "chip," it was originally "video backup account." The Drive is registered to "squidwardred@gmail.com" and the avatar is an image of Matthew Littlemore (see **EXHIBIT F**). This can be obtained by either right clicking one of the images, or blocking the user.

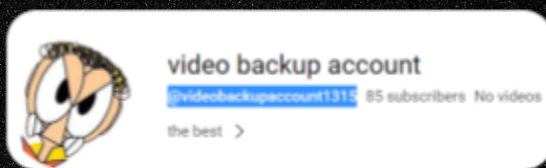

It's no coincidence there's a channel with the exact same name and avatar on YouTube that was created in March of 2020. Through the [Internet Archive](#), we can get access to several now-unlisted videos on the account. They identify themselves in the description of both as "Icine". Here are archives so you can check this for yourself (1, 2).

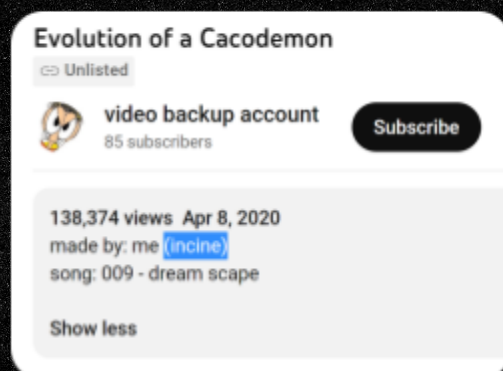

Unless you think I've somehow traveled back in time to upload two videos on a burner account only to then out myself now, it's obviously not me. While I can't blame people for assuming it was, there were still other inconsistencies that should've also been taken into account.

Whoever this was, they had a clear and obvious intention to throw me under the bus and frame me for leaking a bunch of porn. Why else would they change their name to "chip" as soon as I got in hot water with Pipca? The files were last modified over a year ago on the 13th of April 2022 (as shown in EXHIBIT C) and some images were uploaded as early as December 2021. Many images were likely created by Pipca much, much earlier than that.

Beyond that, the idea of keeping tabs on someone for well over a year, infiltrating their porn account, and compiling their porn in secret, and “leaking” it under my actual screen name years later is ridiculous. However, since Pipca is claiming to involve law enforcement, here are some other points worth mentioning:

- **THE NSFW ACCOUNT WAS PUBLIC:** Pipca’s NSFW content was never “leaked,” it was right out in the open as proven by the Internet Archive. **EXHIBIT F** shows the account, fully unlocked. **EXHIBIT G** shows an archived tweet from the account, that once again wouldn’t be accessible if it was private. **How was it leaked if it wasn’t private in the first place? Why did PIPCA say she went to the FBI?** Something isn’t right here.
- **PIPCA HAS ENEMIES:** Pipca’s burp/fat fetish porn was already “leaked” in the past as seen in **EXHIBIT H** - and by “leaked” I mean someone tagged her fetish porn account to mess with her. It’s obvious **EXHIBIT G** shows she was aware of the risks of having a public porn account, and had clearly already dealt with the consequences. If that’s the case, why is Pipca trying to blame me for her own mistakes from over a year ago?

CONCLUSION: Being a public figure with tens of thousands of followers and running a completely public fetish porn account is a risky operation. Pipca knows this, and presumably it's the reason the account is now private. The person who made the Drive was one of many who decided to riff about it long before I knew of its existence. Because of this, it's bizarre to retroactively blame me for “leaking” it. If it was such a non-secret that multiple people are sending me the link, it’s hard to believe she wasn’t aware this stuff was circulating.

But ultimately, I can’t blame random bystanders for taking it at face value because it took some effort to identify the actual culprit. **I can blame Pipca for deliberately smearing me as a potential culprit for her own irresponsible actions**, despite clearly knowing better. Honestly, I think running around trying to “expose” people for drawing porn is lame and I don’t see why people would even care in the first place. The only reason I cared was because Pipca draws fat people that look funny, and we like that.

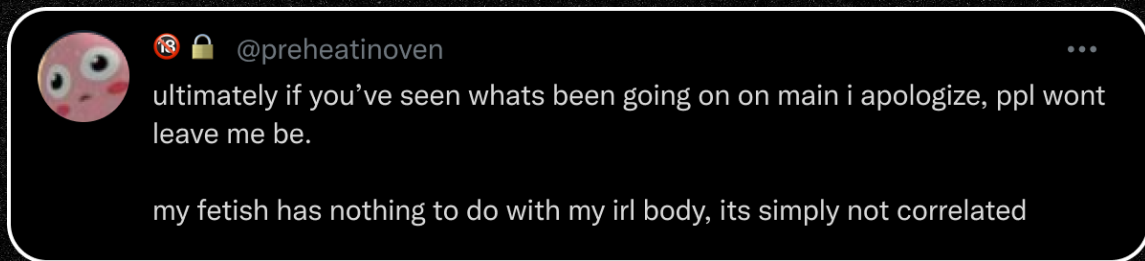

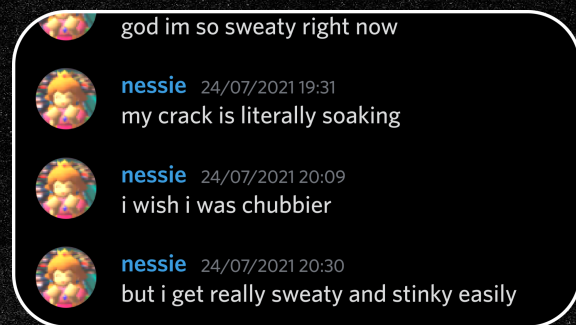
As you can see, Pipca's character is, quite frankly, a chunky little chonker- and that's a good thing actually! The fact of the matter is that fat-fetishesque cartoon characters are **funny**. If you've ever gone on DeviantArt and had a chuckle at the strange and bizarre stuff you've found, you're guilty of this as well! Finding humor in art like that is relatively common, and I'd be hard pressed to find a lot of scenarios where that could be considered harassment.

I don't know what Pipca looks like in real life - nor do I care to know! That's why it confuses me when people accuse me of "body shaming". Now, I get that the whole point of mascot characters is that they're supposed to represent someone to a certain degree. The thing is that I don't think I can confidently say that Pipca is a 400 pound imp creature in real life. Framing it as "harassment" just or "cyberbullying" just misses the point entirely.

Now, there are a surprising number of people who take issue with calling Ol' Girty a fetish character. Pipca has reframed every joke I've made about The Girthiest into being about her real-life appearance. That's ignoring the art she made of morbidly obese women getting their belly buttons penetrated (**LOL**) and the fact she's drawn NSFW of her own persona. But Pipca herself would state that "[her] fetish has nothing to do with [her] real life body, it's simply not correlated."

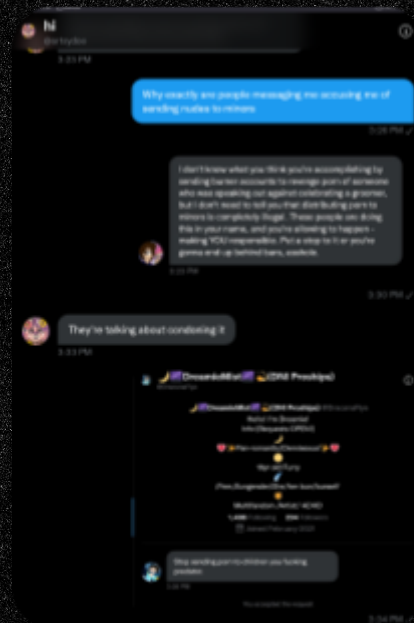
This person claimed that my video mocking pedophiles was “insensitive” to the victims and then proceeded to make up false sex crime accusations against me. Ironic?

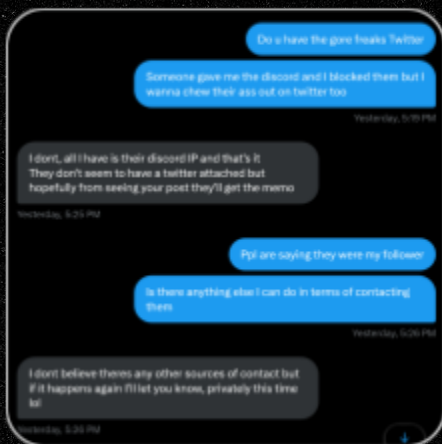


Me confronting Josalyn over people accusing me of sending porn to kids

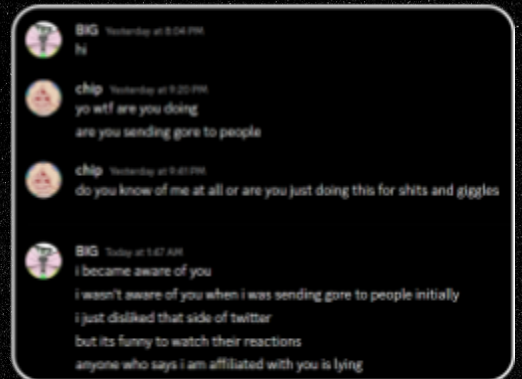
I immediately started asking around once I heard "one of my fans" was allegedly sending gore to people

If you see someone claiming I'm a "pedophile," this is why. People have spun this story into a "sex crime" by claiming I pooped into my own hand and showed it to a minor.

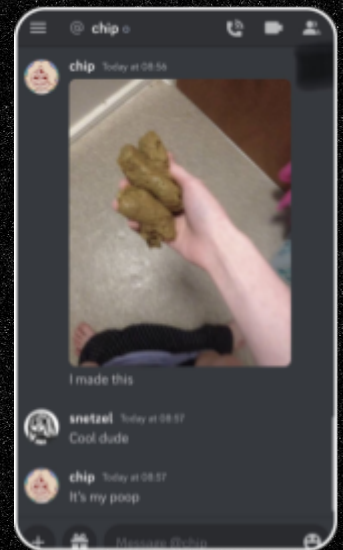

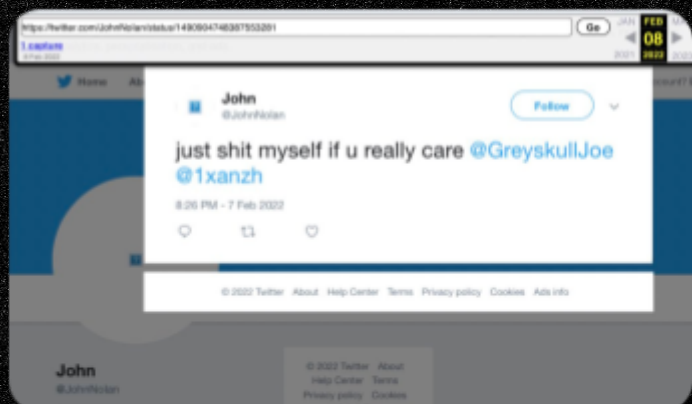

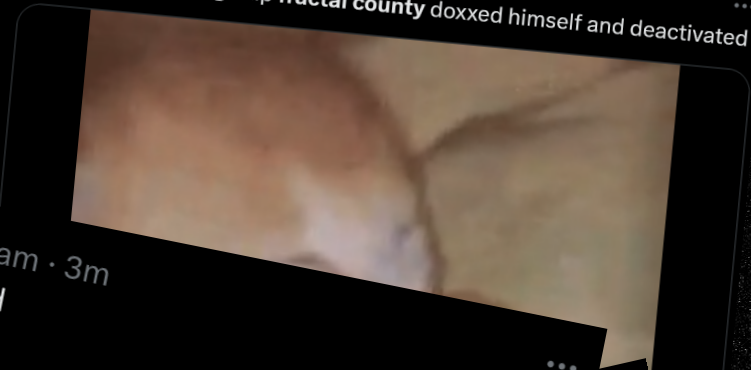
