**EMERGENCY PETITION FOR WRIT OF HABEAS CORPUS
PURSUANT TO 28 U.S.C. § 2241**

JURISDICTION AND VENUE

Jurisdiction and venue are proper in the Middle District of Florida. Petitioner is confined at FCC Coleman Low. The Warden is the proper respondent.

FACTS

Petitioner's CTC date was October 26, 2025. All approvals were completed, including U.S. Probation home approval. Petitioner has no detainers, no disciplinary infractions, and exhausted all administrative remedies. Petitioner remains incarcerated without lawful authority.

RELIEF REQUESTED

Petitioner requests immediate release to community placement or home confinement.

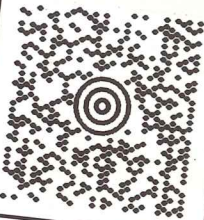
