

Disclaimer: This is an announcement document. It is not considered the "StargiantProductions" google document. In the coming days and weeks we will be putting together a full Google documents with all of this person's transgressions and the evidence and testimonies that we have gathered over the past two years lined up in a neat and easy-to-read format, chapter by chapter. This is merely an initial preview.



At present, StargiantProductions goes by Ryan Kruleski and he/him pronouns and has been identifying that way since April of 2024, a month after he deleted his channel during my initial expose of his illicit activities. I will be referring to him as Ryan and using he/him pronouns for the duration of this documentation.

1. **We have found where he has been hiding on the internet.** Ryan made a return to video production back in October of 2024, with a video called “Why I Won’t Review MLP G6” and has been since placing videos on a channel called “[SushiCookie](#)”. The “Ryanimations Reviews” and other projects with the StargiantProductions branding have been uploaded unlisted on said channel:

2. **Ryan is/was planning on returning:** They set the specific time to June of next year (2026)
3. **The team will be making videos and statements:** I will be making a video going over every new thing that we have learned, as well as a deeper look on some older information. Ryan has written two separate documents that both Lazy Bedhead and I plan on going over in streams. Matti is also working on a video of his own and MintKitten/Wes is considering creating one as well.
4. **In addition, I will be making an all-encompassing google document and accompanying dropbox.** Here is what the table of contents looks like at present, and chances are it will get longer. Ryan’s “suicide prevention video” - a video where he intended to dox and put on blast a private internet individual he was having a problem with, call them suicidal, and call the video a public service announcement was something that was something that was previously lost in the shuffle. It is the second most sociopathic thing I have ever seen him write.

5. **Ryan responded to the allegations:** The video that he came back with on October 2024 had an accompanying Google Doc called "Counter for March 2024". It was displayed within the video itself, so I can confirm it is legit. I cannot give out the document or the video publicly however, since it both uses deadnames and unmask the identity of people who wish to remain anonymous. 6. **Some Points on the Document Are worth Looking at Immediately.** My response text will be in green for reading clarity.

*Accusation: Ryan groomed <REDACTED> when she was 17.

Truth: I waited for <REDACTED> to turn 18 before I said anything sexual to her. When she was 17, I did not pursue anything sexual about her. All sexual things were when she was an adult. <REDACTED> was the one that did sexual stuff without me telling her to do so or without my permission. She also was the one that tried to get me to come live with her in New Hampshire when she turned 18. She told me these ideas when she was 17 in June of 2020. I told her at 17 I wanted sex with her, but I also told her at the same time that I wouldn't have sex with her until she was 18. Even then, there was no video or pictures of her as a minor showing her genitals/boobs, nor did Ryan send any genitals of himself to <REDACTED> when she was a minor.

Ryan doesn't seem to understand this, but he admitted to at the very least grooming his victim without solicitation. He outright states that he said to this person he wanted to have sex with them when they were 17 years old. He also contradicts himself: saying that "I wanted for them to turn 18 before I said anything sexual" and then in the same breath "I told her at 17 I wanted sex with her", as if saying you want sex with someone is not sexual. The more specific allegations the victim gave were of being shown fetish art and being brought into fetish roleplays, which Ryan does not mention in either direction

*Accusation: Ryan groomed Mint Kitten.

Truth: No I didn't. Mint Kitten was only asked by me to do drawings. They were of fictional characters not meant to be sexual. As in there is nothing legally sexual about them. And none of our talks were of me wanting to have sex with <HIM> as a minor. They were goofy talks not meant to be taken seriously. And they weren't sexual in this context. Mint was not forced to draw anything. Everything that <HE> drew for Ryan was something that <HE> wanted to draw.

This is another outright admission. "They were goofy talks not meant to be taken seriously" is on the level of Cosmodore saying "it was just Rule 34" when sending anime pornography to his victim. They were also not of fictional characters; they were of his and Lily Orchard's avatars. "They weren't sexual in this context" implies they were sexual in *some* context. The rest of this is more victim blaming. "Mint was not force to draw anything. Everything that he drew for Ryan was something that he wanted to draw" is dismissive, and either shows that Ryan is lying or he doesn't know how grooming works despite being a now-admitted groomer.

*Accusation: Ryan leaked information. He wiretapped.

Truth: Wrong. Ryan only brought up stuff to counter John for his arguments. And the Twitter leak was by accident. Plus Ryan was never told that the new Twitter thing was meant to be a secret. As for the video recordings, he only recorded them for his own private self in case anyone accused him of anything. And only posted certain video and screenshot information publicly to address various claims against him. Nothing else was ever intentionally posted publicly. His server is a public server by the way. And even then, Ryan never signed any contracts to confirm anything. (No NDA per say.) And the people in question gave permission for Ryan to record. Grace has done similar actions in terms of recording. So by the accusation logic, Grace should be arrested as well. Ryan does not belong in prison and everything was approved of prior.

This is another admission, this time of recording someone without consent; regardless if it was illegal wiretapping or not.

*Accusation: Ryan has anger issues.

Truth: Yes, he does. But that does not mean a crime in this case. He may say "FUCK YOU!" to people. But I never sent a death threat. Being angry in general is not liable grounds for suing.

The video that showcases this document contains several death threats in rapid succession.

7. **Ryan is still in contact with "Brandon the Brony Pony"** The defense document still goes out of its way to defend both him and his decisions during the N3k0Pan incident. It is also showcased that Brandon the Brony Pony is still a Stargiantproductions supporter in new and updated videos.
8. **Ryan threw his hat in the ring to comment on the Ilovekimpossiblealot drama from earlier this year.** He wrote and released a 27-page document to his confidants in August of this year. If you're wondering, this was months after the incident had ended (Lazy Bedhead's comprehensive documentation of the whole event "The Bonk Conspiracy" was uploaded in early July). It also the most sociopathic thing he has ever written.

The document in question is essentially "Addressing My Abuse II", as it starts out by talking about the event, with his stock brand of narcissism, bringing up facts that have no value beyond the scope of his own ego and life.

one was bad, would you claim that ALL the apples are bad? No. Brony Fandom? Yes. I don't know if Brony Fandom really believed in all of this, or just wanted attention. All I know is that he wanted to take down Stephen for having 2 million subscribers. (What the hell? Stephen reached 2 million the same day that I deleted my YouTube channel! Weird.) Or rather, doing it for "Social Brownie Points."

Random tangents that have nothing to do with anything

But let's get down to the reason why I tell people to not use YouTube for a living. YouTube does not pay minimum wage. Look up the "Fair Labor Standards Act" (FLSA) created in 1938. WAY before YouTube got created 20 years ago in 2005. This law is, and I quote, "a United States federal law that establishes fundamental labor standards, including minimum wage, overtime pay, recordkeeping, and child labor provisions for most private and public employees."

And it eventually goes into bitching about me and my team. Ryan is still trying to fight the same battle that he lost in 2021 when he was fired.

And your team is no better. "Graceland" lives in "La La Land." She wanted me to do this terrible payment processing plan that would have made me go BANKRUPT! "But you're paying people above minimum wage!" Listen you cunt, I'm not even getting paid MINIMUM! I'm not listening to you. You can't even handle me critiquing John. You threw a shit fit and blocked me. And yet I refunded you 250 dollars and you don't even thank me you WHORE!

And throughout it all, he manages to somehow have the worst possible takes on the entire situation. Whoever's side you're on, whoever you like, whoever you don't. As most people, Ryan had a problem with Ilovekimpossiblealot's video. But he had a different problem from most people. He found that it was offensive that someone would feel violated that someone else masturbated to them without their consent.

Then she randomly brings "JoonTheKing" in to read a story about masturbation because she couldn't handle it. Okay, if YOU can't handle THAT Rachael, then you should have stopped the video immediately. Because masturbation is INFINITELY better than sexual assault! Rachael, you should be flattered that someone masturbated to you. No, I'm not taking that back ever. And I'm gonna go deeper into the why right now. You're a very, incredibly, disgusting human being Rachael. The fact that someone could call you "attractive" after all of this, or even before this video, you should be thankful for. You could have easily been like millions of people on earth that never get masturbated to. I've had people masturbate to me. Both real life me and OC me. And I am proud of that. It means that they find me attractive and sexy.

Was the timing of the masturbation bad?...yes. BUT, the way Rachael words this is that she's against ANYONE masturbating to her! People masturbate to anything. Rachael has a human and pony OC. People are gonna get a lot of "sexual gratification" out of that. Deal with it Rachael. This is what we also call "slut shaming."

I never thought that I would have had to tell people in my life. Is this story real or not? I CAN'T TELL!

And by the way, so Rachael thinks masturbation is bad, but sexual assault is funny. That is what her hypocritical ASS is saying!

This is just the tip of the iceberg of this secondary document. Once again, I cannot link the document itself because it has things like deadnames and identities that people want to keep hidden. And considering it's 27 pages, it will take awhile for me to go through this entirely, so I can't link it now.

This, more than anything, should let you know what kind of a subhuman that this person is. Whenever I think that I can't get angrier or more disgusted by this person, they find a way to thoroughly prove me wrong and show the world the vile depths of depravity that is their lack of a soul.

This gets far more disturbing when you learn that at one point in time, Ryan wanted to be an editor for Ilovekimpossiblealot. Considering his values, and behavior, I have speculations towards that being another attempt of getting more "goon" material.

9. There is only one person that Ryan thinks he has to apologize to.

Lily Orchard/CD-Call.

...

... You know what? I'm tired of hiding this. I want to make an apology to "Lily Orchard/CD Call" right now. I was way too harsh to her over the years. I said that my Mr. Enter/Addressing My Abuse videos were the worst videos that I have ever made. But the second worst videos that I have ever made were all my CD Call videos.

CD-Call is an innocent human being in everything. After what happened to me on March 15th, 2024, I realized that the internet throwing shit or "Internet Justice" into our faces is just face value and malicious. Real laws are what matters. And since CD-Call has not gone to prison, I find her 100% innocent forever. And fuck Josh and Anna still calling her a piece of shit!

If you've forgotten how the story went - Ryan had a shitfit towards Lily Orchard because she shat on Starlight Glimmer, his comfort character. Then Ryan made several incoherent videos on Lily Orchard, dismissing the more serious allegations as they were arising to talk about how great Starlight Glimmer was. Then Lily Orchard was accused by her sister Courtney of raping her; she was tied to a pedophilic MLP fanfiction called "Stockholm" beyond any reasonable doubt.

After this (and before my expose), Ryan begins saying that he was too harsh on her and the rest of the internet was as well. This was around the time he began to hate Starlight Glimmer himself. And now, at the end of it all, the only one he has in his heart to forgive is Lily Orchard. Birds of a feather.

10. Yes we archived everything we found immediately. All videos linked to us, both of the documents, etc.

11. One thing I want to make it abundantly clear: Ryan must not be allowed to return to a public platform on the internet. At bare minimum.

At present (9/14/2024) - One of my regular videos is currently in editing and should be done in the next couple of days. Tuesday's livestream is also going to be a typical thing. However, after that, making a video going over all of this stuff deeper will be the next thing and we'll be doing a livestream talking about it. Everyone else, let them schedule at their own pace.

I am working on the google document every single day. As you might imagine though, there is a ton of different things - Ryan buries the 'gems' in the most bizarre places, which means that I'll probably have to go through "Addressing My Abuse" again.

Ryan, you wanted an audience? Catch.
